
From the Desk of **DIRECTOR GENERAL**

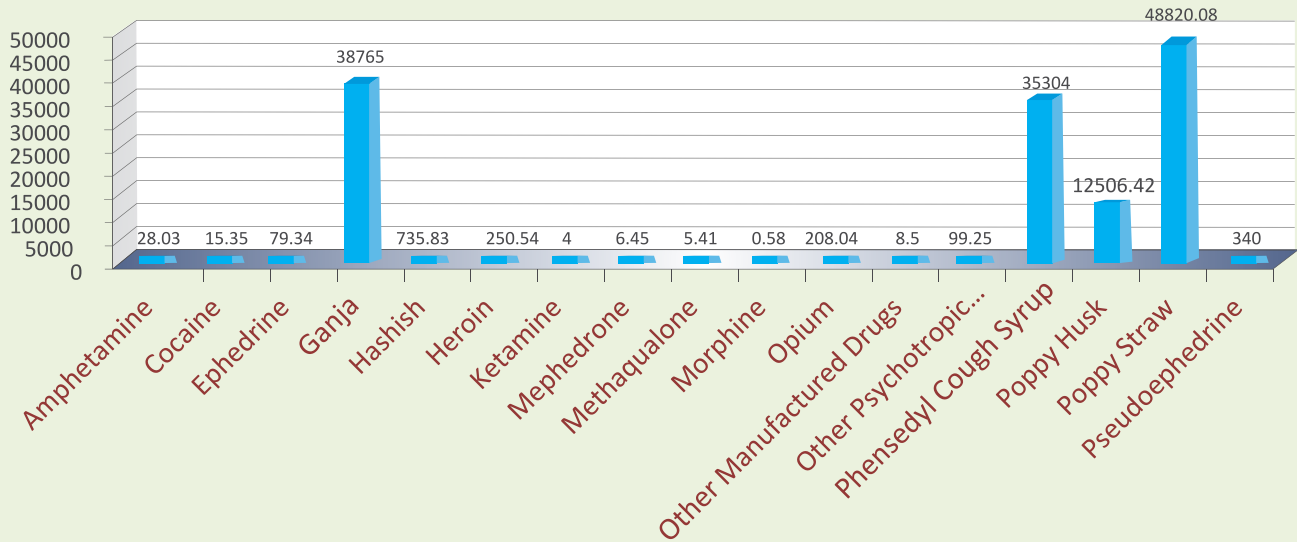

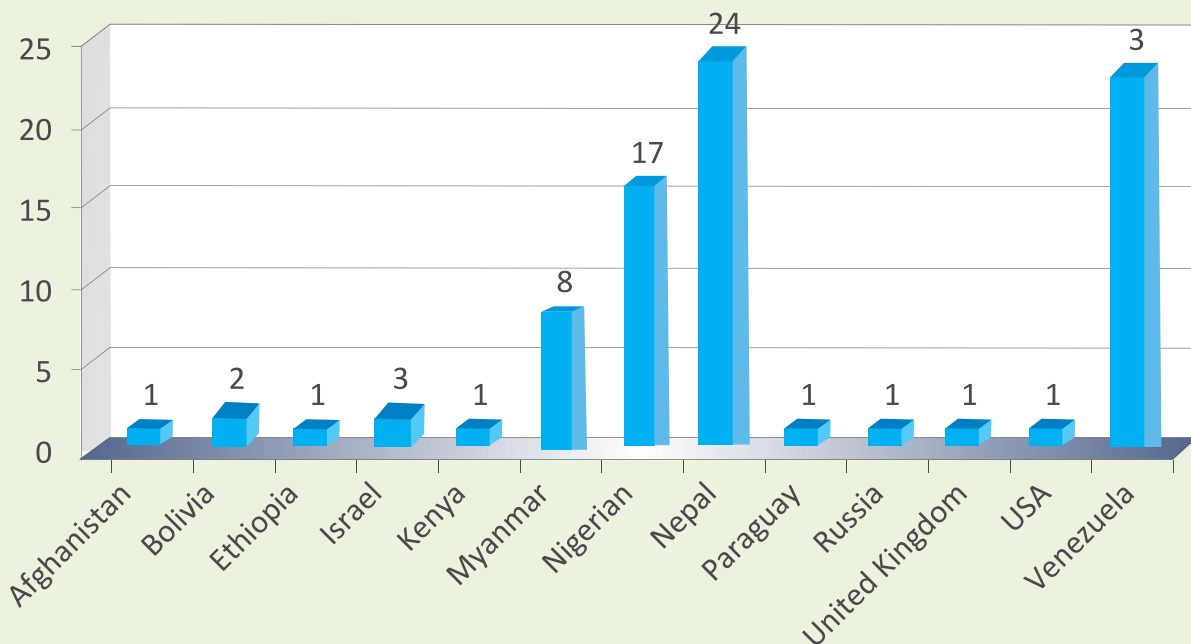
All India seizure including NCB (Oct - Dec, 2017*) (Qty. Kg.)

Significant Seizures by other organization

Central Bureau of Narcotics (CBN)

- On 23.10.2017, officers of Central Bureau of Narcotics, Bareilly, Uttar Pradesh seized 44.000 kg of Hashish at Toll Plaza, Fatehganj Pashchmi, Bareilly. The drug was concealed in secret chamber specially made under the Stepney of the vehicle. Three persons were arrested.
- On 02.12.2017, officers of Central Bureau of Narcotics, Bareilly seized 75.000 kg of Hashish at Bareilly. Two persons were arrested.
- On 05.12.2017, officers of Central Bureau of Narcotics, Indore seized 5.200 kg of Mephedrone at Madhumin Square, Indore. One person was arrested.

Customs

- During the month of May, 2015, officers of the Customs, FPO, New Delhi intercepted 03 parcels containing 500 gram of Heroin. The suspected destinations of seized drugs were United Kingdom & Netherland.

Customs Preventive

- On 05.11.2017, officers of Customs, Preventive Unit, Shillong seized 1820.930 kg of Ganja near CRPF Camp, Kashipur, Cashar District, Assam. Two persons were arrested.

Directorate of Revenue Intelligence (DRI)

- On 28.10.2017, officers of Directorate of Revenue Intelligence, Varanasi seized 7.150 kg of Heroin at main exit gate of Varanasi Junction Railway Station. Three persons were arrested.
- On 14.11.2017, officers of Directorate of Revenue Intelligence, Hyderabad seized 179 kg of Ephedrine and 171.500 kg of Di Benzoyl Tartaric Acid (DBTA) at Bollarum and busted 01 illicit clandestine laboratory. Two persons were arrested.
- On 21.11.2017, officers of Directorate of Revenue Intelligence, Shillong seized 21000 bottles of Phensedyl Cough Syrup at Mawlong on NH-44, Shillong. Two persons were arrested.

- On 17.12.2017, officers of Directorate of Revenue Intelligence, Visakhapatnam seized 804 kg of Ganja at Visakhapatnam. Three persons were arrested.
- On 29.12.2017, officers of Directorate of Revenue Intelligence, Agartala seized 23500 bottles of Phensedyl Cough Syrup at Dhalai, Tripura. Three person were arrested.

Sashastra Seema Bal (SSB)

- During the month of October, 2017, officers of the Sashastra Seema Bal (SSB) seized 210 gram Heroin, 48.780 kg Hashish and 56.800 kg Ganja in 11 cases and arrested Thirteen persons including six Nepalese. The suspected source of the seized drugs in most of these cases was Nepal.



- During the month of November, 2017, officers of the Sashastra Seema Bal (SSB) seized 970 gram Heroin, 224 gram Morphine, 978 gram Methaqualone, 28.480 kg Hashish and 269.570 kg Ganja in 19 cases and arrested twenty four persons including six Nepalese. The suspected source of the seized drugs in most of these cases was Nepal.

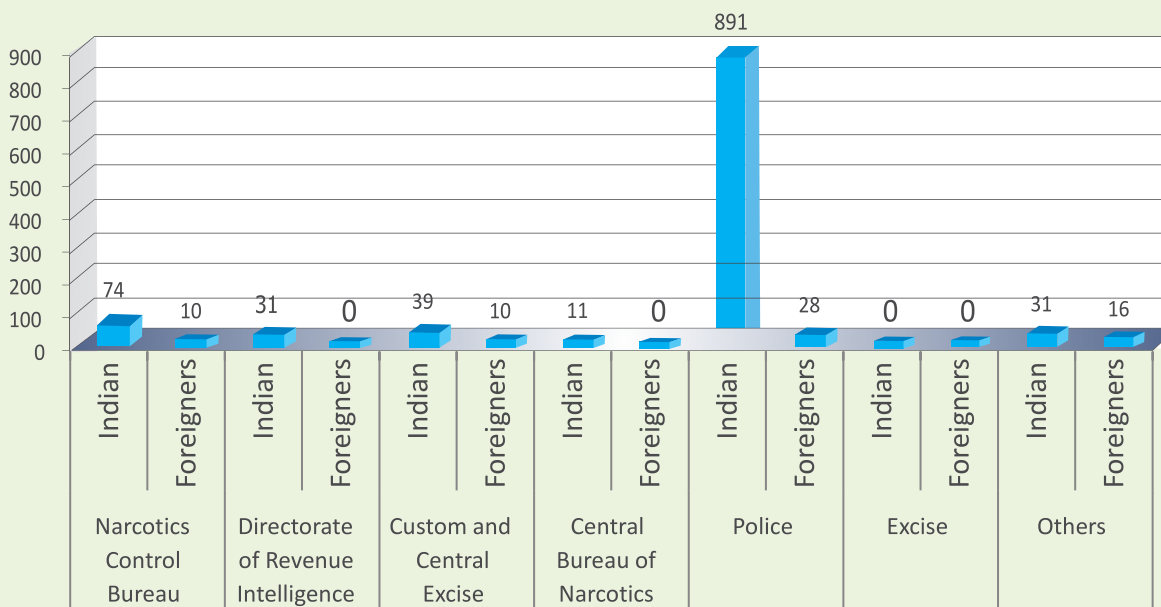
State Police (Delhi Police)

Disposal of drugs

- On 10.10.2017, officers of NCB, Kolkata Zonal Unit in the presence of Regular Drug Disposal Committee disposed off 359.830 kg of Acetic Anhydride through the process of incineration at the Groups Hazardous Waste Management Site of Medicare Environmental Management Pvt. Ltd. at Haldia.
- On 10.10.2017, officers of NCB, Kolkata Zonal Unit in the presence of Regular Drug Disposal Committee and the Judicial Magistrate, 5th Court, Chinsurah disposed off 22.330 kg of Ganja and 25.445 kg of other Psychotropic Substance through the process of incineration at The Common Bio-Medical Waste Treatment Facility Centre of Medicare Environmental Management Private Limited, Near HMC Dump Site, Howrah, West Bengal.
- On 31.10.2017, officers of NCB, Delhi Zonal Unit along with Drug Disposal Committee disposed off 1.380 kg of Cocaine, 12.650 kg of Heroin, 50.300 kg of Hashish, 27.550 kg of Ganja, 68.880 kg of Pseudo Ephedrine, 3.300 kg of Methamphetamine and 225 bottles of Phensedyl Cough Syrup along with samples of the above seized drugs through incinerator at Delhi Pollution Control Board approved Centralized Bio Medical Waste Treatment Facility at Nilothi, New Delhi.

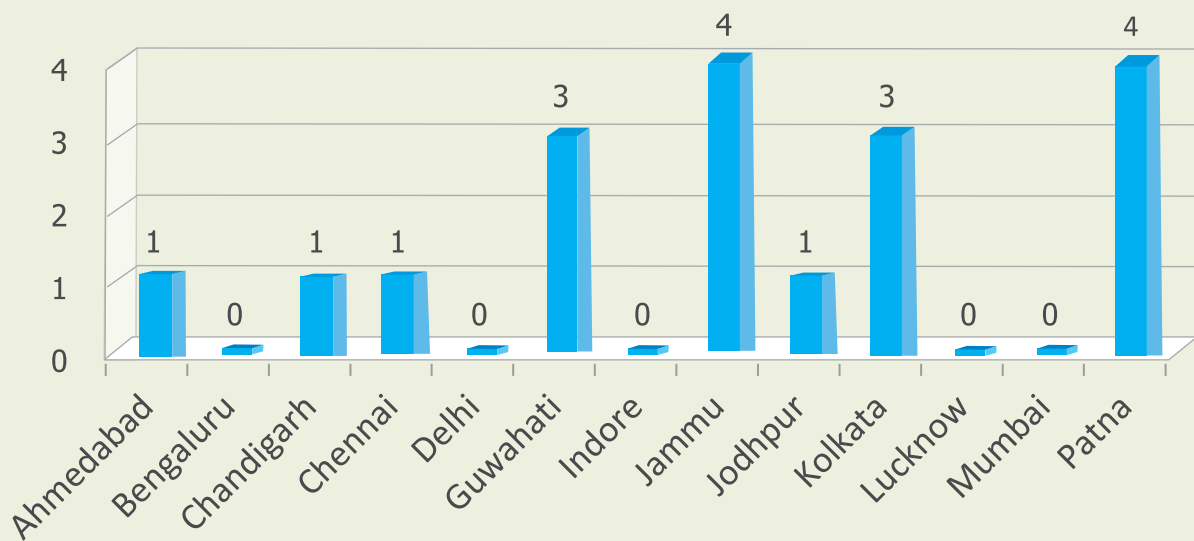

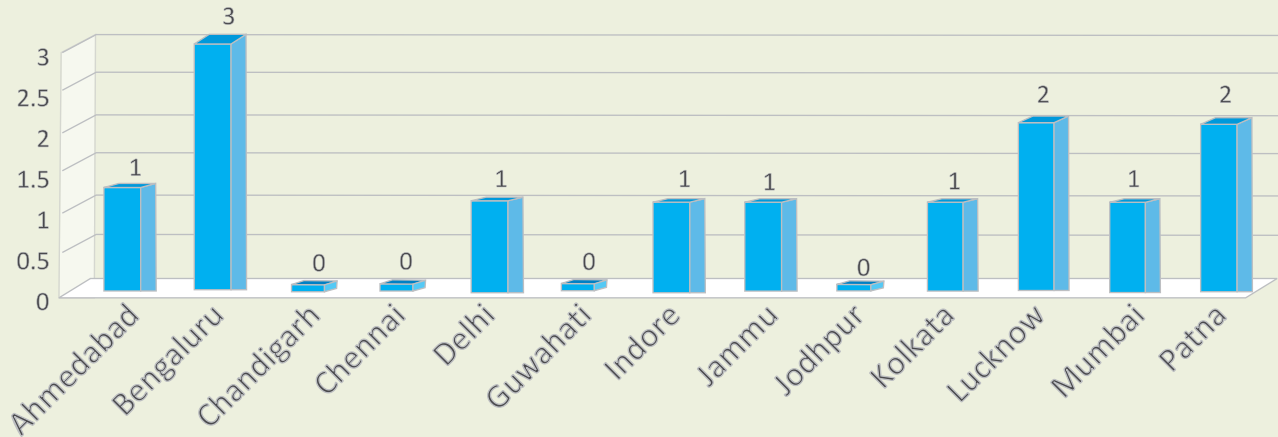

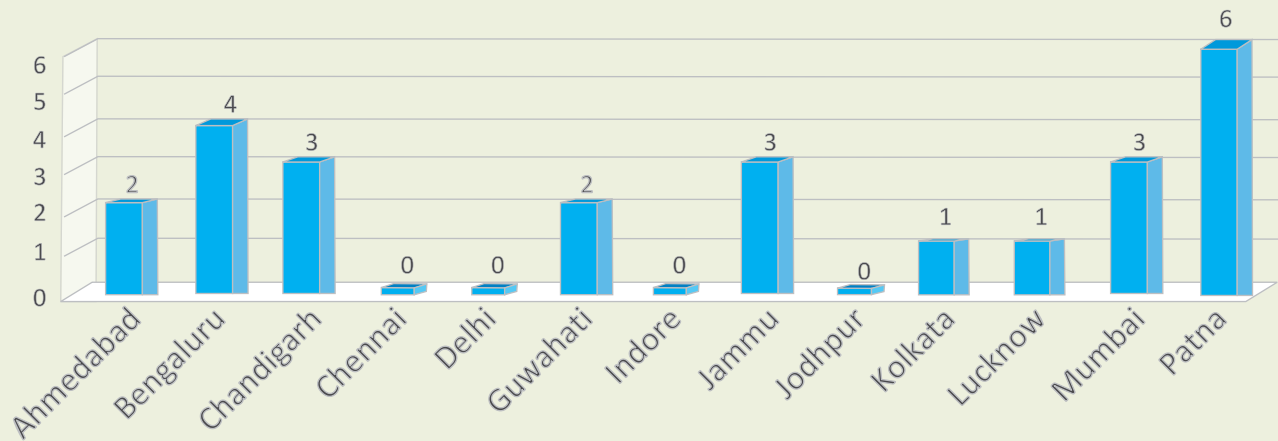

3. Capacity Building

Assistance to states & Union Territories

A Scheme to finance State Governments to strengthen their enforcement capabilities for combating illicit trafficking in Narcotics Drugs and Psychotropic Substances was initially launched by the Union Ministry on 24.10.2004 at an estimated cost of Rs.10.00 Crore. Since then it is being extended at regular intervals. Last time the scheme was extended from 2014-2017 with a budget of Rs. 15.00 crore for providing the assistance to States/UTs to purchase equipments like:-

- Surveillance equipment.
- Laboratory equipment.
- Vehicles for patrolling/surveillance.
- Computers and their accessories.
- Fax machine and photocopies.
- Training equipment and other aids.
- Other equipment useful for enforcement.



Considering the present drug scenario in the country, the Government of India has further decided to extend the scheme for another three years i.e 2017-2020 with estimate budget of Rs. 21.00 crores. The guideline for seeking/ processing the proposals from the States/UTs is under consideration with MHA.

Training

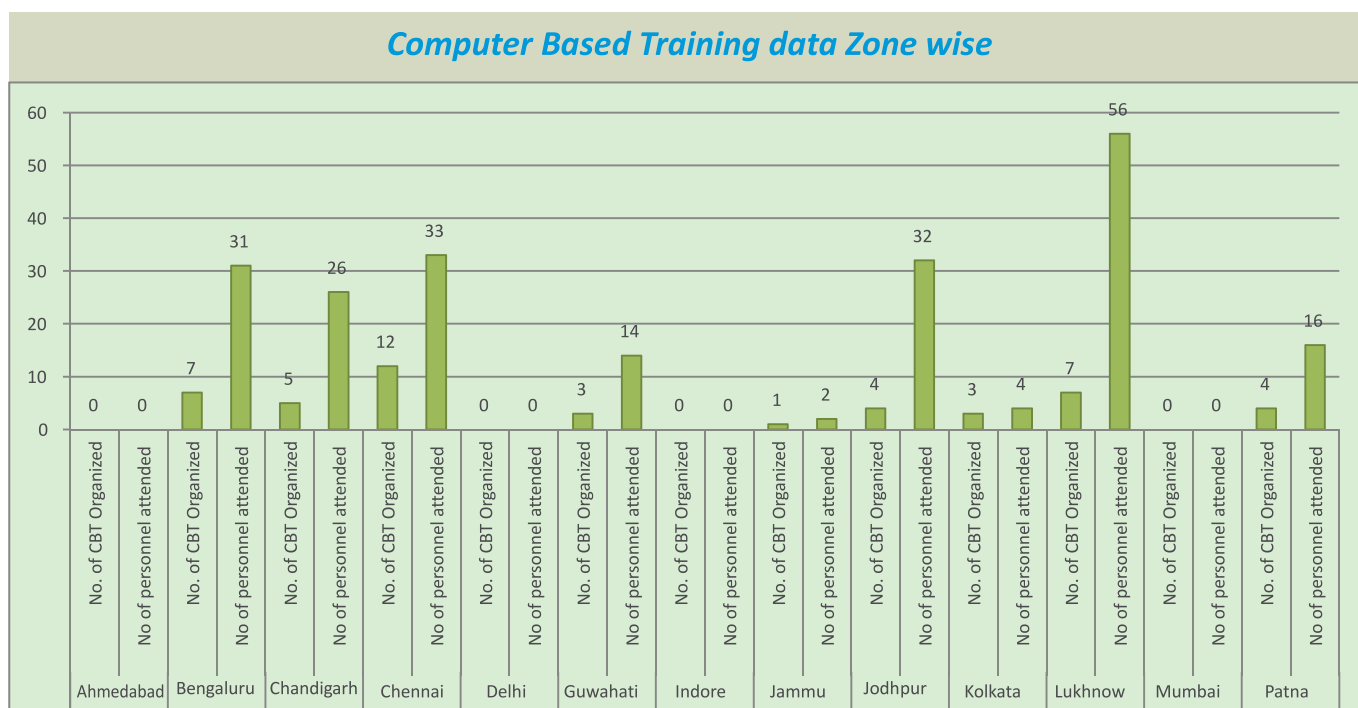

Computer Based Training module

- NCB is organizing CBTs in capacity building for combating illicit trafficking of narcotics drugs and psychotropic substances at CBT established centers at NCB Headquarters and Zones. The bar diagram below shows the number of personnel who attended the CBT training from different organizations.
- The modules cover all aspects of drug law enforcement including intelligence, investigation, precursor trafficking and anti money laundering and is possible to design a variety of courses ranging from few hours to few days, weeks or months. The course content can thus be made specific to the target groups. The interactive nature of the modules facilitates enhancement in retention capacity of the Learners. This module has pre and post test facilities which enables the administrator to assess the impact of learning process.

5. New circular/Guidelines

Reward for officers and informers for NDPS cases

The Government of India has issued new reward guidelines called “The guidelines for grant of rewards to be paid to the officers, informers and other persons, 2017” on 10th October, 2017 to regulate the grant and payment of reward to informers and government officers. As per this policy, an eligible officer is eligible for Rs. 20 lakh /- reward during his entire carrier and Rs. 50,000/- at a time. However a maximum reward of Rs. 2 lakh /- may also be given to an individual in exceptional cases by the Apex Central Rewards Committee. Up to 50% of the total admissible reward amount can be given at pre trial stage if the test report from chemical lab turns positive. As per this policy, the reward sanctioning authority should also consider the factors while granting reward to informers, like, accuracy of the information, degree of risk involved, extent and nature of the help rendered by the informer and whether the information also gave clues of the person involved in the drug trafficking racket. DG , Narcotics Control Bureau, is the Chairman of 03 members central reward committee to process the reward proposal of other Central and State agencies (Except agencies under CBEC) working in the field of drug interdiction. While formulating the Reward Guidelines, 2017, the Government of India has also laid down the following principles:-

- Reward should not be granted as a matter of routine.
- Criteria for grant of reward to informers have been prescribed.
- Provision for special efforts made by the government officials in developing the information, effecting the seizure and post seizure investigation.
- It also excludes any work done by an individual officer in his normal course of duties.

As per the new guidelines, the reward scheme will be made applicable to –

- Informers whose information leads to seizures of Narcotic Drugs, Psychotropic Substances, Controlled substances, forfeiture of illegally acquired property under chapter V A of NDPS Act and contravention of rules made there under, which is booked by any Central and State agencies.
- Officers of Central / State / UTs Government empowered under the provisions of the NDPS Act, 1985 who make seizures, successful investigation/prosecution and conduct post investigation work in respect of contravention of provisions of NDPS Act, 1985.
- Officials of other Central / State / UTs Government who assisted in detecting the contravention of the provisions of the NDPS Act, 1985, Rules or order made there under.

The new reward guideline has not only included new drugs/ psychotropic substances in the revised reward policy but also increased the rate of reward of the seized drug. The revised reward scheme has increased the quantum of reward as per the following tables (I & II):-

स्वापक नियंत्रण ब्यूरो में राजभाषायी उपलब्धियां
