Accused Puithanga is declared PO today.

None for convict R. Lalramchhana.

IO has filed a report in respect of NBWs issued against convict R. Lalramchhana. It is reported that convict was not traceable.

No report is received back on warrants of attachment issued against surety for convict R. Lalramchhana.

It is informed that convict R. Lalramchhana has not deposited fine amount of Rs. 3,000/- imposed upon him on 31.05.2018. It is also informed that FDR pertaining to surety for convict R. Lalramchhana is lying in judicial file. In the facts and circumstances, surety bond is forfeited. A penalty of Rs. 3000/- is imposed upon the surety on account of forfeiture of surety bond. FDR of the surety be sent for encashment to the concerned Bank with the directions to the Bank Manager to deposit a sum of Rs. 3000/- in the Court and to remit the remaining amount of FDR, if any, to the surety.

Copy of order be sent to concerned Bank Manager.

File be consigned to Record Room and be revived as and when accused Lal Rinhngeta and Puithanga are arrested, apprehended or produced.
