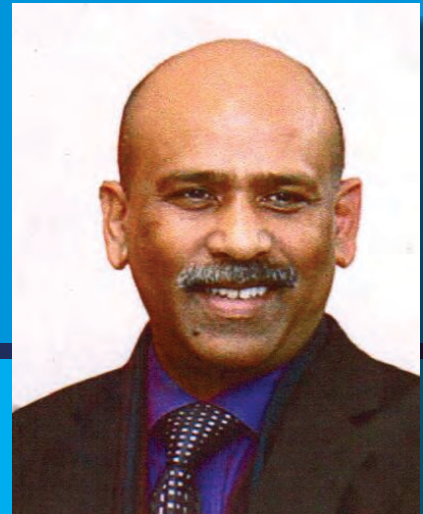

From the Desk of

DIRECTOR GENERAL



I am pleased to present the Annual Report, 2020 for the Narcotics Control Bureau (NCB). The Annual Report highlights the major achievements of NCB in the field of drug law enforcement, coordination efforts at national as well as international level to combat the problem of drug trafficking and also in the field of drug demand reduction. This report also throws light on the trends and patterns of drug trafficking during the period and the scourge of drug abuse as a whole. Besides, the report also delineates the measures taken for capacity building and training of personnel of various drug law enforcement agencies, stakeholders and also the drug demand reduction activities undertaken by NCB.

Apart from its major role in the Drug Supply Reduction Strategy, NCB has also a role to play in the Drug Demand Reduction Strategy of the country. This Annual Report also focuses on the efforts/steps taken by NCB to reduce the public desire for consumption of narcotic drugs or psychotropic substances. During the year 2020, NCB has made sincere and committed efforts to spread awareness against the ill effects of drug abuse among masses by organizing awareness and educational programmes covering approximately 10,395 participants at schools and colleges throughout the country. Moreover, on the occasion of 26th June, i.e., “International Day Against Drug Abuse and Illicit Trafficking”, due to the prevalent COVID-19 pandemic, various online

activities and competitions with 'Anti Drugs' themes were organized throughout the country to spread awareness against drug abuse which garnered much response, especially from the young population.

The geographical location of India renders it an area of concern from the point of view of its possible emergence as both as a source as well as transit country. At present NCB has a pan-India presence through 3 Regional Offices, 13 Zones and 12 Sub-Zones. Regional Offices and field units are actively co-ordinating and mobilizing with State/Central agencies to strengthen their efforts in drug interdiction. NCB Headquarters co-ordinates with foreign countries and organizations like INCB and UNODC. During the year 2020, NCB had participated in 16 international meetings to fulfill the country's international obligation with regard to illicit trafficking in drugs. The professional approach, unmatched valour, devotion to duty and high standards of professionalism of our brave officials has enabled the NCB to face every challenge with aplomb.

I would like to appreciate the team NCB for their efforts in bringing out this Annual Report.

I hope you find this Annual Report both informative and useful. Your feedback and suggestions on how to improve the Annual Report and to make it more comprehensive and useful, are always welcome.

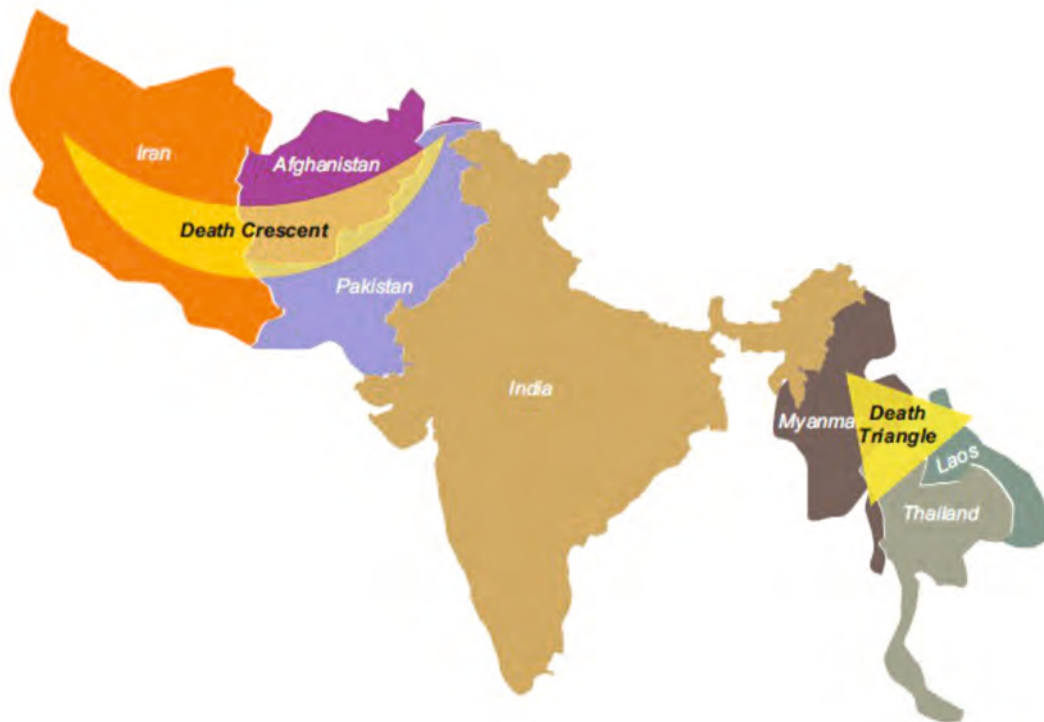

TRAFFICKING SCENARIO IN INDIA

The problem of drug trafficking in India is the consequence of several external and internal factors. One of the prime geographical factors influencing India's drug situation is its close proximity to the Opium producing countries like Afghanistan, Pakistan & Iran in the West as well as

Myanmar, Laos and Thailand in the East which in turn is escalated by the presence of a long maritime border. This has rendered India both a destination and a transit route for opiates as well as synthetic drugs to some extent.

Apart from the above, India has one of the biggest Pharmaceutical and Chemical industrial bases in the world & diversion of pharmaceutical substances from these industries resulting in an increase in the abuse of prescription drugs is a matter of concern. Similarly, some of the Precursor Chemicals which have their origin in India are finding their way to various parts of the world, both legally and illegally, where the diverted chemicals are being used in the illicit drugs manufacturing business. Moreover, illicit cultivation of Opium Poppy and

Cannabis in some parts of the country is also fuelling the drug problem in the country.

1.1 TRENDS AND PATTERNS 2020

- The major Drug trafficking trends in India are highlighted below:
- Trafficking of opiates from South West Asian countries and South East Asian countries to India.

- Maritime trafficking of Heroin and ATS from South West Asian & South East Asian countries to India.
- Illicit cultivation of opium & cannabis in some pockets of the country.
- Increase in trafficking through courier parcels due to disruption in public transportation services during COVID-19 pandemic.
- Increase in instances of trafficking through dark-net involving crypto currencies.
- Involvement of foreign nationals particularly Nigerians, Afghani and Myanmarese nationals in trafficking and distribution networks of Heroin and Cocaine.
- Diversion of pharmaceutical drugs within India and influx of Amphetamine Type Stimulants (ATS) from Myanmar in North Eastern States of India.
- Increase in trafficking of Ganja within India

1.2 NARCOTIC DRUGS

1.2.1 OPIUM

“Opium” means the coagulated juice of the opium poppy, where “opium poppy” means the plant of the species *Papaver somniferum* L. *Papaver somniferum* L. is a plant that grows in many countries around the world with moderate climates. It has white to red flowers and round to elongated capsules containing seeds which can range in colour from white to dark violet.

There are a number of psychoactive substances that can be extracted from opium, with morphine and codeine being the most predominant.



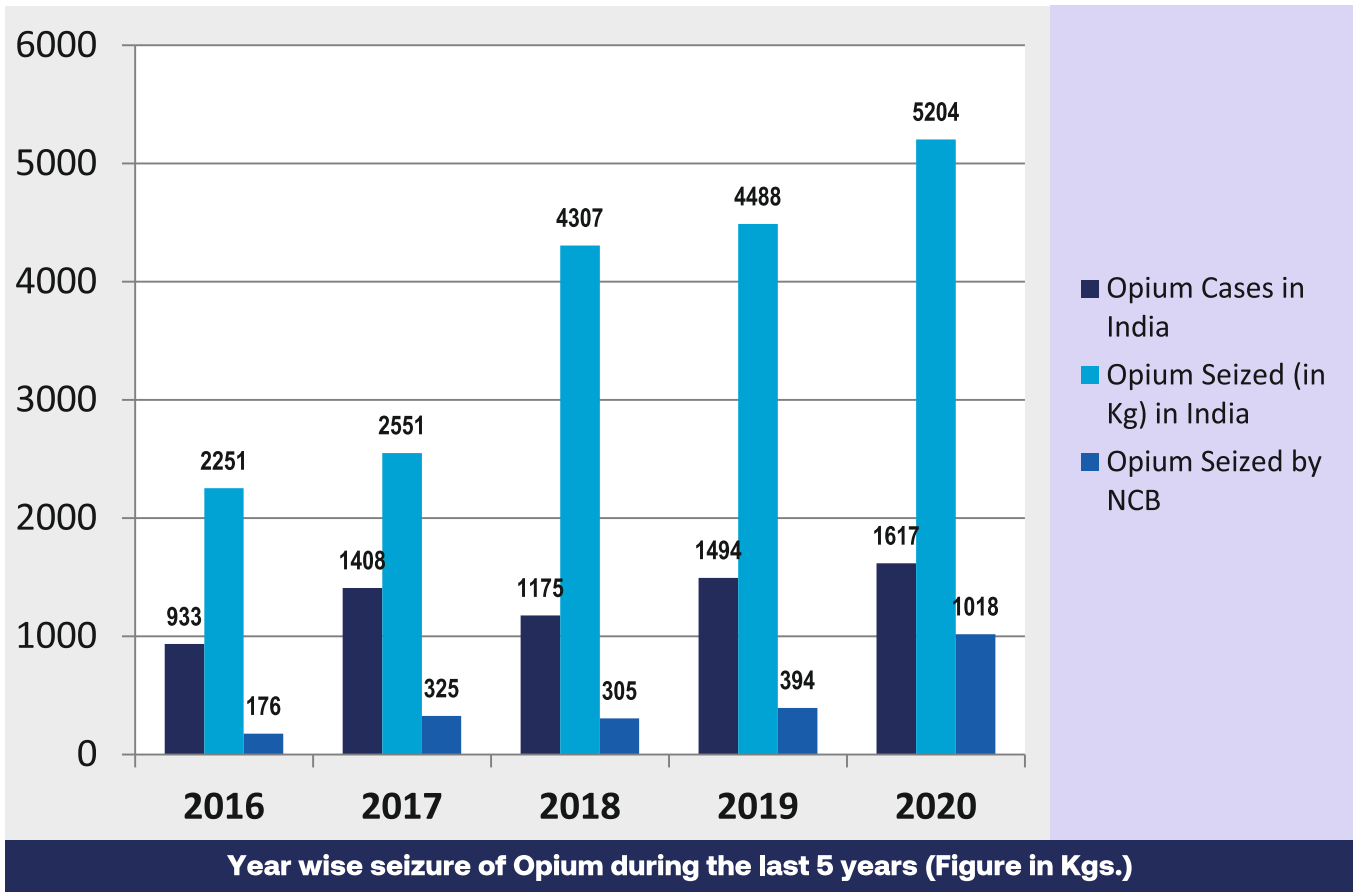

Trends:

- Trafficking from Rajasthan, U.P. and M.P. to other parts of country.
- Major trafficking of Opium is from the states of Manipur, West Bengal, Jammu & Kashmir, Uttarakhand, Bihar, Jharkhand and Gujarat.

Total Opium seizures effected in 2020 were 5212 Kg. The comparative figures for the last 05 years are given below. While there has been an variation of trend in the number of reported Opium seizures in comparison to previous years, up to 2019, the quantity of Opium seized has increased from 4488 Kg in 2019 to 5212 Kg in 2020.

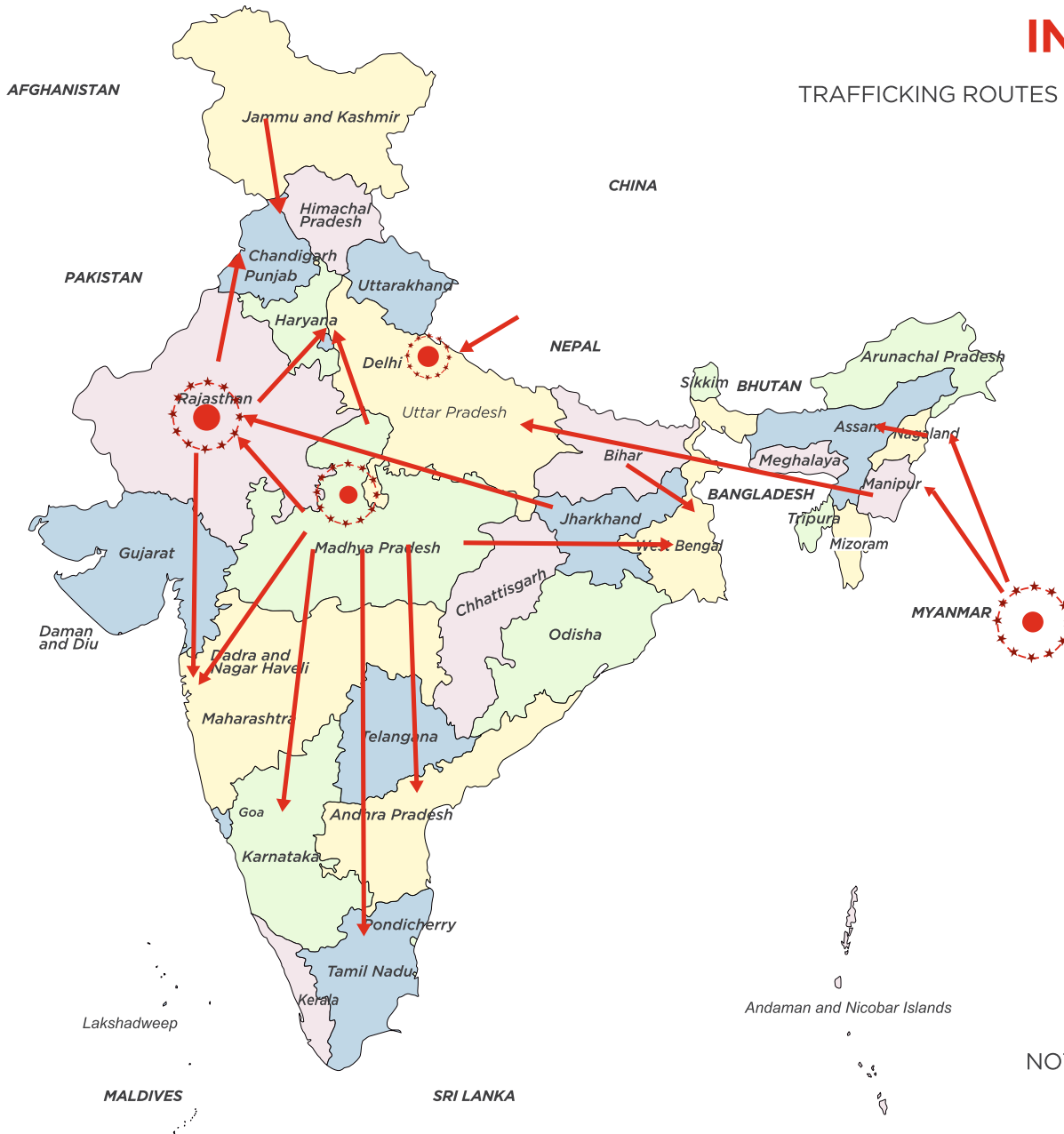

CASE STUDY-BIGGEST OPIUM SEIZURES

1. Seizure by NCB Jodhpur Zone

On 19.07.2020 NCB, Jodhpur team effected a seizure of 233.976 kgs Opium from the residence of accused at Distt- Chittorgarh (Rajasthan). One Scorpio Vehicle was also seized. Two persons, both residents of Rajasthan were arrested in this case.

2. Seizure by NCB Lucknow Zone

On 29/05/2020, NCB Lucknow, acting on a specific intelligence input effected a major seizure of 123.882 KGs of Opium at Paschimi tiraha by-pass, NH-2, Fatehpur, (Uttar Pradesh) and arrested 03 persons. The seized Opium was being carried in a truck. The seized Opium was concealed inside the both side lift tyres and in the driver's Cabin.

During preliminary investigation, one of the accused who was also the intermediary between the supplier and receiver, revealed that the seized drug was supplied by a person and his associate both residents of Chatra, Jharkhand and loaded at Simariya which was further to be delivered to one person at Ambala (Haryana).



Later on the main supplier was identified and Non Bailable Warrant has been issued against him by the Hon'ble Court. Investigation has been kept open against his associate, whose identity has not been confirmed yet.

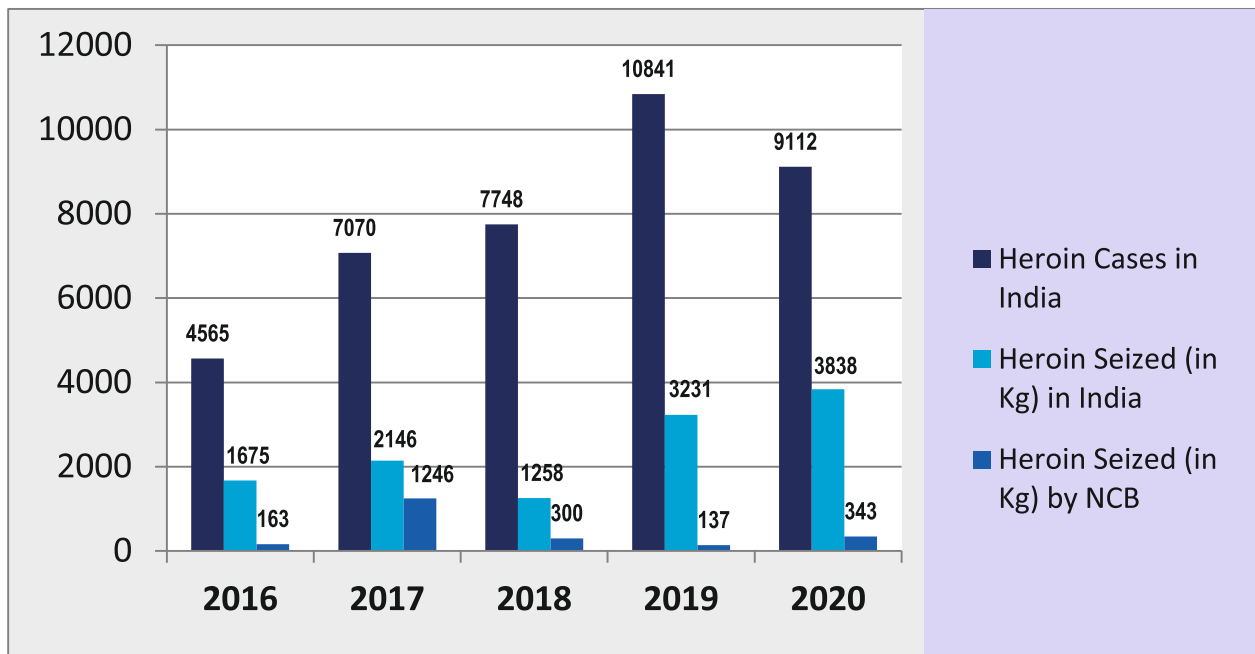
1.2.2 HEROIN

Heroin (diamorphine or diacetylmorphine) is a semi-synthetic opiate synthesized from morphine which, in turn is the most prevalent alkaloid extracted from Opium. There are two main types of Heroin, namely the water soluble diacetylmorphine hydrochloride salt and the relatively water insoluble diacetylmorphine base and both can appear in a range of colours from white to brown. Following injection, heroin is rapidly broken down in the blood to the pharmacologically active 6-monoacetylmorphine and then to morphine, the major active metabolite. Compared to morphine, heroin is more fat-soluble (due to its two acetyl groups), and crosses the blood-brain barrier more rapidly, usually in 15-20 seconds, and achieves relatively higher levels in the brain following intravenous injection, with almost 70 per cent of the dose absorbed into the brain. Oral administration of heroin results in extensive breakdown to morphine. Heroin is approximately twice as potent as morphine and has a high

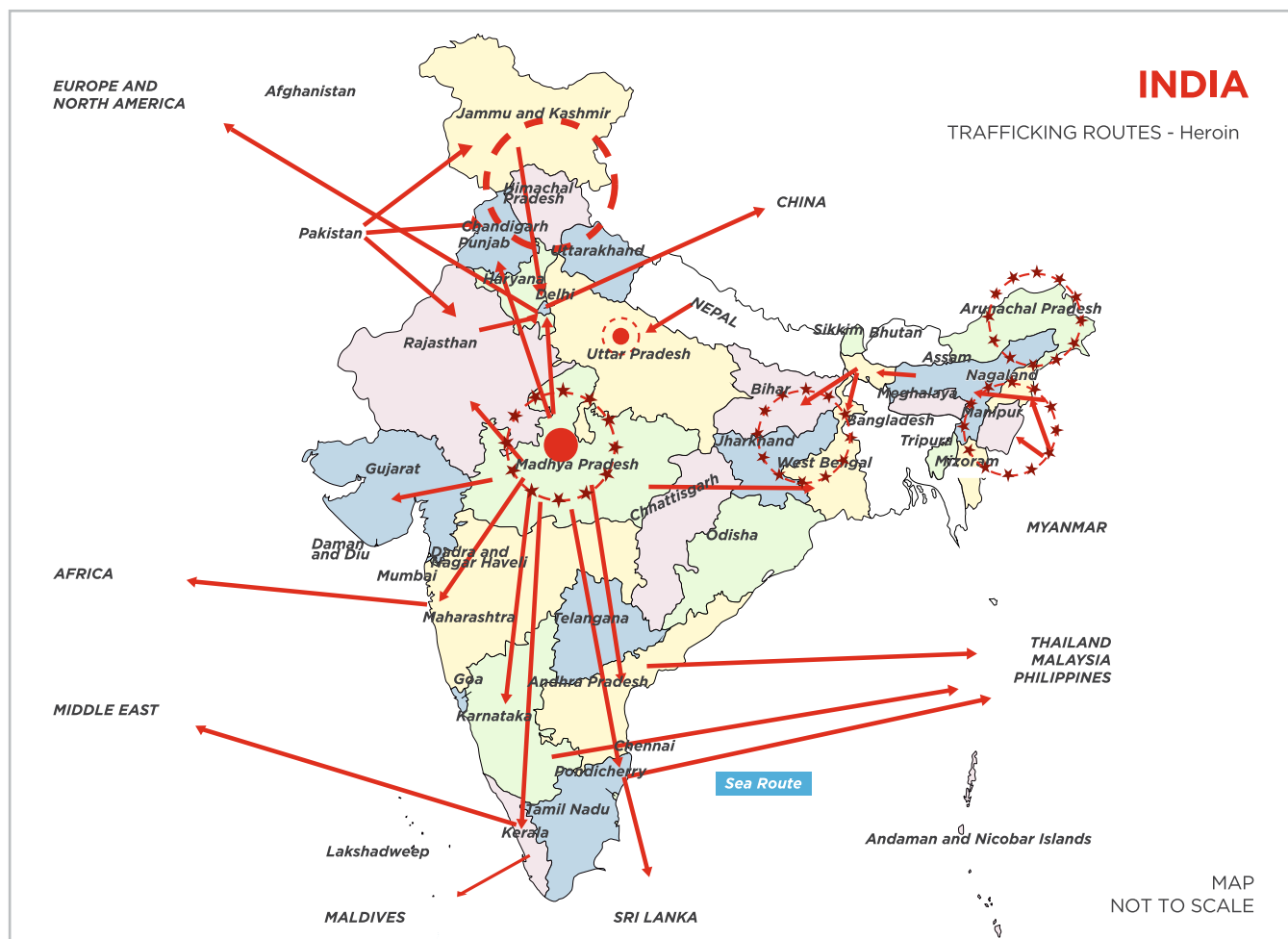
potential for abuse.

Trends:-

- While South West Asian Heroin accounted for around 39% (1256/3231) of the total Heroin seized in India in 2019, in 2020 it saw a huge decline the same as only 9% (329 / 3838) of the total Heroin seized in India was originated from South West Asia
- Major trafficking of Heroin in India takes place through India-Pakistan border, i.e., through bordering states of Punjab and Jammu & Kashmir. From these bordering states Heroin is trafficked into other states.
- Recent trend of increase in Maritime trafficking of South West Asian Heroin through sea.
- Inter-State trafficking of Opium poppy from the states of West Bengal, Uttarakhand, Bihar, Jharkhand, Jammu & Kashmir, and Manipur
- Substantial quantity seizures of Heroin have been effected in Punjab, Delhi, and UP.

CASE STUDY - BIGGEST HEROIN SEIZURES

1. Seizure OF 95.875 Kg OF Heroin – NCB Madurai Sub-Zone (Chennai Zone)

Narcotics Control Bureau received an information from Coast Guard Commandant, Tuticorin intimating about the apprehension of Srilankan fishing boat “Shenaya Duwa alongwith six crew member (Srilankan nationals) and has recovered considerable quantity of drugs and arms and has requested for representatives for joint interrogation on 25.11.2020. Accordingly a team was framed headed by Zonal Director, Chennai Zone and carried out yhe joint interrogation at Tuticorin after which the six apprehended persons alongwith the contraband recovered was handed over to NCB team for seizure formalities at Zone B Harbour, Old VOC Port, Tuticorin.

The NCB Madurai effected seizure of 95.875 kgs of Heroin from 99 parcels, 18.325 kgs of Amphetamine from 20 boxes, 5 Pistols, 10 empty Pistol Magazines, 5 mobile phones, 1 Thuraya Satellite Mobile phone as per procedure on

26.11.2020 at Zone B Harbour, Old VOC Port, Tuticorin. Statement of all the six persons were recorded and based on their voluntary confessional statement and properties seized all the six Srilankan Nationals were arrested and remanded to judicial custody. Based on the voluntary statement given by the six arrested persons, surveillance was mounted at Karapakkam, Chennai and arrested two srilankan nationals. Further one more person was arrested in follow up action on 22.01.2021 at Chennai.



2. Seizure OF 59.600 Kg OF Heroin – NCB Amritsar Sub-Zone (Chandigarh Zone)

Narcotics Control Bureau, Sub-Zone, Amritsar under Chandigarh Zone taken over one of the biggest recovery of Heroin i.e., 60 packets by the troops of 10 Bn BSF, deployed in Dera Baba Nanak, Gurdaspur on 19.07.2020. Pakistani smugglers attempted to smuggle 60 packets of

Heroin through river Ravi near BSF BOP Nangli. Smugglers tried to take advantage of bad weather and flow of Ravi river. They hide all 60 packets in 60 football bladders and tied it with approx 900 meter nylon rope. Alert sentry of BSF observed suspected item coming from Pakistan side to India in river Ravi. They immediately caught the suspected item with the help of boat and recovered 60 packets of Heroin unclaimed.



Further, BSF requested NCB, Amritsar Sub-Zone for handing over the said case. NCB team reached 10 Bn BSF HQ located

at Shikar (Dera Baba Nanak area, Distt. Gurdaspur, Punjab) and seized all 60 packets of Heroin weighing 59.600 Kg and

1.2.3 CANNABIS (GANJA)

“Cannabis” means the flowering or fruiting tops of the cannabis plant (excluding the seeds and leaves when not accompanied by the tops) from which the resin has not been extracted, by whatever name they may be designated. Cannabis contains a number of chemical substances, however the most predominant and only psychoactive substance is (-)-trans-delta9-tetrahydrocannabinol (delta-9-THC or THC).

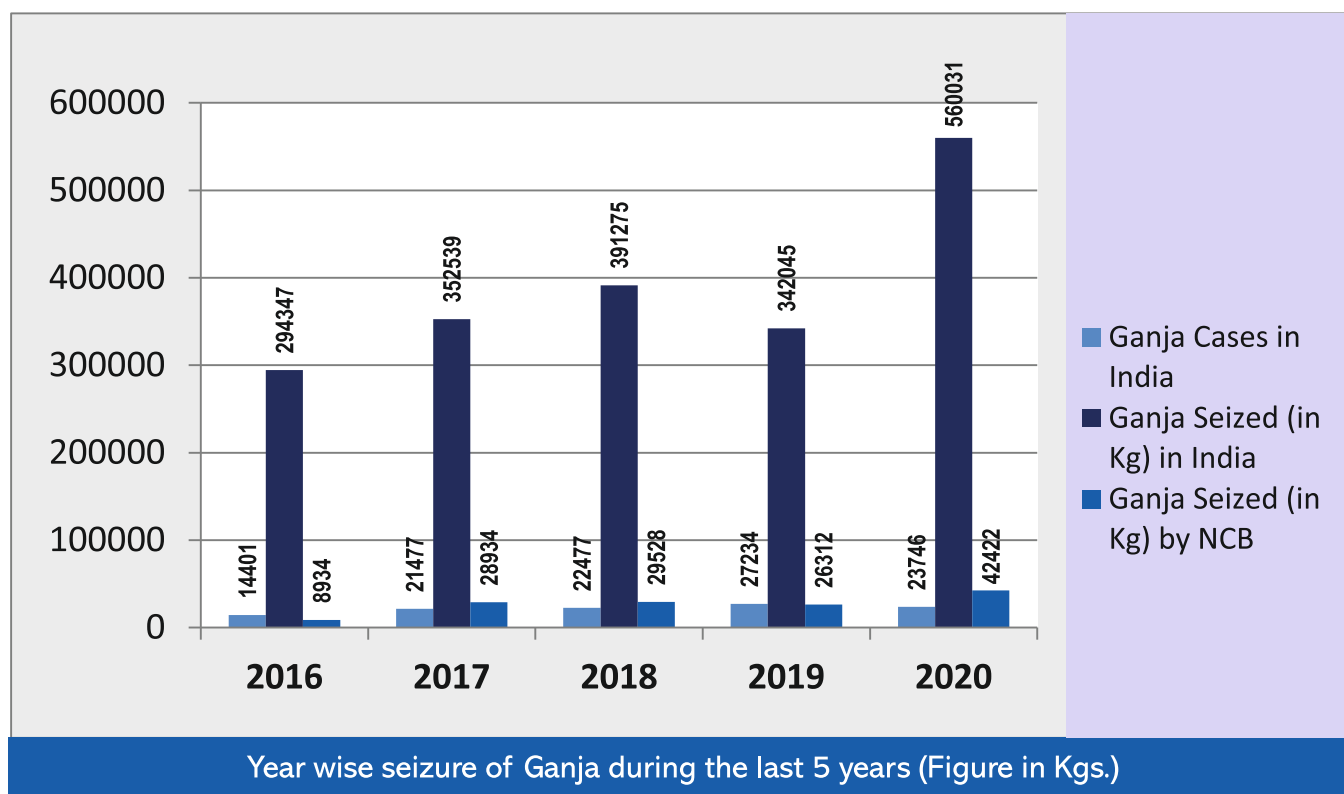


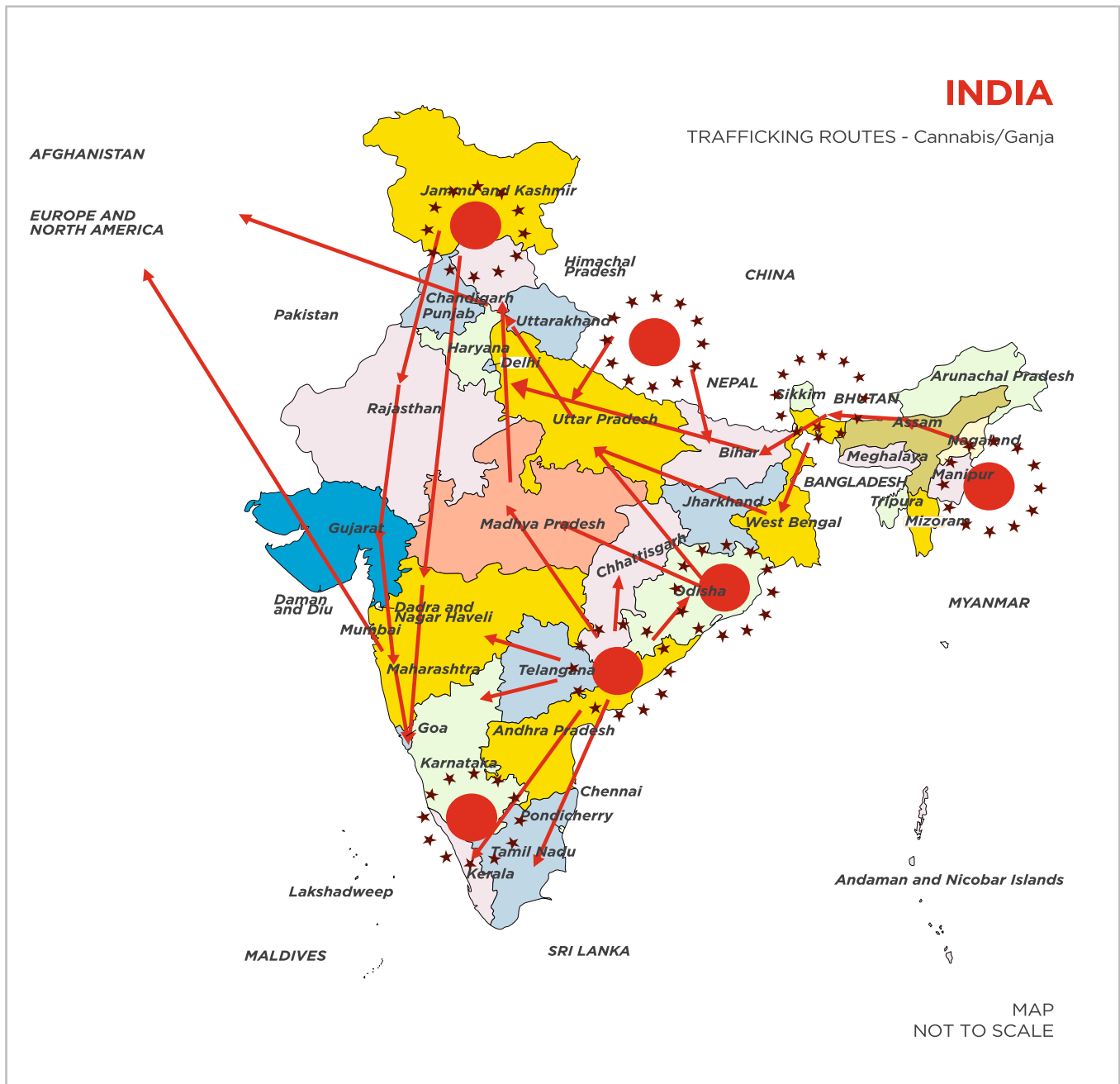
Trends:

Trafficking from the North-East India to eastern states is mainly by surface transport.

Trafficking in substantial quantities takes place across India - Nepal border and in the states of Odisha, Himachal Pradesh and in small quantities from states of Manipur and West Bengal.

The main transit routes for Ganja are through Assam, Odisha, West Bengal, Bihar, Uttar Pradesh, Nagaland, Maharashtra and Chhattisgarh.

Ganja was seized near Health City Hospital, Khanapara, Guwahati, Kamrup (Metro), Assam.

During the search of the truck, the contraband was recovered and 04 persons were apprehended (two from each truck) and were later arrested. Seized drug was sourced from Tripura and destined to Assam / Bihar.



2. Seizure of 1400.2 Kg of Ganja by NCB Patna Zone

Pursuant to specific intelligence a team of NCB Patna Zonal Unit intercepted a truck along with two persons R/o Punjab and Bihar respectively near Didarganj Toll Plaza, NH 30, Patna and brought them to Karpoori Thakur Sadan, Rajiv Nagar, Patna. During search of the truck, 1400.200 Kgs of Ganja concealed beneath 104 sacks of peanuts of dala (lorry) was recovered.



3. Seizure of 2121.9 Kg of Ganja by NCB Lucknow Zone

On 07.08.2020, NCB, Lucknow Zonal Unit along with STF, Varanasi intercepted a container truck near Chakia Mor, Chandauli (UP) and seized 2121.9 KGs of Ganja which was hidden in custom made cavity, fabricated behind driver's cabin of the truck. One person was arrested in this connection. The preliminary investigation revealed that Ganja was sourced from Salur, Andhra Pradesh and was destined to Prayagraj (UP) based receiver.

1.2.4 CANNABIS (HASHISH)

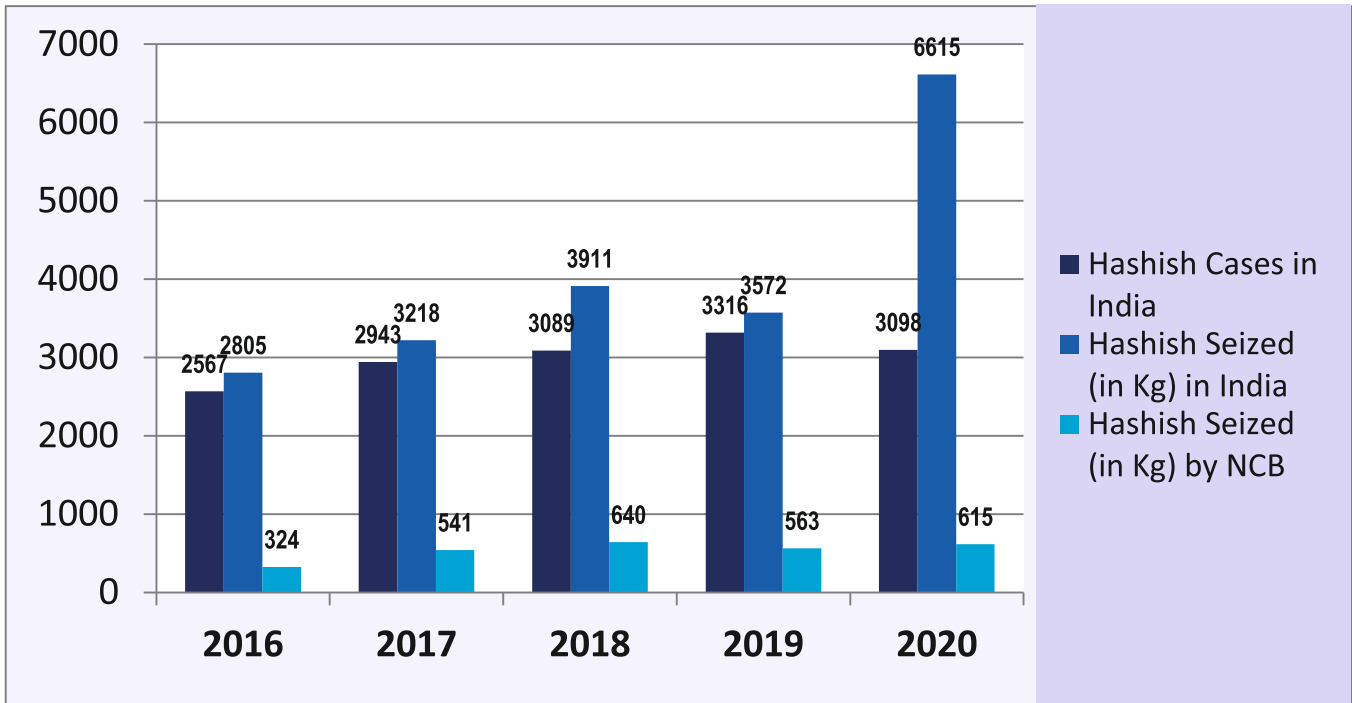
Hashish, or Charas, is a drug extracted from cannabis. Hashish is the separated resin, whether crude or purified, obtained from the cannabis plant. Characteristically, cannabis resin is the dried brown or black resinous secretion of the flowering tops of the cannabis plant. Cannabis resin is placed under Schedule I and IV of the Single Convention on Narcotic Drugs of 1961.

Trends:

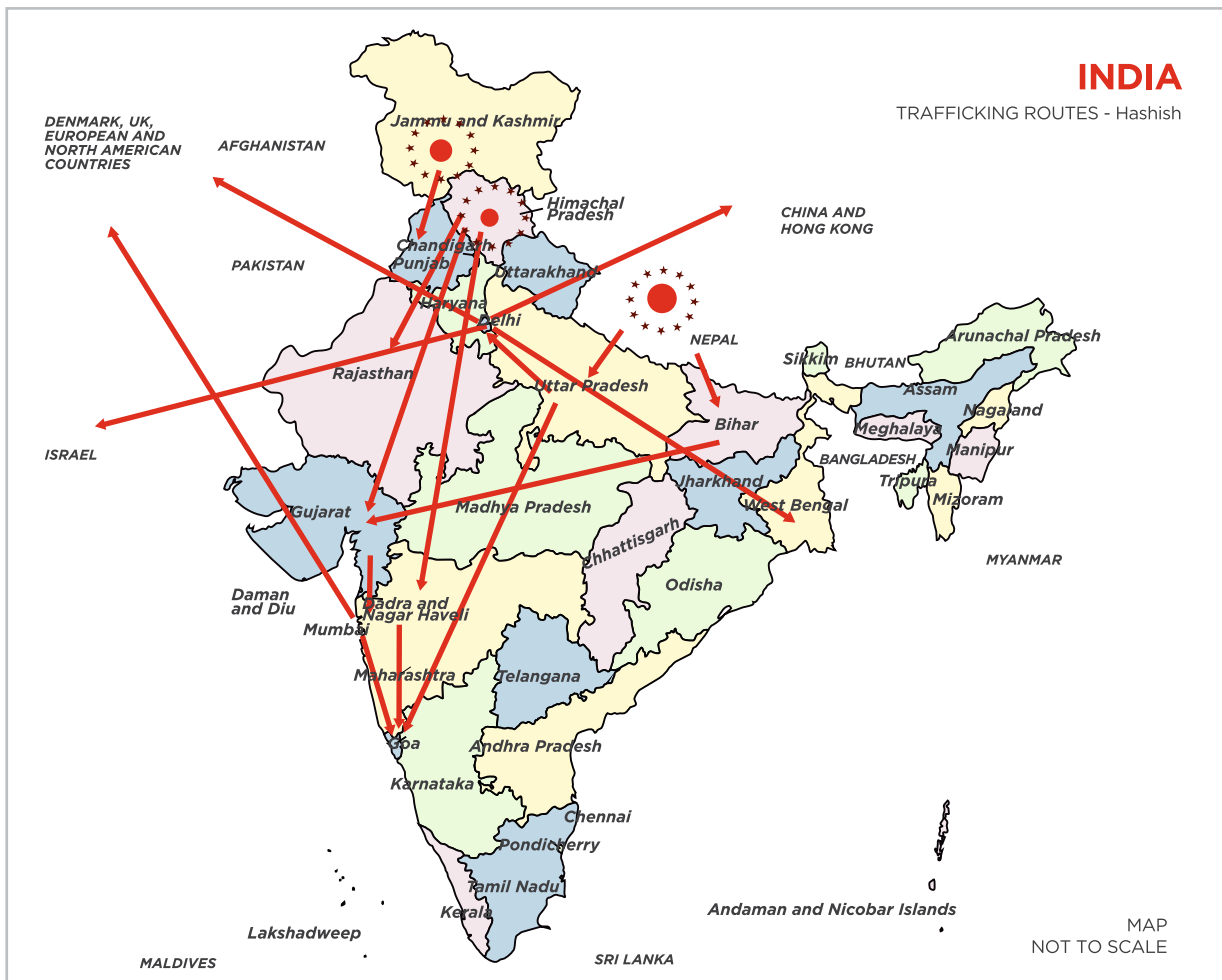
- Charas/Hashish is derived from the illicit cannabis cultivation being done by the drug traffickers at Kashmir Valley especially in the districts of South Kashmir and Kullu in Himachal Pradesh.

- There is a trend of trafficking of Charas from Kashmir and Himachal Pradesh to Maharashtra, Rajasthan, Goa & Gujarat and other metro towns of India.
- Charas is also trafficked from Nepal to India.

Officers of Narcotics Control Bureau, Jammu recovered 54.400 Kgs Charas & Rupees 1,91,000/- from the possession of two persons and a lady all residents of Delhi near Ban Toll Plaza, Jammu on 15.09.2020, and arrested them under section 8, 20, 29 & 60 of the NDPS Act, 1985 on 16.09.2020 . Further 02 kg charas was also recovered from the seized vehicle UP-14CP-0029 on 18.09.2020 during the interrogation.

According to the voluntary statement of one of the accused & further investigation, voluntary statement of Mumbai based receiver was recorded on 11.10.2020 at Colaba, Mumbai and accordingly he was arrested on 11.10.2020.



2. Seizure of 50 Kg of Charas by NCB Patna Zone

On 18.02.2020, NCB Patna Zonal Unit seized 50 Kgs of Charas which was originally recovered by 47 BN, SSB, Pantoka one Scorpio car, and arrested two accused.

After completing medico-legal formalities they were produced before the L'd Court of Special Judge, Motihari on 19.02.2020 and remanded to judicial custody.



3. Seizure of 30.860 Kg of Charas by NCB Lucknow Zone

Brief of operation conducted: - Acting upon the inputs on trafficking of Charas from Nepal to Uttar Pradesh, on 11.03.2020, the Narcotics Control Bureau, Lucknow Zonal Unit launched an operation with SSB, Rupaidiha of 42nd Bn, Nanpara and succeeded in intercepting a Tempo Traveller in the possession of two persons, both r/o Nagar PalikaTulsi Nagar, Nepal in the

intervening night of 11/12th March, 2020 at Rupaidiha, Bahraich. Arrested persons were produced before the ASJ, Bahraich on 13.03.2020. Spot interrogation revealed that the seized Charas was sourced from one lady r/o Nepal who herself was likely to receive the same at Rupaidiha, Bahraich.



1.2.5 COCAINE

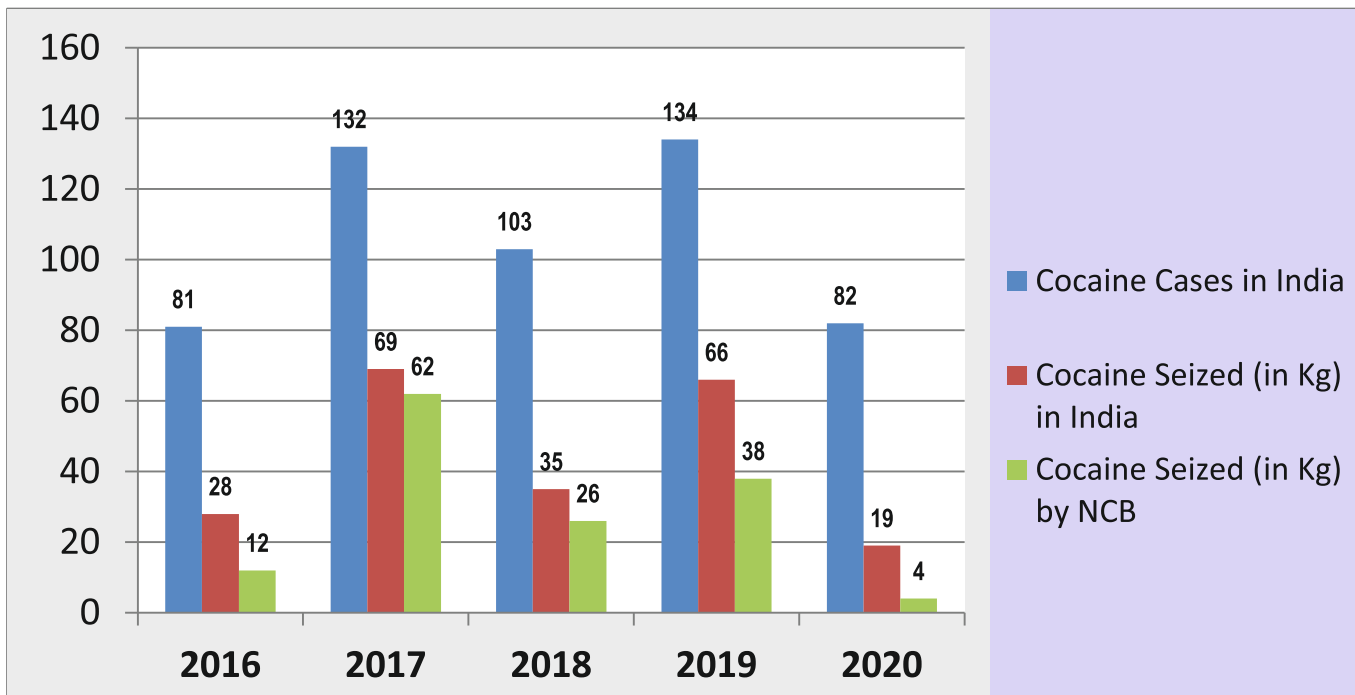
Cocaine is the main psychoactive alkaloid obtained from coca leaves. It is generally encountered in two forms which differ in their route of administration. Cocaine hydrochloride, which is insufflated or injected, and cocaine base, which is a smokable form.

Crack and freebase are terms used for different forms of cocaine base generated from purified cocaine hydrochloride through specific conversion processes to make them suitable for smoking. Inhalation of the heated vapours of cocaine base results in a quick onset of effects due to the rapid absorption of the substances in the lungs. However, inhalation of cocaine pyrolysis products can be toxic and cause respiratory problems.

Trends:

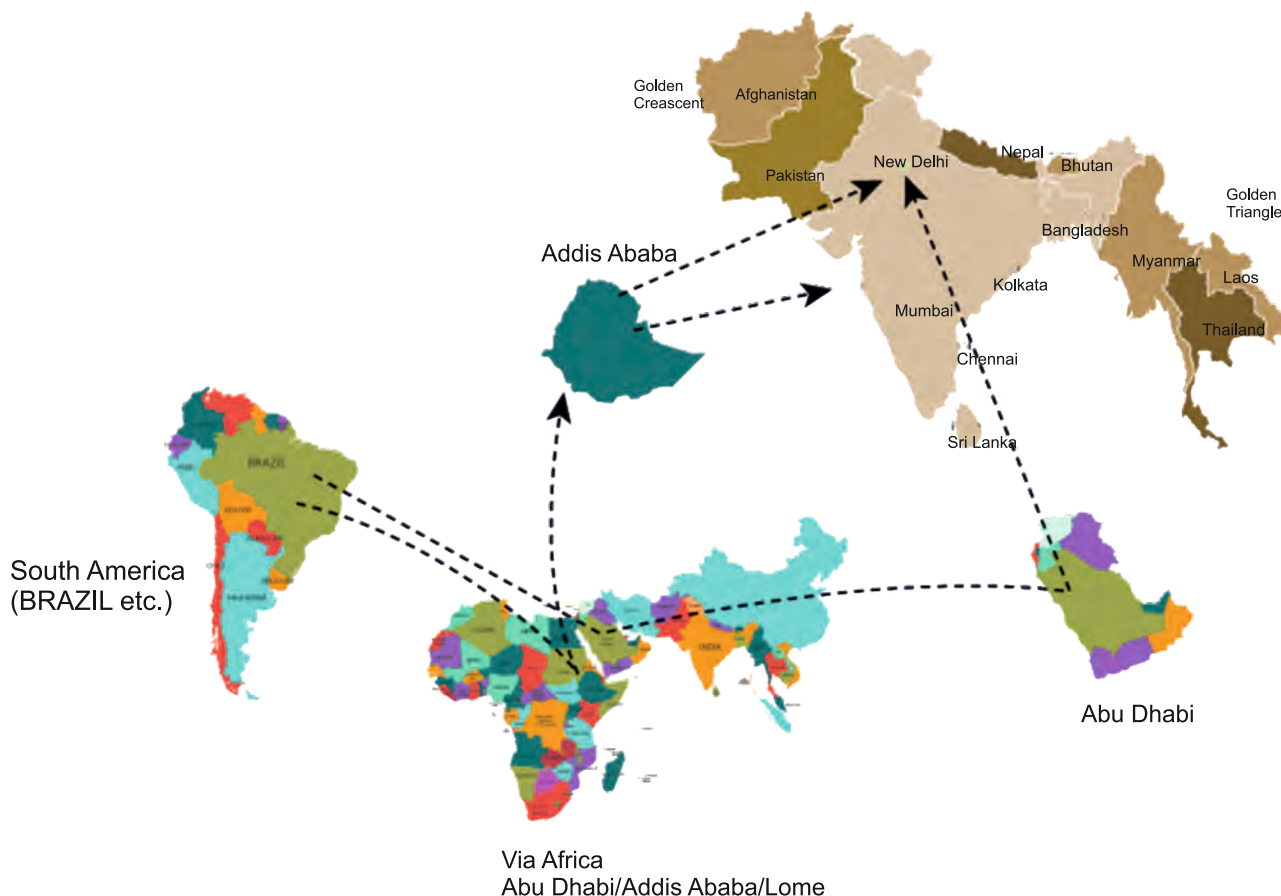
- Smuggling of cocaine is mostly being done by African nationals based in India.

- Instances of Cocaine being smuggled from Afghanistan, Argentina, Brazil and South America have also come to notice.
- Seizures of Cocaine in India have been made at airports mostly.
- There are many instances of small quantities of Cocaine trafficking through parcels concealed in common household articles like cosmetics, utensils, books and clothing.
- The latest trend is trafficking of Cocaine in liquid form.

Significant seizures of Cocaine by NCB:

- On 15.02.2020, Officers of NCB, Delhi Zonal Unit seized 1.795 kg of Methamphetamine, 250 gram of Cocaine and 95 gram of Heroin at Foreign Post Office, Kotla Road ITO, New Delhi.
- On 03.03.2020, Officers of NCB, Delhi Zonal Unit seized 255 gram of Cocaine and 30 gram of Methamphetamine. 01 person was arrested.
- On 01.09.2020, Officers of NCB, Delhi Zonal Unit seized 670 gram of Cocaine at Customs Examination Area, IGI Airport, New Delhi.
- On 01.09.2020, Officers of NCB, Delhi Zonal Unit seized 970 gram of Heroin at Customs Examination Area, IGI Airport, New Delhi. In follow up action 7.131 kg of Heroin, 1.100

kg of Ganja & 445 gram of Cocaine was seized. Total 07 persons were arrested.

- On 02.09.2020, Officers of NCB, Bangalore Zonal Unit seized 256.5 gram of Cocaine at Foreign Post Office, Chamarajpet, Bangalore, Karnataka.
- On 02.09.2020, Officers of NCB, Bangalore Zonal Unit seized 630 gram of Cocaine at Air Cargo Complex, Bangalore airport, Karnataka.
- From 12.10.2020 to 18.10.2020, Officers of NCB, Mumbai Zonal Unit seized 1.034 kg of Cocaine, 1.966 kg of Phencyclidine, 29.300 kg of narcotic drug, 114.675 kg of liquid precursor & 353 gram of Ephedrine at Mumbai, Maharashtra. 04 persons were arrested.

- On 13.10.2020, Officers of Air Customs Preventive, IGI Airport, New Delhi seized 2.304 kg of Cocaine. 01 person was arrested.
- On 01.12.2020, Officers of NCB, Delhi Zonal Unit seized 118 gram of Cocaine at Andheri West, Mumbai. 01 person was arrested.
- On 18.12.2020, Officers of NCB, Delhi Zonal Unit seized 114 gram of Cocaine & 10 gram of Methamphetamine at Uttam Nagar, New Delhi. 01 person was arrested.
- On 21.12.2020, Officers of NCB, Delhi Zonal Unit seized 190 gram of Cocaine & 02 kg of Methamphetamine at New Delhi Railway Station, New Delhi. 02 persons were arrested.
- On 21.12.2020, Officers of NCB, Bangalore Zonal Unit seized 235 gram of Cocaine at Foreign Post Office, Bangalore. 02 persons were arrested.

CASE STUDY-BIGGEST COCAINE SEIZURES

1. Seizure of 1.034 Kg Cocaine by NCB Zonal Unit, Mumbai

- On the basis of intelligence developed by NCB Mumbai on 12.10.2020, a team of NCB Mumbai seized approx 1 Kg Cocaine and 02 Kg PCP from a resident of Palghar, Mumbai, who during interrogation revealed that one other accused also resident of Palghar, Mumbai had provided him the contraband for selling.
- Further on 13.10.2020, NCB Mumbai team apprehended the supplier and based on his disclosure a total of 29.3 Kg of MDMA was recovered from his godown on 14.10.2020.
- Subsequently both accused persons were arrested and Hon'ble Court, Esplanade,

Mumbai provided their custody to NCB till 19.10.2020, wherein both disclosed that all the drugs belonged to a third accused and his brother.

- NCB Mumbai Team intercepted third accused on 14.10.2020, who confessed that Cocaine, PCM & MDMA seized earlier by NCB in this case belongs to him & his brother who is already an accused in DRI case of 483 Kg Ephedrine in March 2020 and is presently out on bail.
- Based on his disclosure, NCB team raided an isolated godown where 61.8 Kg of liquid chemical believed to be precursor was seized and he was arrested on 16.10.2020 and Hon'ble Court provided his custody to NCB till 19.10.2020.
- His brother was taken in NCB custody from Yerwada Jail, Pune and subsequently arrested on 04.11.2020 in this case.
- On confrontation between first two accused, they disclosed that a small quantity of contraband items and liquid chemical is there in his godown, which was given by third accused & his brother. Based on the disclosure, on 18.10.2020, NCB Mumbai seized 353 gm Ephedrine and 52.8 Kg liquid chemical believed to be Propiophenone precursor.

2. Seizure of 670 gram of Cocaine by NCB Zonal Unit, Delhi

In pursuance to the Director General, Narcotics Control Bureau order under the provisions of section 50A of the NDPS Act for conducting controlled delivery of parcel bearing AWB No-1735174092 which was believed to containing Narcotics drugs, NCB, Delhi Zonal Unit has seized the parcel on 01.09.2020 from IGI Airport, Custom Area, Delhi. The parcel was opened and found to contain 670 grams of

Cocaine. All recovered substance was seized under the provision of NDPS act after observing all the legal formalities in the presence of independent witness.

The said parcel originated from Addis Abada with consignor details as Hiwot Hagere, Addis Abada Ethiopia, whereas the consignee was R/o- Nalasopara East, Palghar, Maharashtra, India.

Further, on 17.09.2020 attempt was made to deliver the parcel (under controlled delivery) to the consignee address at his residence Nalasopar Vasai Link Road, Behind Adit Banquet, Nalasopar East Palghar, Maharashtra with the help of Aramex Cargo staff and the accused was apprehended when he was

receiving the parcel. On the basis of his disclosure, two other persons associated with him were also apprehended. All the accused persons are presently in judicial custody at Tihar Central Prison.



1.3 NARCOTIC CROPS

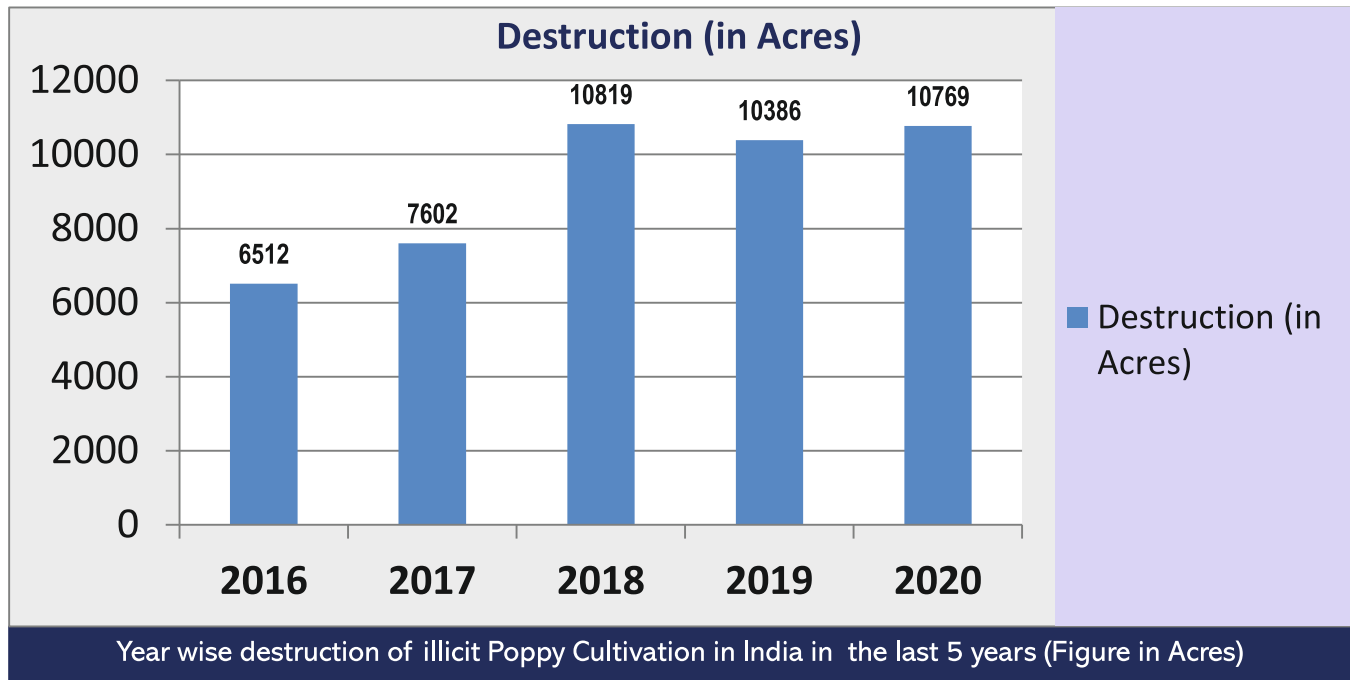
1.3.1 Licit Opium Poppy Cultivation

Licit cultivation of Opium Poppy is carried out in India in selected tracts notified by the Central Government annually in the States of Madhya Pradesh, Rajasthan and Uttar Pradesh. Licences are issued by the CBN to eligible cultivators in the above three States as per the General Conditions relating to Grant of Licence framed by the Central Government.

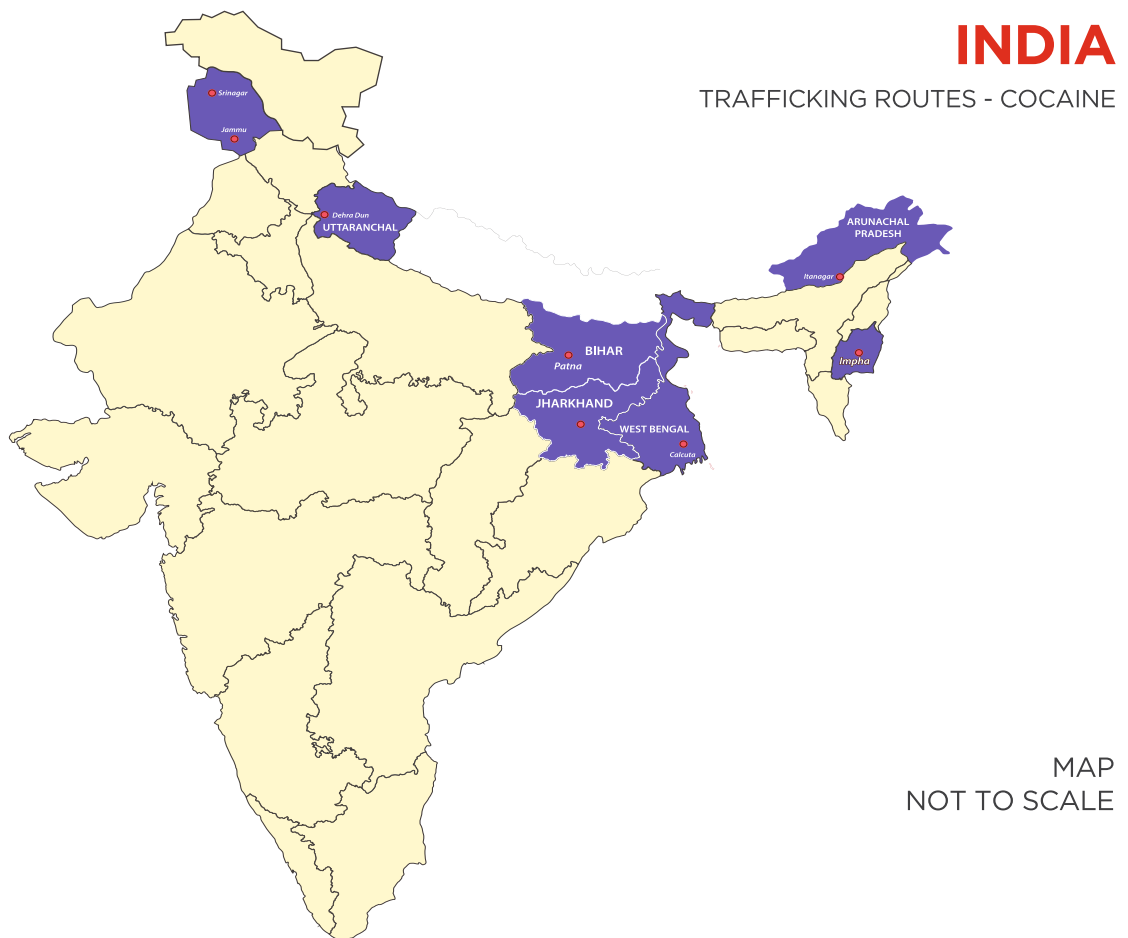
1.3.2 Illicit Opium Poppy Cultivation

Illicit cultivation of Opium poppy has been endemic in several parts of the country, both for the production of poppy seed as well as to obtain opium. Such cultivation on a noticeable scale has been reported in the past from Jammu & Kashmir, Himachal Pradesh, Uttarakhand, Bihar, Jharkhand, West Bengal, Manipur and Arunachal Pradesh.

During 2020, illicit cultivation of opium poppy was found in the states of West Bengal, Arunachal Pradesh, Assam, Manipur, Jharkhand, Bihar, Jammu & Kashmir, Rajasthan and Himachal Pradesh.



Illicit Opium Poppy Cultivation in In India





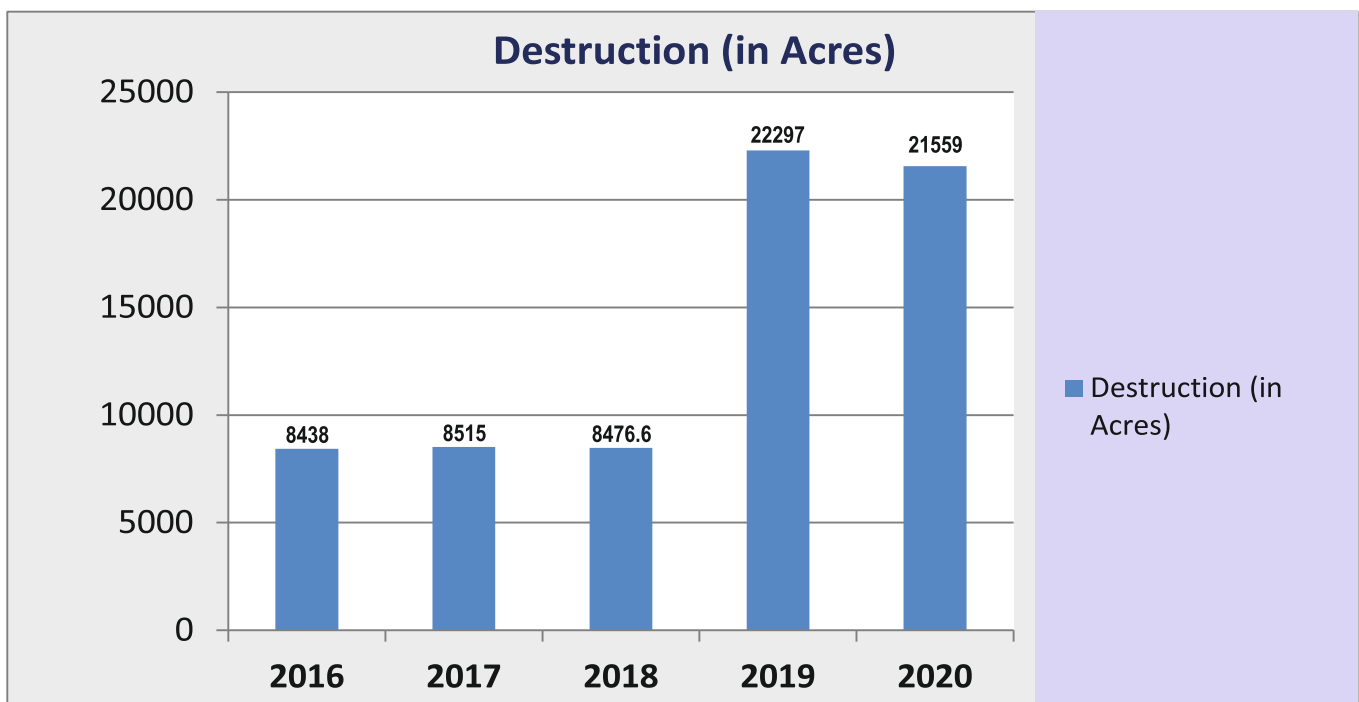
Destruction of illicit opium poppy cultivation

- During 2020, officers of NCB, Guwahati Zone, Local Police & District Administration destroyed illicit cultivation of Opium Poppy spread over 7858 acre of land in Arunachal Pradesh and 20 acre of land in Assam.
- During 2020, officers of NCB, Imphal Sub Zone along with NAB, Manipur Rifles, Local Police & District Administration destroyed illicit cultivation of Opium Poppy spread over 1382 acre of land in Manipur.
- During 2020, officers of NCB, Patna Zone, Local Police & District Administration destroyed illicit cultivation of Opium Poppy spread over 91 acre of land in Bihar and 495 acre of land in Jharkhand.
- During 2020, officers of NCB, Kolkata Zone, Local Police & District Administration destroyed illicit cultivation of Opium Poppy spread over 19 acre of land in West Bengal.
- During 2020, officers of NCB, Jammu Zone, Local Police & District Administration destroyed illicit cultivation of Opium Poppy spread over 893 acre of land in Jammu & Kashmir.
- During 2020, officers of NCB, Chandigarh Zone & Mandi Sub Zone, Himachal Police & District Administration of Himachal Pradesh destroyed illicit cultivation of Opium Poppy spread over 10 acre of land in Himachal Pradesh.

1.3.3 Illicit Cannabis Cultivation

Under the NDPS Act, as also under the UN Drug Control Conventions, the cultivation of Cannabis is illegal. One of the important countermeasures undertaken by NCB is to identify and destroy illicit cultivation of the plant. In 2020, the area under illicit cannabis

cultivation was detected to be around 21559 acres, in the states of Odisha, Himachal Pradesh, Jammu & Kashmir, West Bengal, Manipur, Tripura, Tamil Nadu, Karnataka and Telangana which was subsequently destroyed by various Central & State agencies.

- During 2020, Officers of NCB, Sub-Zone, Bhubaneswar, Odisha Police, Excise, Forest and Para military forces carried out Illicit Cannabis cultivation destruction operation and destroyed Cannabis cultivation spread over 18361 acres in Odisha.
- During 2020, Officers of NCB, Sub-Zone, Chandigarh Zone & Mandi Sub-Zone, Himachal Police, Excise, Forest and district administration carried out Illicit Cannabis cultivation destruction operation and destroyed Cannabis cultivation spread over 1582 acres in Himachal Pradesh.
- During 2020, Officers of NCB, Sub-Zone, Imphal, Local Police, Excise, Forest, Para

military forces and district administration carried out Illicit Cannabis cultivation destruction operation and destroyed Cannabis cultivation spread over 1284 acres in Tripura.

- During 2020, Officers of NCB, Jammu Zone, Local Police, Forest and district administration carried out Illicit Cannabis cultivation destruction operation and destroyed Cannabis cultivation spread over 295 acres in Jammu & Kashmir.

1.3.4 Release of funds to NCB Zonal units for carrying out destruction of

illicit crop cultivations

NCB provides funds to its Zonal Units for carrying out destruction of illicit cultivation of Opium Poppy and Cannabis on the basis of proposals received. This fund is primarily released from NFCDA (National Fund for Control of Drugs Abuse) which NCB obtains from Department of Revenue from time to time.

The details of funds released to the Zonal Units of NCB for carrying out destruction operation of illicit crop cultivation in the year 2020 are given below:-

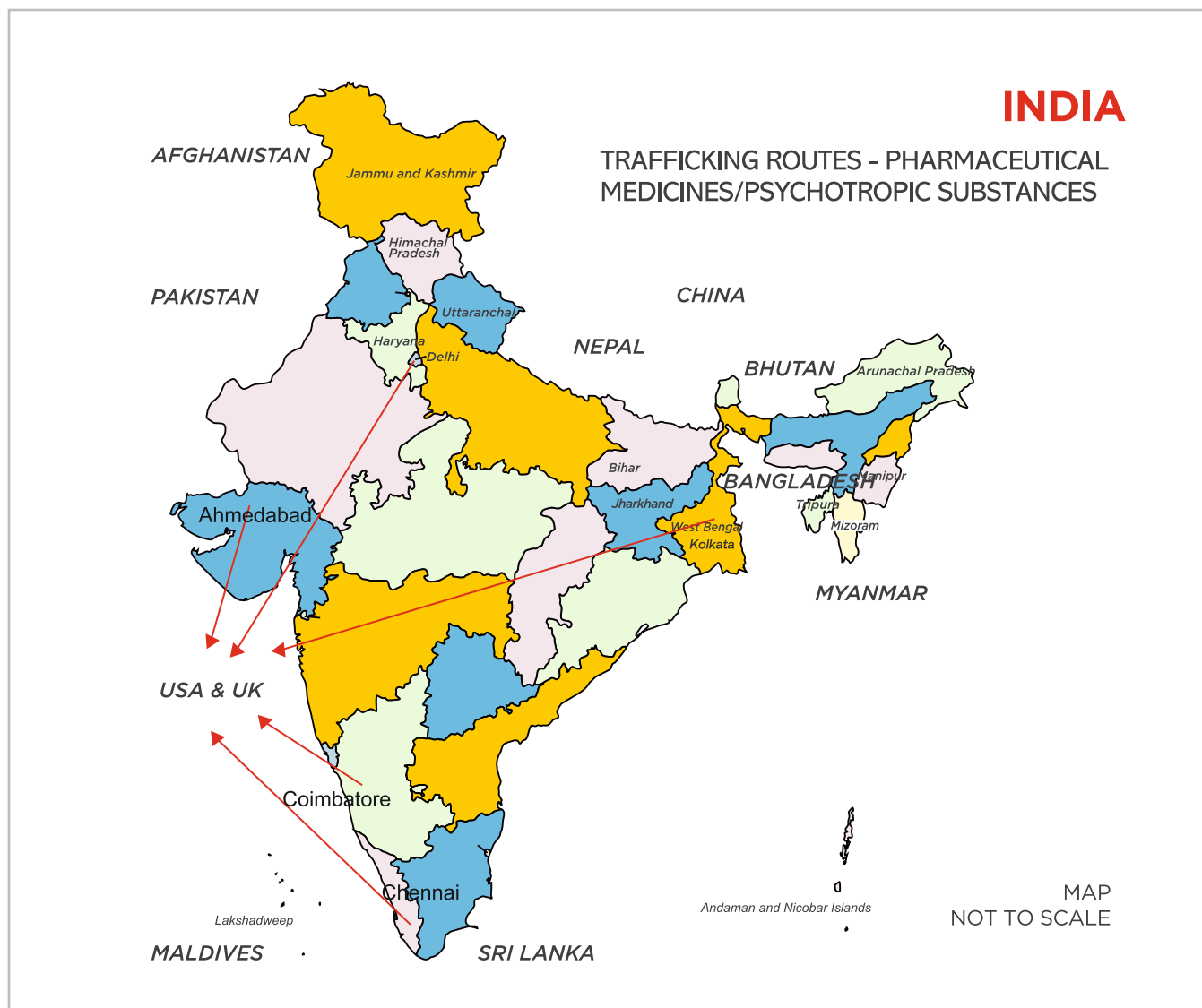
1.4 PSYCHOTROPIC SUBSTANCES

Psychotropic Substances are any chemical agent affecting the mind or mental processes (i.e. any psychoactive drug). In the context of international drug control, “psychotropic substance” means any substance, natural or synthetic, or any natural material in Schedule I, II, III or IV of the 1971 Convention.

According to the NDPS Act, "psychotropic substance" means any substance, natural or synthetic, or any natural material or any salt or preparation of such substance or material included in the list of psychotropic substances specified in the Schedule. The Schedule includes substances like ATS, Methamphetamine, Methaqualone, Alprazolam, Diazepam, Buprenorphine, etc. A new psycho-active substance referred to as Mephedrone was newly included in the list of psychotropic substances, during the year 2016.

The Government of India has notified 13 substances on 27th February, 2018 under the NDPS Act, 1985. The details of which are as under:

 - (ii) **N-Phenethyl-4-piperidone (NPP)**



1.4.1 Synthetic Drugs

The abuse of synthetic drugs is one of the fast emerging challenges for drug law enforcement agencies. Synthetic drugs like Amphetamine Type Stimulants (ATS) have become the drug of choice in South East Asia and in North America. In India, several attempts have been made in the past to set up clandestine manufacturing facilities, especially in Maharashtra and Gujarat to produce ATS.



Trends:

- Trafficking of ATS from Myanmar to India along North-Eastern Border States.
- Australia, Malaysia and Thailand are the major destination countries for ATS trafficking sourced from India.
- USA, Australia, Malaysia and South Africa are the major destination countries for Methaqualone/ Mandrax sourced from India.
- A major portion of Methaqualone/ Mandrax seizures are effected at Airports of New Delhi, Kolkata and Mumbai.

Significant seizures of Methaqualone by NCB:

- On 17.02.2020, Officers of NCB, Bangalore Zonal Unit seized 700 gram of Methaqualone at Yeshwanthpur Railway Station, Bangalore. 01 Nigerian national was arrested.
- On 06.11.2020, Officers of NCB, Delhi Zonal Unit seized 816 gram of Methaqualone at DHL Express India Pvt. Ltd., Kirti Nagar, New Delhi.

Significant seizures of Amphetamine Type Stimulants (ATS) by NCB:

- On 07.01.2020, Officers of NCB, Bangalore Zonal Unit, on the basis of operational input received from NCB, Ahmedabad Zonal Unit seized 1.020 kg of Hashish and 500 gram of Methamphetamine at Sanjay Nagar, Bangalore. 02 persons were arrested.
- On 17.01.2020, Officers of NCB, Imphal Sub-Zone seized 970 grams of Methamphetamine at Khudengthabi check post, Tengnoupal, Manipur. 01 person was arrested.
- On 29.01.2020, Officers of NCB, Guwahati Zonal Unit seized 1.992 kg of Methamphetamine at Khanapara,

Guwahati. 03 persons were arrested.

- On 13.02.2020, Officers of NCB, Chennai Zonal Unit seized 5.000 kg of Methamphetamine at Valsarvakkam, Chennai. 04 persons were arrested.
- On 22.02.2020, Officers of NCB, Guwahati Zonal Unit seized 5.150 kg of Methamphetamine at Beltola, Guwahati. 05 persons were arrested.
- On 25.02.2020, Officers of NCB, Kolkata Zonal Unit seized 390 gram of Methamphetamine at Balurghat, Dakshin Dinajpur, West Bengal.
- On 08.03.2020, Officers of NCB, Kolkata Zonal Unit seized 5,000 tablets of Methamphetamine at BSF BOP-Hili, South Dinajpur, West Bengal.
- On 18.03.2020, Officers of NCB, Mumbai Zonal Unit seized 680 gram of Amphetamine at DHL, Andheri, Mumbai.
- On 09.06.2020, Officers of NCB, Guwahati Zonal Unit, seized 1.190 kg of Methamphetamine at Beharbari, Guwahati, Assam. 03 persons were arrested.
- On 07.07.2020, Officers of NCB, Mumbai Zonal Unit seized 2.300 kg of Amphetamine at RPF, Diva Railway Station, Mumbai. 01 person was arrested.
- On 04.09.2020, Officers of NCB, Chennai Zonal Unit seized 721 gram of Methamphetamine at Aramax India Pvt. Ltd, Ekkaduthangal, Chennai, Tamilnadu.
- On 14.09.2020, Officers of NCB, Kolkata Zonal Unit seized 232.700 kg of Methamphetamine at Port Blair, Andaman & Nicobar Island.
- On 13.10.2020, Officers of NCB, Delhi Zonal Unit seized 795 gram of Methamphetamine at Kirti Nagar, New Delhi.

- On 14.10.2020, Officers of NCB, Guwahati Zonal Unit seized 2.146 kg of Methamphetamine at Guwahati, Assam. 03 persons were arrested.
- On 06.11.2020, Officers of NCB, Guwahati Zonal Unit seized 2.078 kg of Methamphetamine at Rajgarh road, Chandmari, Guwahati. 02 persons were arrested.
- On 07.12.2020, Officers of NCB, Imphal Sub-Zone seized a total of 167.37 kg of Methamphetamine & 28,500 tablets of Tramadol. 06 persons were arrested.
- On 21.12.2020, Officers of NCB, Delhi Zonal Unit seized 190 gram of Cocaine & 02.000 kg of Methamphetamine at New Delhi Railway Station, New Delhi. 02 persons were arrested.

CASE STUDY-BIGGEST METHAMPHETAMINE SEIZURES

Seizure of 167.37 kg of Methamphetamine by NCB Zonal Unit, Guwahati (Imphal)

As per the information developed by IO, NCB Imphal, on 07/12/2020, the officer of NCB, Imphal received an input about illegal production / processing of Methamphetamine at Moreh Ward no. 3, Tengnoupal, near public ground, Manipur. The NCB team in assistance with 43 Bn, Assam Rifles reached to the house of a person and cordoned off the area. On lawful search of the house, 81.3 Kg of Methamphetamine along with, stones of various sizes/color and one double bore gun along with live cartridge were recovered.

On the basis of preliminary enquiry from the persons present at that house, search of another house located at some distance was also conducted which resulted in the

recovery of 128.07 Kg of Methamphetamine, 28500 Tramadol Capsules, 13500 Pregbalin capsules, 140500 Bus Pirone HCL tablets along with stones of various sizes/color and one French Pistol along with live rounds.

Total 05 persons including 02 associates from second location were arrested.

Initially a total of 209.37 Kg Methamphetamine was seized, but due to negative report for 42 Kg of the contraband the final seizure was of 167.37 Kg of Methamphetamine

Seizure of 232.700 kg of Methamphetamine by NCB Zonal Unit, Kolakata

On 14.09.2020, NCB Kolkata Zonal Unit seized 227 packets of alleged Methamphetamine contained 232.7 Kg of the contraband which were handed over by Andaman Police. Investigation revealed that these packets were found from local villagers as they had collected it from from sea shore after presuming it to be some kind of tea as "China tea" was written over the packets. It is suspected that, traffickers might have dropped these packets in high sea and since the packets float on water, they might have found their way towards Andaman Coast where locals collected them.

Significant seizures of Ketamine by NCB:



- On 28.01.2020, Officers of NCB, Chennai Zonal Unit seized 9.900 kg of Ketamine at Indira Colony, Ashok Nagar, Chennai.

1.5 Precursor Chemicals

Trends:

- Ephedrine/ Pseudoephedrine trafficking is done mainly through Delhi, Chennai, Cochin and Airports.
- There are instances of use of courier/ parcels also.

Significant seizures of Ephedrine/ Pseudoephedrine:

- On 03.02.2020, Officers of NCB, Mumbai Zonal Unit seized 12 kg of Pseudoephedrine at DHL Courier Pvt. Ltd., Mumbai. In follow up action 37.5 kg of Pseudoephedrine was seized on 05.02.2020. 02 persons were arrested.
- On 11.03.2020, Officers of NCB, Kolkata Zonal Unit seized 5.974 kg of Pseudoephedrine at DHL Express India Pvt. Ltd., DN-53, Sector-V, Salt Lake City, Kolkata
- On 28.05.2020, Officers of NCB, Chennai Zonal Unit, seized 2.520 kg of Ephedrine at DHL Express India Pvt. Ltd., Guindy Industrial Estate, Chennai. 01 person was arrested.
- On 09.06.2020, Officers of NCB, Delhi Zonal Unit, seized 15 kg of Ephedrine at Hazrat Nizamuddin Railway Station, New Delhi. 01 person was arrested.
- On 14.08.2020, Officers of NCB, Delhi Zonal Unit seized 3.8 kg of Ephedrine at DHL Express Pvt. Ltd., Rama Road, Kirti Nagar, New Delhi.
- On 16.08.2020, Officers of DRI,

Hyderabad seized 76 kg of Ephedrine & 150.100 kg of Mephedrone at Sangareddy, Telangana. 01 person was arrested

- On 13.10.2020, Officers of DRI, Bangalore seized 12.996 kg of Pseudoephedrine at Yeshwanthapur, Bangalore.
- On 13.10.2020, Officers of NCB, Kolkata Zonal Unit seized 3.950 kg of Ephedrine at Salt Lake, Kolkata.
- On 11.11.2020, Officers of NCB, Bangalore Zonal Unit seized 6.870 kg of Pseudoephedrine from a courier parcel at Aramex, Bangalore.

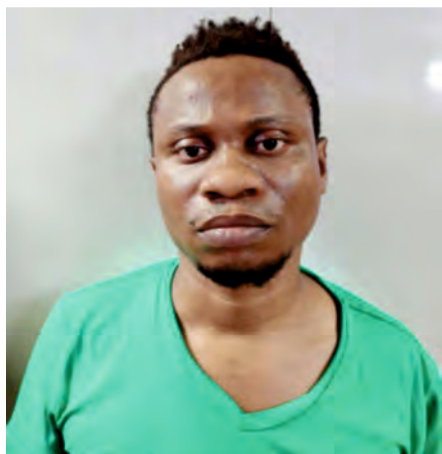
CASE STUDY-BIGGEST EPHEDRINE SEIZURE

Seizure of 15 Kg of Ephedrine by NCB Delhi Zone

On 09.06.2020, 15 Kg of white crystalline substance suspected to be ephedrine was recovered from the possession of a person at Hazrat Nizamuddin Railway Station, New Delhi. The suspect was to travel from New Delhi to Mumbai on the same day.

In the course of the investigation, sample was sent to CRCL, New Delhi for analysis and confirmation. As per the report of the CRCL, New Delhi, the sample tested negative for ephedrine but tested positive for Dimethyl sulphone, a salt.

Permission was sought from the Hon'ble Court for retesting of the same. As such, report received from the CRCL, Hyderabad stated that the same tested positive for Dimethyl sulphone and that the presence of ephedrine could not be detected.



Based on the findings of the CRCL, New Delhi and CRCL, Hyderabad, the Hon'ble Court is of the opinion that Dimethyl sulphone is not listed under the narcotic drugs, psychotropic substances, controlled substances (precursors) or psychoactive drugs. Based on these findings, the case against accused was dismissed and ordered for his deportation.

1.6 PHARMACEUTICAL DRUGS

India has one of the biggest pharmaceutical industrial bases & diversion of pharmaceutical substances is resulting in the increasing abuse of prescription drugs. The problem seems to be serious in the North-East and North-West region of the country. The pharmaceutical products that are abused include Buprenorphine, Codeine-based cough syrups, Alprazolam, Diazepam and other sedatives. The easy availability of such preparations is the major factor that encourages their misuse. There is also a perception that these pharmaceutical drugs are less harmful than hard drugs like Heroin, Cocaine, etc. However, this is a misconception, since these can be addictive and also have a debilitating effect on health. Pharmaceutical preparations having narcotic / psychotropic substances are under the purview of the Drugs and Cosmetic Act, and the NDPS Act in India.

Law enforcement agencies have also seized sizeable quantities of Alprazolam tablets, Zolpidem, Tramadol tablets, Sildenafil tablets, etc.

Significant seizures of Pharmaceutical Drugs (Tablets):

Zonal unit seized 50,000 tablets of Tramadol at DTDC, Kapasaheda, Delhi. In follow up action, 67,500 tablets of Tramadol, 65,500 tablets of Alprazolam, 3,60,000 tablets of Nitrazepam, 600 tablets of Diazepam, 11,300 tablets of Clonazepam, 1,69,940 capsules of Tramadol, 1400 Injection of Pentazocine & 80 bottles of Corex cough syrup were seized on 10.01.2020 at Agra (UP) and Ludhiana (Punjab).03 persons were arrested.

- On 17.01.2020, Officers of NCB, Mumbai Zonal Unit seized 5000 tablets of Tramadol and 9430 tablets of Zolpidem at Model Post Office, Marine Lines, Mumbai.
- On 24.01.2020, Officers of NCB, Mumbai Zonal Unit seized 9900 tablets of Zolpidem at Airport Sorting House, Mumbai Airport, Mumbai.
- On 31.01.2020, Officers of NCB, Delhi Zonal Unit seized 4200 tablets of Zolpidem & 6000 tablets of Alprazolam at TNT India Pvt. Ltd. (Fedex Courier), New Delhi. In follow up action 12000 tablets of Tramadol were seized and 01 person was arrested.
- On 12.02.2020, Officers of NCB, Delhi

Zonal Unit seized 5250 tablets of Alprazolam, 2000 tablets of Zolpidem, 100 tablets of Diazepam, 490 tablets of Nerodelm at Tripati Service Courier, Transport Centre, Punjabi Bagh, New Delhi.

- On 15.02.2020, Officers of NCB, Delhi Zonal Unit seized 91,288 tablets of Psychotropic Substances at TDI Kingsbary Kundli Sonipat, Haryana in follow up action of NCB Delhi Crime no. 13/2020.
- On 07.03.2020, Officers of NCB, Chandigarh Zonal Unit and Amritsar Sub-Zone seized 33,000 tablets of Tramadol Hydrochloride Tablets at Bathinda, Punjab. 02 persons were arrested.
- On 08.03.2020, Officers of NCB, Kolkata Zonal Unit seized 5,000 tablets of Methamphetamine at BSF BOP-Hili, South Dinajpur, West Bengal.
- On 13.03.2020, Officers of NCB, Mumbai Zonal Unit seized 61,725 tablets of Psychotropic Substances at DTDC Courier Andheri, Mumbai.
- On 16.03.2020, Officers of NCB, Mumbai Zonal Unit seized 2000 tablets of Diazepam, 510 tablets of Alprazolam, 70 tablets of Tramadol, 388 tablets of Lorazepam, 200 tablets of Zolpidem and 130 tablets of Diazepam at DHL, Andheri, Mumbai. 01 person was arrested.
- On 26.04.2020, Officers of NCB, Ahmedabad Zonal Unit, in coordination with FDA, Gujarat seized 61,368 tablets of Psychotropic drugs & 840 bottles of Codeine based cough syrup at Patan, Gujarat. 01 person was arrested.
- On 12.06.2020, Officers of NCB, Chandigarh Zonal Unit, seized 56,980 tablets of Tramadol at Panchkula, Patiala & Ferozpur. 03 persons were arrested.
- On 14.06.2020, Officers of NCB, Delhi Zonal Unit, seized 2,50,000 tablets of Tramadol at Maruti Express Logistics, Mahipalpur, New Delhi.
- On 18.06.2020, Officers of NCB, Delhi Zonal Unit, seized 50,000 tablets of Tramadol at DTDC Express Ltd., Kapashera, New Delhi.
- On 18.06.2020, Officers of NCB, Delhi Zonal Unit, seized 5,000 tablets of Tramadol at DTDC Express Ltd., Kapashera, New Delhi.
- On 22.06.2020, Officers of NCB, Delhi Zonal Unit, seized 80,000 tablets of Tramadol & 5000 tablets of Alprazolam at DTDC Express Ltd., Kapashera, New Delhi.
- On 02.07.2020, Officers of NCB, Amritsar Sub-Zone, seized 3000 tablets of Tramadol at Jalandhar, Punjab. 02 persons were arrested.
- On 08.07.2020, Officers of NCB, Mumbai Zonal Unit seized 19,78,312 tablets & 274.75 kg of Psychotropic substances in Mumbai.
- On 09.09.2020, Officers of NCB, Ajmer Sub-Zone in coordination with BSF seized 50,000 tablets of Tramadol & 55,200 tablets of Alprazolam at Sriganganagar, Rajasthan. 01 person was arrested.
- On 09.09.2020, Officers of NCB, Jodhpur Zonal Unit seized 6,02,300 tablets of Tramadol & 338 bottles of Codeine based cough syrup at Motor Merchant Market, Jodhpur, Rajasthan. 04 persons were arrested.
- On 07.11.2020, Officers of NCB, Delhi Zonal Unit seized 2,18,335 tablets of

Tramadol, 1,72,320 capsules of Tramadol, 22,150 injections of Diazepam & 4,810 bottles of Codeine based cough syrup at Mathura, UP. 03 persons were arrested.

- On 19.11.2020, Officers of NCB, Delhi Zonal Unit seized 51,17,400 tablets of Alprazolam, 2,27,400 tablets of Nitrazepam, 45,000 tablets of Tramadol, 45,600 tablets of Lorazepam, 1,49,000 capsules of Tramadol, 12,000 injections of Pentazocine & 72,539 bottles of Codeine based cough syrup at Ghaziabad, Uttar Pradesh.
- On 07.12.2020, Officers of NCB, Imphal Sub-Zone busted two clandestine laboratories at Moreh, Tengnoupal, Manipur and seized a total of 209.37 kg of Methamphetamine & 28,500 tablets of Tramadol. 06 persons were arrested.

CASE STUDY – BIGGEST PHARMACEUTICAL SEIZURE

Seizure of 54,35,400 tablets, 1,49,600 capsules and 12000 injections and 72,539 bottles of CBCS by NCB Delhi Zone

On 18.11.2020, various drugs including 54,35,400 tablets, 1,49,600 capsules and 12000 injections and 72,539 bottle of codeine based cough syrup were recovered at the site of a Trader at Ranjeet Singh Compound, Sihani Chungi, Meerut Road, Ghaziabad, UP. The details of the seizure includes Alprazolam= 51,17,400 Tablets, NITRAZEPAM= 2,27,400 Tablets, TRAMADOL Capsules= 1,49,600, TRAMADOL Tablets= 45000, PENTAZOCINE injection= 12000 vials, LORAZEPAM= 45600 TABLETS, Codeine Based Cough Syrup= 72539 bottles. The owner of the

drugs could not be traced at the spot. The spot was sealed off.

On 30.11.2020 the suspect filed a writ petition before Hon'ble Delhi High Court requesting the Hon'ble Court to quash the seizure proceedings but same was dismissed by Hon'ble High court of Delhi on 01.12.2020.

On 17.12.2020 the suspect surrendered before the court and the prosecution filed an application for his custody for investigation but he was remanded to judicial custody with a direction to the investigating agency to interrogate him in jail.

On 18.12.2020 the accused was examined and he wrote his statement and admitted his involvement in the present case in Dasna Jail. He also disclosed the names of two of his associates. He was formally arrested in Jail and filled an application in court for his departmental custody.

On 21.12.2020 the accused was remanded to 7 days departmental custody.

One of his associate tendered his voluntary statement on 24.12.2020 wherein he disclosed that he along with other associate were involved in the illegal trade of medicines. He also disclosed that they used name of the Traders which is registered in the name of main accused. He also disclosed that he along with other associate used to visit manufacturers for purchasing of medicines and also used to deal with sale of the medicines of different persons. Besides that he also disclosed about the knowledge regarding search and seizure proceedings at the premises of the Traders. He also disclosed that he allured main accused to indulge in the illegal business of medicines for monetary considerations. He also disclosed that the drug license was got issued by him with the conspiracy and active

supervision of other associate. He also disclosed that he was aware about requirement of the main accused in the investigation, while he was not joining investigation and he was also aware that main accused was regularly paying huge money through different persons to avoid joining of investigation.

The associate tendered his voluntary statement on 24.12.2020 U/s.67 of NDPS Act, wherein he disclosed that he was active member of conspiracy acted with other associate and main accused for the purpose of illegal business of medicines.

That a fourth person was also found involved in the present crime and therefore was arrested on 07.01.2021. The case is under trial.

1.7 INTERNET PHARMACY

The emergence of drug trafficking through internet pharmacy, especially through the illegal websites established in the USA, Europe etc. offering unregulated trade in a range of prescription medicines over the internet has taken firm root in India as a supplier. These online pharmacies transmit orders from paying customers to agents in India, who then procure the medicines from either legitimate or illegitimate sources before dispatching them to customers by mail and courier. The sheer volume of international post makes it impossible to screen every parcel and hence a vast majority of illegal consignments passes by undetected by the authorities. Internet pharmacies are usually highly vulnerable and keep the identity of organizers tightly veiled. In India, nevertheless, the NCB either on its own or in coordination with the outside

agencies has been making at least one bust every year over the years. In one such case, on 31.01.2020, Officers of NCB, Delhi Zonal Unit seized 4200 tablets of Zolpidem & 6000 tablets of Alprazolam at TNT India Pvt. Ltd. (Fedex Courier), New Delhi. In follow up action 12000 tablets of Tramadol were seized and 01 person was arrested.

1.8 CONTROLLED DELIVERY

Clause (viib) of section 2 of the NDPS Act defines the expression 'controlled delivery' as follows:

'[(viib) 'controlled delivery' means the technique of allowing illicit or suspect consignments of narcotic drugs, psychotropic substances, controlled substances or substances substituted for them to pass out of, or through or into the territory of India with the knowledge and under the supervision of an officer empowered in this behalf or duly authorized under section 50A with a view to identifying the persons involved in the commission of an offence under this Act]'

The Director General of Narcotics Control Bureau constituted under sub-section (3) of section 4 or any other officer authorized by him in this behalf, may, notwithstanding anything contained in this Act, undertake controlled delivery of any consignment to :

- (a) any destination in India
- (b) a foreign country, in consultation with the competent authority of such foreign country to which such consignment is destined, in such manner as may be prescribed.

2.1 TRAINING

Along with enforcement and co-ordination, NCB has also been given the mandate of training and capacity building in the sphere of drug law enforcement. It has been the constant endeavor of NCB to both upgrade its own manpower pool and also that of sister agencies involved in drug law enforcement. NCB has consistently been imparting training to DLEOs of both Centre and States in an effort to boost the drug interception capabilities of the overarching drug law enforcement architecture of India.

NCB has been delivering training sessions and also organizing Workshops to agencies at State level like State Police, Excise etc and to federal agencies like GST & Central Excise, RPF etc. Border Guarding Forces play a pivot role in preventing entry of narcotics into India and thus training programs are regularly organized for them from time-to-time. Agencies like BSF, Indian Coast Guard etc. are given Computer-based-Training (CBT) at various Zonal Units of NCB under the aegis of the United Nations Office on Drugs and Crime (UNODC) so that they can anticipate the means of trafficking, effectively identify drug contraband and take suitable action towards their seizure and apprehension/arrest of traffickers and carriers.

Further, NCB has also made tangible efforts at partnering with leading national training institutes of excellence such as CAPT, Bhopal, NACIN Academy, Faridabad, LNIN Institute of Forensic Science and Criminology, New Delhi and National Forensic Science University, Gandhinagar along with various CDTIs spread

across the country in an effort to ensure the availability of competent resource persons and subject experts on drug law enforcement to take training sessions and Workshops for itself and sister agencies. NCB has also an active MoU with CAPT, Bhopal and NFSU, Gandhinagar towards capacity building. Also, NCB in conjunction with CAPT, Bhopal has established a Training Centre on Drug Law Enforcement in anticipation of its future capacity building requirements. NCB has also conducted in the recent past, multiple international/bilateral training-cum-orientation sessions for drug law enforcement personnel from foreign nations such as Afghanistan and Bangladesh as per expressions of interest made in Director General-level talks that NCB had with these nations in the past.

In the year 2020, the mode through which training is imparted a sea change as training through virtual platforms became a norm due to the restrictions imposed arising out of the COVID-19 pandemic. This shift made the concerned organizations realised that online training modules can be effectively used to impart training to Officials in a hassle free way.

Apart from the above, The Computer Based Training (CBT) module developed by UNODC is also being used by NCB to provide training to the personnel of Law Enforcement Agencies.

During this period, NCB conducted 223 Training Programmes all over India. A total of 6,214 persons participated in the training programmes.

MoU with National Forensics Science University (NFSU), Gandhinagar, Gujarat

Narcotics Control Bureau and National Forensics Science University have signed an MoU on 25.08.2020 to broadly address the following four areas:-

- Assistance and consultancy during investigation and prosecution of NDPS cases.
- Research in the area of drugs, digital and allied forensics.
- Capability and capacity building in the area of drugs, digital allied forensics.
- To increase awareness among youth against drug abuse and offer counseling.

2.2 ASSISTANCE TO STATES

With a view to eradicate the drug menace, the Government of India has introduced a Scheme, (Assistance to States) to finance State Governments to strengthen their

enforcement capabilities for combating illicit trafficking in Narcotics Drugs and Psychotropic Substances. Under this Scheme, financial assistance is given for augmenting the drug law enforcement capabilities of the States. Financial Assistance is provided for purchase of equipments on following aspects:

- a) Surveillance equipment;
- b) Laboratory equipment,
- c) Vehicles for patrolling/surveillance;
- d) Computers and their accessories;
- e) Fax machine and photocopies;
- f) Training equipment and other aids; and
- g) Other equipments useful for enforcement.

The Scheme was launched by the Ministry of Home Affairs on 24th October, 2004 for 05 years which was extended from time to time under existing guidelines. The details of the time line of the scheme is as under

Implementation of EAT (Expenditure Advance and Transfer) Module of PFMS

MHA had communicated to NCB that the Department of Expenditure, Ministry of Finance had emphasized that the release of funds to State Governments and monitoring further utilization should be undertaken through EAT (Expenditure Advance Transfer) module of PFMS. The monitoring can be implemented only if the Implementing Agencies are registered and mapped on PFMS and use EAT module of PFMS.

Accordingly, NCB requested all States receiving financial assistance under the scheme "Assistance to States/UTs for Narcotics Control" to register their respective agencies on PFMS, who are utilizing the fund provided under the ibid scheme. It was requested that the registration details be sent to NCB for further mapping.

The States are in the process of registering their agencies on PFMS the details received by NCB till now have been mapped on the EAT Module of PFMS of the scheme is as under

2.3 DRUG DETECTION KITS

NCB procures and provides Drug Detection Kits to the Drug Law Enforcement Agencies across the country. These DD Kits provides

simple, correct and user friendly method for 'on the spot' testing of suspected materials even by non-technical officials. These Drug Detection Kits are of three types

- A) Narcotic Drugs Detection Kit,
- B) Precursor Chemicals Detection Kit and
- C) Ketamine Detection Kit.

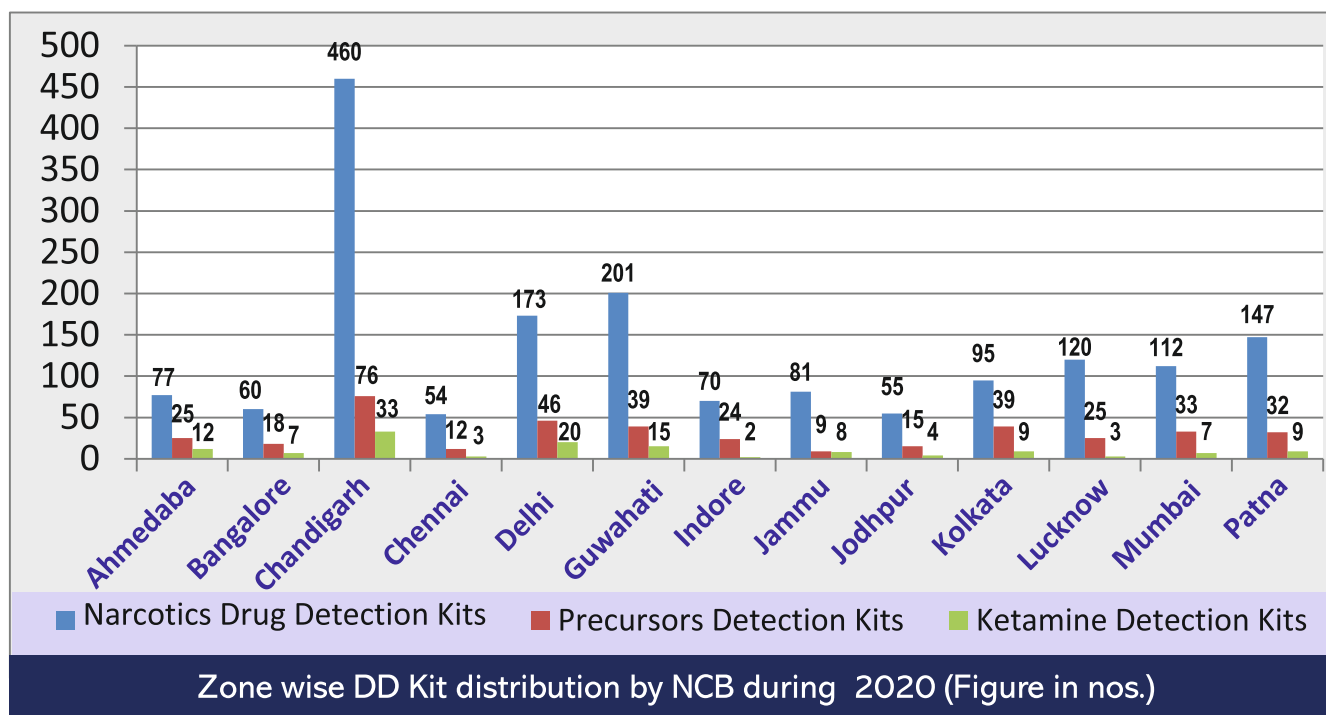
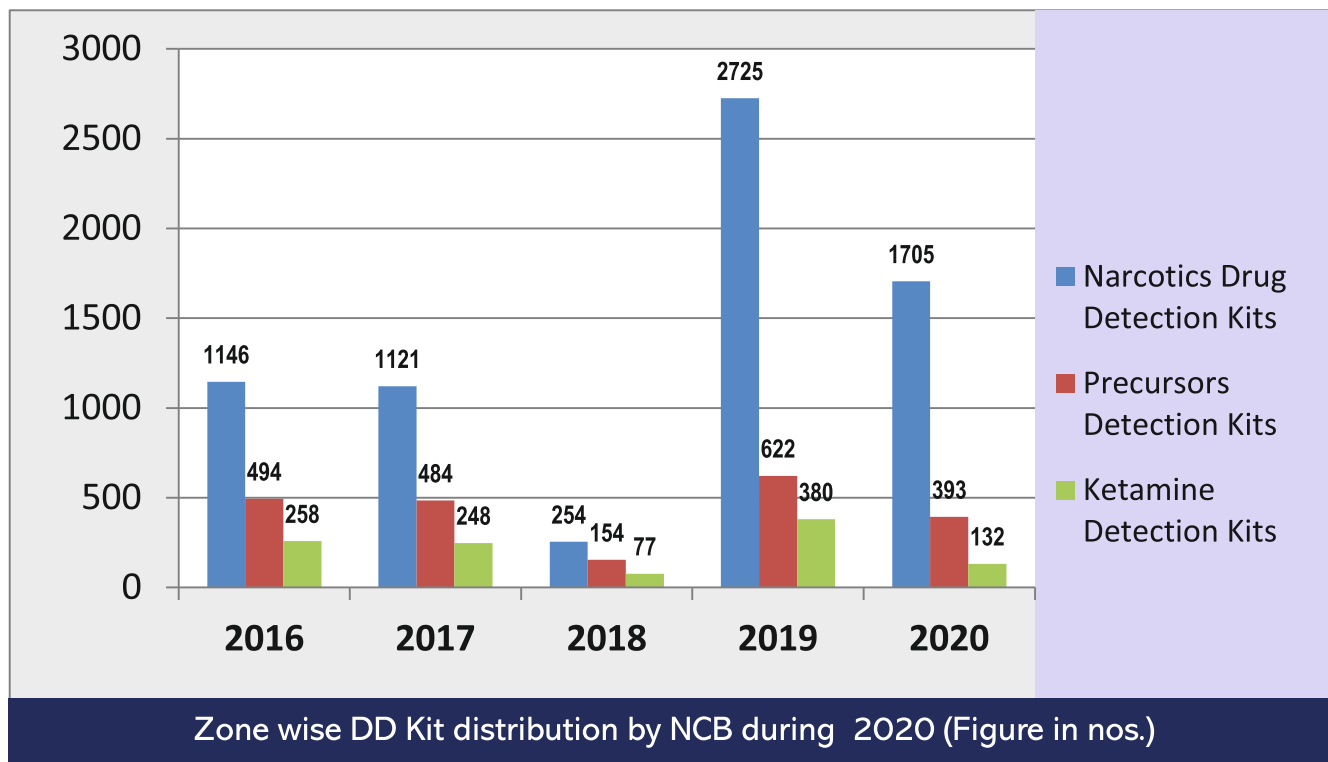
The DD Kits are procured centrally by NCB Hqrs. since 1989 from Hindustan Antibiotics Ltd., Pune and distributed to the Zonal Units of NCB. The DD Kits received by the Zonal Units are further distributed to all the drug law enforcement agencies falling under their jurisdiction.

Narcotics Control Bureau procures Drug Detection Kits for all Drug Law enforcement agencies of the country. The same was distributed by NCB Zones to State Police and other Drug Law Enforcement Agencies as follows:

- a) Standard size Narcotics Drug Detection Kits – 1705

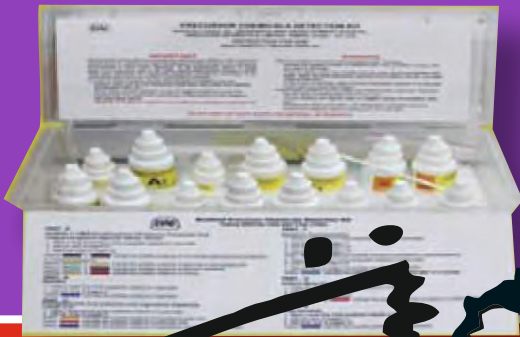

2.4 DRUG DEMAND REDUCTION

Demand Reduction refers to the steps taken by any agency to reduce demand for consumption of narcotic drugs or psychotropic substances. The demand reduction strategy is in addition to the supply reduction strategy which focuses on drug interdiction.

The Government of India has mandated the Ministry of Social Justice and Empowerment (MSJ&E) to run different demand reduction programmes.

The measures adopted for demand reduction include:

- Awareness building and educating people about harmful consequences of narcotic drugs
- Community-based intervention for identification, treatment, motivation, counselling and rehabilitation of drug addicts
- Training of volunteers/service providers and other stake holders.

Nasha Mukh Bharat Abhiyan (NMBA)

'Nasha Mukh Bharat Abhiyan' is a coordinated effort of the Ministry of Social Justice and Empowerment, Narcotics Control Bureau under Ministry of Home Affairs and Department of Health under the Ministry of Health and Family Welfare.

In January, 2020, NCB had provided a list of 272 districts which are vulnerable from Drug supply point of view to MoSJ&E. Subsequently, based on the list of districts provided by NCB and on the findings of the National Survey on Extent and Pattern of Substance Use in India, the Ministry of Social Justice and Empowerment has undertaken intervention programmes in these vulnerable

districts across the country. The intervention programmes have been initiated with an aim to: Reach out to Children and Youth for awareness about ill effect of drug use; Increase community participation and public cooperation; Supporting Government Hospitals for opening up De-addiction Centers in addition to existing Ministry Supported De-addiction Centers (IRCA's); and Conducting Training programme for participants.

Alternative development

Alternative development is a way of weaning away farmers who have traditionally been cultivating opium poppy/cannabis illegally, and their livelihood depends on such cultivation. In such circumstances, mere enforcement and crop destruction will not suffice. Thus, farmers are trained in and helped to develop alternative means of livelihood. The areas under such illicit cultivation are identified through consultations between the Department of Revenue, NCB and the concerned State Governments after a careful study.

Recently, the Department of Revenue has constituted a Task Force in consultation with the state government to identify such areas where Alternative Development programmes can be implemented in future.

Demand Reduction Programmes by NCB

Apart from its regular work in the field of drug interdiction, NCB does some work in spreading awareness among the masses by way of various programmes. These programmes include:

- Street Plays/ Cultural Programmes
- Run against drug abuse
- Display of Awareness Board in Pub, Bar and Airport, etc.

- Painting and slogan writing competition
- Pledge taking ceremonies
- Display of banners and posters at prominent public places
- Publication of Advertorial in leading newspaper
- Transmission of Anti-Drug Message through Radio channel
- SMS alert about drug awareness
- Observance of 26 June as 'International Day Against Drug Abuse & Illicit Trafficking' to create awareness

During 2020, NCB carried out 112

awareness and educational programmes as part of drug demand reduction activities across the country, covering approximately 10,395 participants.

In 2020, however, due to the COVID-19 pandemic, NCB had initiated various online activities to observe 26th June. Which are as under:-

3.1 International Meetings /Conferences

3.1.3 JUDICIAL COOPERATION

a) Controlled Delivery Operations :

NCB conducts Controlled delivery operations in coordination with other countries. The Director General, Narcotics Control Bureau is empowered under Section 50A of the NDPS Act, 1985 to authorize "controlled delivery" of any contraband drugs to India or abroad.

b) Mutual Legal Assistance :

Mutual Legal Assistance Treaty (MLAT) is an agreement between two countries for gathering and transfer of evidence. Mutual Legal Assistance Treaty usually provides the framework to facilitate the widest measure of mutual assistance in:

- taking evidence or statements from persons;
- effecting service of judicial documents;
- executing searches and seizures;
- examining objects and sites;
- providing information and evidentiary items;

- providing originals or certified copies of the relevant documents and records including bank, financial, corporate, and business records;
- identifying or tracing proceeds, property, instrumentalities
- or other things for evidentiary purposes;
- The specific form of Mutual Legal Assistance that can be given or obtained depends on the provisions of the treaty with the foreign government.
- India has signed Mutual Legal Assistance Treaties with 40 countries namely Australia, Bahrain, Belarus, Bosnia & Herzegovina, Bulgaria, Canada, Egypt, France, Italy, Kazakhstan, Kuwait, Maldives, Mauritius, Mexico, Myanmar, Mongolia, Russia, Singapore, Spain, South Africa, South Korea, Switzerland, Tajikistan, Thailand, Turkey, Ukraine, Uzbekistan, UAE, UK and USA.

c) Extradition

- Extradition is the process of surrendering a fugitive residing in a country, who is wanted by the law enforcement of another country, after due process.
- India has extradition treaties with 37 countries.
- Such treaties with several other countries have been negotiated.
- India has extradition arrangements on the basis of reciprocity with 08 countries.
- The Indian Extradition Act contains a provision in terms of which extradition can be considered even in the absence of an extradition treaty if the offence for which extradition has been sought is included in any international convention to which both India and the other country seeking extradition are parties.

3.1.4 INCB/UNODC Reporting

Being a signatory to the various international conventions on narcotic drugs and psychotropic substances, India is under obligation to submit the required information to the United Nations office of Drugs Crime (UNODC) and International Narcotics Control Board (INCB) in the prescribed formats. NCB is the nodal/central agency for implementation of the India's obligations under various international conventions.

International Narcotics Control Board (INCB)

To meet the international obligations under the UN Conventions on Narcotic Drugs, 1961, Convention on Psychotropic Substances, 1971 and United Nations Convention against Illicit traffic in Narcotic Drugs and Psychotropic Substances, 1988, NCB submits seven reports in the prescribed formats namely Form A, B, C, D, P, A/P and B/P to INCB Vienna. Form A & A/P relates to Import & Export of Narcotic Drugs and Psychotropic Substances, respectively, and the same are being submitted to INCB on quarterly basis. The other Forms i.e B, C, D & P is being submitted to INCB on an annual basis and relates to annual assessment /estimates of narcotics drugs and psychotropic substances in different fields. While Form B/P is being submitted once in 3 years which relates to annual assessment of medical and scientific requirement of scheduled substances. Inputs on the different Forms come from Central Bureau of Narcotics (CBN), the Chief Controller of Factories (CCF) and the Drug Controller General of India (DCGI).

United Nations Office on Drugs and Crime (UNODC)

Every member country has to provide inputs in the Annual Report Questionnaire (ARQ) every year on the working of the

international drug control treaties to UNODC.

The ARQ has four parts detailed below:

Part-I Legislative and Institutional framework

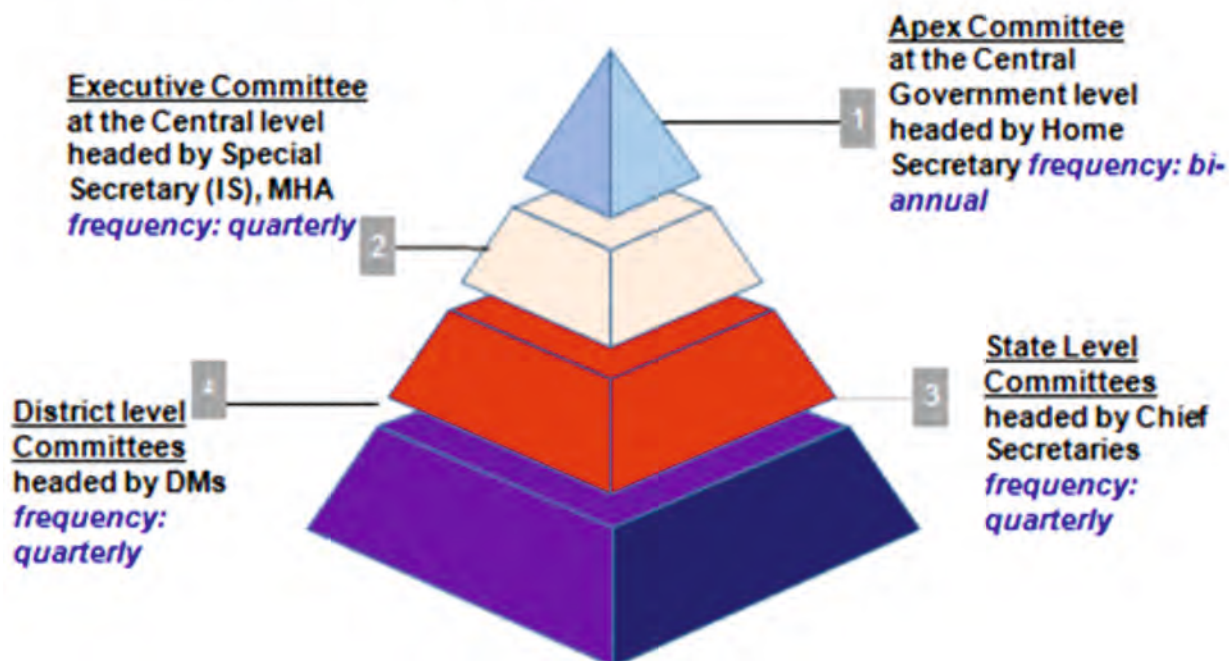
Part-II Comprehensive approach to drug demand & supply reduction

Part-III Drug Abuse situation, extent, pattern and trends of drug abuse
 Part-IV Illicit supply of drugs - Extent, pattern and trends in illicit drug cultivation, manufacture and Trafficking.

NCB furnishes the ARQ to UNODC. This becomes a part of the World Drug Report published every year.

The Act constitutes the statutory framework for drug law enforcement in India, **It prohibits "the manufacture, production, trade, use, etc. of Narcotic Drugs and Psychotropic substances", except for medical and scientific purposes.**



The Act also lists down stringent provisions on manufacturing, sale, purchase, possession, consumption, abuse and trafficking of drugs and prescribes stringent **punishment for violators**

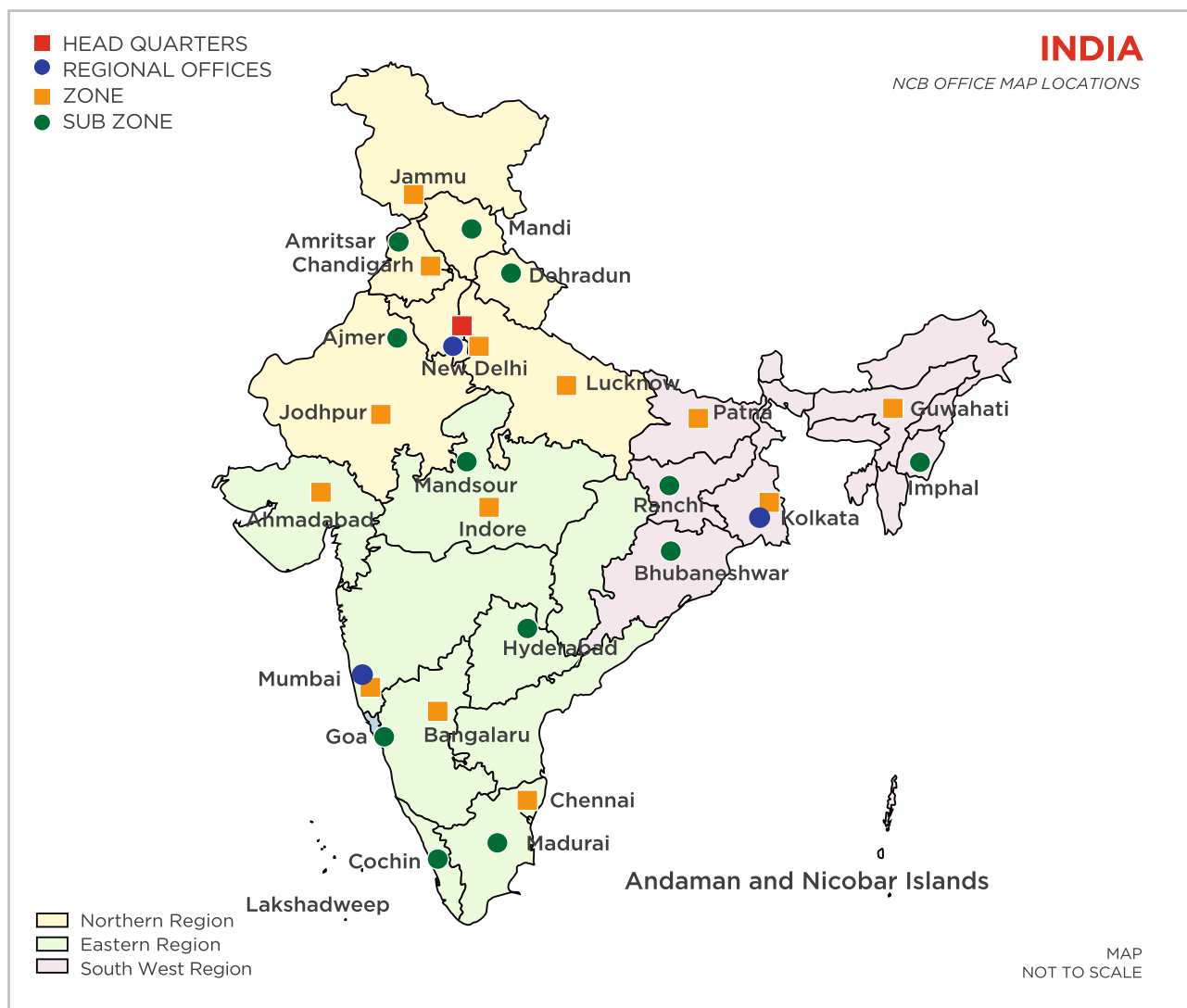
4.1 NCB CHARTER

In exercise of powers under Section 4 of NDPS Act, 1985, the 'NARCOTICS CONTROL BUREAU' was constituted with Headquarters at Delhi with effect from 17th Mar, 1986. The Bureau, subject to the supervision and control of the Central Government, is to exercise powers and functions of the Central Government for taking measures with respect to:

- Co-ordination of actions by various

offices, State Governments and other authorities under the N.D.P.S. Act, Customs Act, Drugs and Cosmetics Act and any other law for the time being in force in connection with the enforcement provisions of the NDPS Act, 1985.

- Implementation of the obligation in respect of counter measures against illicit traffic under the various international conventions and protocols that are in force at present or which may be ratified or acceded to by India in future.



- Assistance to concerned authorities in foreign countries and concerned international organizations to facilitate coordination and universal action for prevention and suppression of illicit traffic in these drugs and substances.
- Coordination of actions taken by other concerned Ministries, Departments and Organizations in respect of matters relating to drug abuse.

On the recommendation of the Group of Ministers (GoM) on national security, NCB was transferred from Department of Revenue (DoR) to Ministry of Home Affairs (MHA) on 18.02.2003.

4.2 NCB ORGANISATION

The NCB was established in 1986, with a sanctioned strength of 164 and Zonal Units at Delhi, Kolkata, Chennai, Mumbai and Varanasi. Later new zones were sanctioned at Jodhpur, Chandigarh, Jammu, Ahmadabad, Indore, Guwahati, Patna and Bangalore whereas the Varanasi zone was shifted to Lucknow. Besides the office of three Deputy Director Generals (Regional) were created, one each in Delhi, Kolkata and Mumbai. Sub zones at Dehradun, Amritsar, Mandi, Ajmer, Ranchi, Bhubaneswar, Imphal, Goa, Mandasaur, Cochin, Madurai and Hyderabad has been created during last decade.

- The Mega Proposal i.e., expansion of NCB in three phases had been sent to MHA with creation of Chemical Analyst Wing, Prosecution Wing, cyber Wing, Drug Intelligence Wing, Computer/IT Cadre and Canine Squad.
- Details of the posts filled by deputation in 2020 are as under:-
- Deputy Director General – 2, Deputy Director/Zonal Director – 2, Assistant Director – 1, Intelligence Officer – 12, Junior Intelligence Officer – 8, Surveillance Assistant – 2, Driver – 1 and Sepoy – 3.
- Eighteen (18) Assistant and One (1) Lower Division Clerk were recruited in 2020 under direct recruitment quota.
- MHA vide letter dated 10.10.2018 conveyed the approval of UPSC for one time permission to fill up all the 195 sanctioned posts of Junior Intelligence Officer (JIO) as :
 - (i) 85% (166 posts) by deputation basis.
 - (ii) 15% (29 posts) by Limited Departmental Competitive Examination (LDCE).

To fill the posts of Junior Intelligence Officer in NCB Limited Departmental Competitive Exam was conducted on 03.12.2020 to fill up 29 posts of JIO.

NCB

4.2.1 NCB MANUAL

In the modern era of echnological advancement, emergence of new drugs and modus operandi used by drug traffickers, emerging scenario of drug menace has become more complex and in turn, posing serious threat to the society and creating new challenges for the Drug Law Enforcement Agencies of the country. For NCB being premiere and nodal drug law enforcement agency it was felt mandatory to have standard manual of its own so as to bring in place the standard operating procedures/guidelines related to its functioning in administrative, operational and legal matters.



Accordingly, after extensive exercise, NCB manuals two volumes i.e., Administrative Manual & Operational Manual were published. Set of the NCB Manual was released by the Hon'ble Home Minister of India, Sh. Amit Shah during BIMSTEK Conference at Vigyan Bhawan, New Delhi on 13.02.2020.

4.3 INFRASTRUCTURE/PROJECTS

- Construction work of Office cum Residential Complex (OCR) at Chandigarh Zone and Ahmadabad Zone has been completed.
- Construction work of Office Complexe (OC) at Indore Zone is under progress & constructed about 95%.
- Construction work of Office Complexe (OC) at Bhubaneswar Sub-Zone is under progress & constructed about 70%.
- Construction of Office cum Residential Complex (OCR) at Guwahati Zone is yet to be started.
- Construction work of Office cum Residential Complex (OCR) at Bangalore Zone could not be started due to land dispute.

4-4 राजभाषा हिंदी

उल्लेखनीय प्रयास

संघ की राजभाषा नीति के संबंध में राजभाषा विभाग, गृह मंत्रालय द्वारा समय-समय पर जारी निर्देशों का ब्यूरो मुख्यालय एवं इसके अधीनस्थ कार्यालयों में अनुपालन कार्य किया जा रहा है। स्वापक नियंत्रण ब्यूरो मुख्यालय, उप महानिदेशक के कार्यालयों, क्षेत्रीय व उप क्षेत्रीय कार्यालयों के सभी अधिकारियों व कर्मचारियों द्वारा इस संगठन में राजभाषा के प्रयोग को बढ़ाने के निम्नांकित सार्थक प्रयास किए गए:—

राजभाषा कार्यान्वयन समिति की तिमाही बैठकें

स्वापक नियंत्रण ब्यूरो, मुख्यालय में विभागाध्यक्ष की अध्यक्षता में गठित विभागीय राजभाषा कार्यान्वयन समिति की बैठक (OLIC) का आयोजन किया गया। बैठक में हिंदी में कार्य करने और हिंदी के प्रयोग को बढ़ाने के लिए चर्चा की गई तथा इस संबंध में कार्य नीतियां बनाकर उनका कार्यान्वयन सुनिश्चित किया गया।

ब्यूरो के सभी अधीनस्थ कार्यालयों में भी विभागीय राजभाषा कार्यान्वयन समितियां गठित हैं। इन कार्यालयों में भी राजभाषा कार्यान्वयन समिति की बैठकों के नियमित आयोजन संबंधी निर्देश दिए गए।

तिमाही, अर्धवार्षिक तथा वार्षिक प्रगति रिपोर्ट का संकलन

ब्यूरो मुख्यालय की प्रत्येक तिमाही प्रगति रिपोर्ट का संकलन करने के लिए मुख्यालय के सभी अनुभागों से आंकड़े मंगवाए गए और ब्यूरो मुख्यालय की समेकित रिपोर्ट गृह मंत्रालय तथा राजभाषा विभाग को भी भिजवाई गई एवं राजभाषा की वेबसाइट पर भी अपलोड की गई। गृह मंत्रालय तथा राजभाषा विभाग से प्राप्त रिपोर्ट की समीक्षा पर अनुवर्ती कार्रवाई करके उन्हें रिपोर्ट भजवाई गई।

ब्यूरो मुख्यालय की वार्षिक मूल्यांकन रिपोर्ट तथा अर्धवार्षिक रिपोर्ट भी समेकित कर तैयार करके भेजी गई।

ब्यूरो मुख्यालय के सभी उप महानिदेशक के कार्यालयों, क्षेत्रीय एवं उप क्षेत्रीय कार्यालयों से राजभाषा प्रयोग संबंधी तिमाही प्रगति रिपोर्टें नियमित रूप से मँगवाई गई। उप महानिदेशक (उत्तरी क्षेत्र), उप महानिदेशक (दक्षिण पश्चिमी क्षेत्र) व उप महानिदेशक (पूर्वी क्षेत्र) के कार्यालयों तथा क्षेत्रीय कार्यालयों की वर्ष 2020 में सभी तिमाहियों की राजभाषायी रिपोर्टों की मदवार विस्तारपूर्वक समीक्षा की गई तथा पाई गई कमियों को दूर करने हेतु सुझाव दिए गए।

रिपोर्टों को समय पर राजभाषा विभाग के संबंधित क्षेत्रीय कार्यान्वयन कार्यालयों को भिजवाने के भी निदेश दिए गए। अधिकतर कार्यालय अपनी रिपोर्ट संबंधित क्षेत्रीय कार्यान्वयन कार्यालयों को भिजवा रहे हैं।

हिन्दी प्रशिक्षण

हिंदी शिक्षण योजना के अंतर्गत हिंदी टंकण प्रशिक्षण के लिए ब्यूरो मुख्यालय से 05 कार्मिकों नामतः सुश्री कंचन रानी (अवर श्रेणी लिपिक), श्री मनीष (अवर श्रेणी लिपिक), श्री प्रगट सिंह (डी.ई.ओ.), श्री आनंद कुमार झा (ऑपरेटर टेली कम्यूनिकेशन), श्री संतोष कुमार सिंह (ऑपरेटर टेली कम्यूनिकेशन) को नामित किया गया।

राजभाषायी निरीक्षण

गृह मंत्रालय, राजभाषा विभाग के क्षेत्रीय कार्यान्वयन कार्यालय, दिल्ली ने स्वापक नियंत्रण ब्यूरो, मुख्यालय का दिनांक 21.08.2020 को राजभाषा नीति कार्यान्वयन संबंधी ई-निरीक्षण किया। ई-निरीक्षण के दौरान एक ओर उन्होंने कार्यालय में हिंदी में हो रहे कार्य की सराहना की तो दूसरी ओर कार्य को अधिकाधिक हिंदी भाषा में किये जाने के लिए प्रेरित भी किया। इस निरीक्षण संबंधी समस्त तैयारियों एवं इसके सफलतापूर्वक संपन्न होने के बाद निरीक्षण रिपोर्ट प्राप्त होने पर अनुवर्ती कार्रवाई करके रिपोर्ट भेजी गई।

दिनांक 11 दिसंबर, 2020 को गृह मंत्रालय के निरीक्षक दल द्वारा ब्यूरो मुख्यालय का राजभाषायी निरीक्षण किया गया। इस निरीक्षण के दौरान श्रीमती कविता रावत, सहायक निदेशक के मार्गदर्शन में निरीक्षण को सफल बनाने के लिए हिंदी अनुभाग के अनुवाद अधिकारियों ने अथक प्रयास किया। निरीक्षण दल ने इसकी सराहना की। निरीक्षण के दौरान ब्यूरो मुख्यालय में उपलब्ध फाइलों/ रजिस्ट्रों/ प्रशिक्षण सामग्री मानक मसौदों तथा अन्य दस्तावेजों की जांच की गई तथा निरीक्षण उपरांत प्राप्त रिपोर्ट पर अनुपालनार्थ कार्रवाई की गई।

मूल रूप से हिन्दी में टिप्पण आलेखन हेतु नकद पुरस्कार योजना

राजभाषा विभाग, गृह मंत्रालय की ब्यूरो मुख्यालय तथा इसके सभी अधीनस्थ कार्यालयों में लागू उक्त प्रोत्साहन योजना वर्ष 2020 के लिए ब्यूरो, मुख्यालय के पाँच (05) कार्मिकों को पुरस्कार हेतु नामित किया गया। इनमें से, सुश्री दीपिका, उच्च श्रेणी लिपिक को प्रथम पुरस्कार अर्थात् 5000 (पाँच हजार रुपये) तथा श्री देवेन्द्र नाथ शर्मा, सिपाही, सुश्री प्रियंका, उच्च श्रेणी लिपिक एवं श्री प्रेम रंजन, सिपाही को द्वितीय पुरस्कार अर्थात् 3000×3=9000/- तथा श्री ऋषिपाल, सहायक को तृतीय पुरस्कार अर्थात् 2000/- (दो हजार रुपये) की राशि प्रदान की गई।

पुस्तकालय में हिन्दी पुस्तकों की खरीद

ब्यूरो मुख्यालय के पुस्तकालय में हिन्दी पुस्तकों की खरीद के लिए निर्धारित 50% का लक्ष्य प्राप्त करते हुए वर्ष 2020 में निर्धारित लक्ष्य के तहत 37 पुस्तकों की खरीद की गई जिनमें शब्दकोश, कहानियाँ, उपन्यास, सामाजिक, एतिहासिक, ज्ञानवर्धक आदि विषयों से संबंधित पुस्तकें शामिल हैं।

हिन्दी दिवस तथा हिन्दी पखवाड़ा

कोविड-19 महामारी के कारण, ब्यूरो मुख्यालय व सभी अधीनस्थ कार्यालयों में 14 सितंबर से 28 सितंबर, 2020 के दौरान हिन्दी पखवाड़ा लघु स्तर पर मनाया गया इसमें माननीय गृह मंत्री एवं गृह सचिव के हिन्दी संदेश ऑनलाइन प्रेषित किए गए तथा साथ ही, महानिदेशक महोदय द्वारा एक अपील जारी की गई जिसमें ब्यूरो मुख्यालय व सभी अधीनस्थ कार्यालयों में अधिकारियों व कर्मचारियों को इस दौरान अधिक से अधिक कार्य हिन्दी में करने के लिए निदेश दिया गया।

वर्ष 2020 के दौरान ब्यूरो मुख्यालय में उक्त हिन्दी पखवाड़ा के दौरान कोरोना संबंधी एस ओ पी का पालन करते हुए हिन्दी निबंध प्रतियोगिता एवं हिन्दी टिप्पण-आलेखन प्रतियोगिता का आयोजन किया गया। इन प्रतियोगिताओं में कुल 23 प्रतिभागियों ने भाग लिया तथा कुल 10 विजेताओं को पुरस्कार राशि सहित प्रमाण-पत्र प्रदान किए गए।
