



DRUG TRAFFICKING SCENARIO IN INDIA

India is sandwiched between world's largest Heroin and synthetic drugs producing areas: the South West Asian countries of Iran, Afghanistan and Pakistan and the South East Asian countries, which makes it a transit point as well as consumption region. Illicit Heroin and synthetic drugs such as Methamphetamine, ATS etc produced in these regions are smuggled into and transit through India. India is also affected by illicit cultivation & trafficking of Cannabis and Opium Poppy. In addition, India has a large chemical industrial base with growing pharmaceutical industry. This has resulted in

substantial rise in the recreational abuse of prescription drugs especially Codeine based cough syrups, sedatives etc.

Along with the Western and Eastern borders on either side, international border with Nepal, Bangladesh and long maritime boundary make the situation even more complex. The drug situation in India is, therefore, a complex combination of several factors. The drug trafficking across international borders and the inter-state trafficking of drugs make India a victim of drug trafficking in multiple ways.



The salient features of drug trafficking scenario in India may be summarized as under:-

- 1 Trafficking of Opiates from South West Asia and South East Asia to India.
- 2 Illicit cultivation of Opium & wild growth of Cannabis in some pockets.
- 3 Increase in instances of trafficking through dark net involving crypto currencies.
- 4 Seizure of drugs from check-in baggage, body concealment and air cargo at airports.
- 5 Involvement of foreign nationals in trafficking and distribution networks of Heroin and Cocaine.
- 6 Diversion of pharmaceutical drugs and influx of ATS from Myanmar in North Eastern States of India.
- 7 Increase in trafficking through courier parcels in India

- 8 Trafficking of drugs by drones at Indo Pak border
- 9 Maritime trafficking of Heroin, ATS and other drugs from Iran / Pakistan to India and further to Sri Lanka and other countries.

1.1 TRENDS AND PATTERNS 2023

In India the drug related issues are dealt through the coordinated efforts of the several Drug Law Enforcement Agencies of Central and State Governments. NCB has been designated as Nodal Agency for drug law enforcement in the country and also assigned the task of data management pertaining to drug issues. The following table depicts the seizures of major narcotic drugs and controlled substances from 2018-2023 by the drug law enforcement agencies in the country:-

I. Trafficking of Opiates from South West Asia and South East Asia to India.

Trafficking of Heroin in India is mostly through its Eastern and Western borders. Trafficking of Heroin remains a constant challenge for DLEAs in India. In recent times, trafficking of huge quantities of Heroin through maritime routes has emerged as a significant challenge.

II. Increase in instances of trafficking through Dark net involving crypto currencies.

Darknet refers to a part of the internet that is intentionally hidden and accessible only through use of specific software, configurations, or authorization, often using non-standard communication protocols and ports. The use of Darknet markets for drug trafficking involves the buying and selling of illicit substances through online platforms that operate on the Darknet. Here are some ways in which Darknet is associated with drug trafficking:-

◆ Anonymity and Privacy: Darknet users often rely on encryption and anonymity tools such as Tor (The Onion Router) to mask their identities and locations. This provides a level of privacy for both buyers and sellers involved in illegal transactions, including drug trafficking.

- Cryptocurrency Transactions: Darknet markets typically use cryptocurrencies like Bitcoin, Monero etc. for transactions. Cryptocurrencies can offer a higher level of anonymity compared to traditional payment methods, making it challenging for law enforcement to trace financial transactions related to drug sales.
- ♦ Global Reach: Darknet markets allow for global transactions, enabling buyers and sellers from different parts of the world to connect and conduct illegal drug transactions. This global reach makes it difficult for law enforcement agencies to effectively monitor and regulate such activities.
- ◆ Marketplace Structure: Darknet marketplaces often function similarly to legitimate e-commerce platforms, with sellers offering a variety of drugs, product descriptions, and user reviews. This structure makes it easier for buyers to find and purchase illicit substances.
- ◆ Escrow Services: Some Darknet markets use escrow services, where a third party temporarily holds the payment until the buyer receives the product. This is intended to provide a level of trust in transactions but can also facilitate illicit activities.

III. Drugs Trafficking through courier/parcels /Post

NCB noticed an increase in the trafficking of drugs through couriers and parcels post-COVID 19 lockdown and suspension of international air traffic. In 2019, while just 67 such cases were reported to NCB, the number of such cases inflated to 260 in 2020. However,

- there is a marginalised fall in the number of cases booked through couriers since 2021.
- Parcel/courier seizures linked with Darknet, crypto currency & B2B platforms.
- ◆ Primarily metropolitan cities targeted.
- Anonymity and involvement of multiple countries.

IV. Trafficking of drugs through air cargo and air passengers

Cocaine and Heroin are the most trafficked drugs through air cargo and the air passengers. Emerging trend noticed since end of 2020. These drugs are mostly trafficked by human carriers in check-in baggage / body concealment. Origin of such

carriers is noticed mostly from African / Middle Eastern countries. Destination of these carriers is – Delhi, Ahmedabad, Mumbai, Jaipur and other major airports in India.

Major nationality of the carriers reported - Uganda, Zambia, Kenya, Zimbabwe, Tanzania, Mozambique, South Africa etc.

V. Trafficking of drugs through land borders

◆ Indo - Pak border: Though no major cases have been reported in recent the past, however this still remains challenging for Indian DLEAs. In recent times, trafficking of Heroin through drones into India has emerged as a new challenge. Such instances have been reported in Jammu & Kashmir, Rajasthan and Punjab border. Amritsar sector remains the most sensitive in terms of trafficking through drones.

1.2 NARCOTIC DRUGS

1.2.1 OPIUM






There are a number of alkaloids that can be extracted from Opium, some major alkaloids are Morphine, Codeine, Thebaine, Papaverine and Noscapine which are being extracted at Government Opium & Alkaloid Works at Neemuch (MP) and Ghazipur (UP).

Trends

 Major trafficking of Opium is from the States of Rajasthan, U.P. and M.P. Manipur, West Bengal, Jammu & Kashmir, Uttarakhand, Bihar, Jharkhand and Gujarat.

- Myanmar Second largest producer of Opium
- ◆ Although the area under cultivation has not returned to historic peaks of nearly 58,000 ha cultivated in 2013, Poppy cultivation in Myanmar is expanding and becoming more productive. Majorly trafficked into India through land borders along NE states



Significant Seizures of Opium by NCB:

- On 21.01.2023, Officers of NCB, Indore Zonal Unit seized 10.286 kg of Opium and 7.220 kg of Poppy Straw at Mundali, Mandsaur, Madhya Pradesh. 03 persons were arrested.

- On 07.10.2023, Officers of NCB, Chennai Zonal Unit seized 1.060 kg of Opium at Pursarvakam, Chennai. 02 persons were arrested.
- On 20.10.2023, Officers of NCB, Chandigarh Zonal Unit seized 2.380 kg of Opium at

- Sambu Toll Plaza, Ambala, Haryana. 03 persons were arrested.
- On 09.12.2023, Officers of NCB, Lucknow Zonal Unit seized 02 kg of Opium at Rampur Railway Station. 02 persons were arrested.
- On 19.12.2023, Officers of NCB, Ahmedabad Zonal Unit seized 4.574 kg Opium at DHL Exp. Pvt. Ltd, Vejalpur, Ahmedabad.

CASE STUDY - 01

Name of the Drug: Opium & Poppy Straw Qty. Seized: 10.286 Kg Opium

NCB Zonal Unit : Indore Zonal Unit

Total Arrest: 03 Persons

- On 20.01.2023, NCB, Indore Zonal Unit received a secret information that three Indian national have hidden huge quantity of illicit Opium and Poppy Straw along with them at Khalsa Punjab Dhaba, Vil-Mundli, Mandsaur-Neemuch Highway, Mandsaur.
- ◆ On 21.01.2023, NCB Indore Zonal Unit affected a seizure of 10.286 kg Opium & 7.220 Kg Poppy Straw at Khalsa Punjab Dhaba, Vill-Mundli, Mandsaur-Neemuch Highway, Mandsaur, Madhya Pradesh. On the basis of recovery and their confessional statements all 03 persons were arrested on 21.01.2023 for violation of section 8/15/18/25/27A and 29 of the NDPS Act, 1985 (as amended).
- ◆ Further, immediate interrogation revealed that two packets of illicit Opium have hidden in Bada (Plot) opposite residence of main accused in Vil- Mundli. Swift and immediate action of the NCB team led to recovery of another two packets of illicit opium
- ♦ Subsequently, all three accused were arrested on 21.01.2023.




1.2.2 HEROIN



Heroin is a highly addictive drug which is synthesized from Opium. Raw Opium is dried and purified to produce Morphine which is then treated with Acetic Anhydride to make Heroin. Depending upon its processing, Heroin comes out in a variety of colours, ranging from white to dark brown. Heroin is also known as smack, brown sugar locally and Chitta in Punjab. The level of purity of Heroin is indicative of the degree of sophistication in its processing.

Trends

- Opium poppy cultivation dramatically declined across all parts of Afghanistan and almost entirely in some provinces.
- With Taliban coming in power in 2021, area under cultivation decreased by 95%
- Trafficking into India through land & Maritime borders along Punjab, J&K, Rajasthan, Gujarat and Western Coast.
- Increased Maritime trafficking.





Significant seizures of Heroin by NCB:

- On 05.01.2023, Officers of NCB, Jodhpur Zonal Unit in coordination with BSF seized 3.248 kg of Heroin at BOP- K.S. Wala, 34 Bn, BSF, Raising Nagar, Rajasthan.
- On 06.01.2023, Officers of NCB, Lucknow Zonal Unit seized 1.280 kg of Heroin at Barabanki, Uttar Pradesh. 02 persons were arrested.
- On 10.01.2023, Officers of NCB, Jodhpur Zonal Unit in coordination with BSF seized 5.206 kg of Heroin at BOP- Sundar Pura, 125 Bn BSF, Sri Ganga Nagar, Rajasthan
- ◆ On 03.02.2023, Officers of NCB, Amritsar Sub-Zone in coordination with Enforcement Directorate team seized 2.160 kg of Heroin and 65 gram of Opium. Further, in the follow-up action on the same day in coordination with Enforcement Directorate team seized 13.980 kg of Narcotics powder at Anaj Mandi of Nausera Pannuan, Tarn Taran, Punjab.
- ◆ On 07.03.2023, Officers of NCB, Jodhpur Zonal Unit in coordination with BSF seized 2.505 kg of Heroin at BOP- KK Tibba, 127 Bn BSF, Gharsana, Sri Ganga Nagar, Rajasthan. 04 persons were arrested.
- On 27.03.2023, Officers of NCB, Amritsar Sub-Zone in coordination with BSF seized

- 5.820 kg of Heroin along with 01 Motor Cycle at BOP-Fatehpur, 183 Bn BSF, Ajnala, Punjab
- On 17.05.2023, Officer of NCB, Jodhpur Zonal Unit in coordination with BSF seized 05.005 kg of Heroin at 127 BN BOP, Nemichand, Gharsana, Distt- Sri Ganga Nagar, Rajasthan.

- 02 kingpins of international Drug syndicates were arrested from Jaipur International Airport while they were attempting to flee the country to Sharjah, UAE on 24/11/2022.
- ◆ Investigation till date have revealed that this group was smuggling Heroin from 03 primary routes i.e. Mundra Port Gujarat, ICP Attari Punjab and through J&K. The kingpin has admitted of importing more than 2000 Kgs of Heroin from these 02 Customs Port and from J&K.
- Cover consignments used at Mundra Port Gujarat, ICP Attari Punjab were high value cargo so that suspicion/red flags do not arise. Total 2000 kgs. heroin was manufactured from these tainted products at Ludhiana & Muzaffarnagar UP. Though imports were from Afghanistan, payments totaling 40 K USD approx. made to account in Wells Fargo Bank New York.
- ♦ A Pakistani national is the main handler/supplier abroad.
- ◆ Initially the Complaint against the seventeen persons were filed on 12.05.2023 and later Supplementary Complaint was filed against all the 20 accused persons on 22.12.2023 after a thorough investigation and sufficient evidences on record.

1.2.3 CANNABIS (GANJA)

According to the UNODC, "Cannabis is the most widely used illicit substance in the world". The typical herbal form of Cannabis consists of the flowers and substending leaves and stalks of mature pistillate of female plants. The resinous form of the drug is known as Hashish. Cannabis contains a number of chemical substances, however, the most predominant and only psychoactive substance is (-)-trans-delta9-tetrahydrocannabinol (delta-9-THC or THC).


Trends:

1.2.4 CANNABIS (HASHISH)



Hashish or Charas is the Cannabis resin derived from the plant Cannabis sativa. Generally Hashish is obtained from the plant by rubbing the flowering tops of the Cannabis plant between the palms of the hands or on rubber sheets. Cannabis resin is placed under Schedule I and IV of the Single Convention on Narcotic Drugs of 1961.


Trends:

Charas/Hashish is derived from the illicit Cannabis cultivation being done by the drug traffickers at Kashmir Valley especially in the districts of South Kashmir and Kullu in Himachal Pradesh.

- There is a trend of trafficking of Charas from Kashmir and Himachal Pradesh to Maharashtra, Rajasthan, Goa & Gujarat and other metro towns of India.
- Charas is also trafficked from Nepal to India.

1.2.5 COCAINE



Cocaine is widely used as a recreational drug that is prepared from Coca leaves. It is found in South American countries, primarily Brazil, Colombia, Bolivia and Peru. Cocaine, originating in South America, is trafficked throughout the world. In India, it is mainly smuggled in small quantities by West African drug traffickers. It is generally encountered in two forms which differ in their route of administration. Cocaine hydrochloride, which is insufflated or injected, and cocaine base, which is a smokable form.


Trends:

- Smuggling of Cocaine is mostly being done by African nationals based in India.
- Instances of Cocaine being smuggled from Afghanistan, Argentina, Brazil and South America have also come to notice.
- Seizures of Cocaine in India have been made at airports mostly.

- concealed in common household articles like cosmetics, utensils, books and clothing.

CASE STUDY-05

Name of the Drug: Cocaine Qty. Seized: 5 Kg Cocaine

NCB Zonal Unit : Mumbai Zonal Unit Total Arrest: 02 Persons

♦ In pursuance of active intelligence follow up pertaining to international drug trafficking, based on specific input, a Bolivian lady 'X' was identified to have arrived from Sao Paolo to Mumbai via Dubai by Etihad airlines on 12.10.2023 along with drug consignment and was staying at a pre-booked hotel in Khetwadi, Mumbai. Immediately, a team was constituted which proceeded to the hotel and setup a discreet search operation.

- ◆ Upon confirmation about presence of the lady, the team intercepted her who was with another lady 'Y' a Bolivian national. Upon preliminary questioning, no satisfactory reply was given by the duo upon which search of their belongings was made during which total 05 Kgs Cocaine was recovered from baggage of both ladies.
- The drugs were guilefully concealed among non-suspicious items as undergarments, cloths, toothpaste, cosmetic tubes, soap, footwear, makeup kit. The drugs were carefully concealed in form of powder, liquid & paste which could be easily planted among regular items.
- ◆ During interrogation, they revealed information about their handler and stated that in order to minimise suspicion of anti drug agencies, they opted to travel from Dubai to Mumbai by Etihad Airways. They revealed that they crossed over to Brazil and received the consignment and parted ways for the travel. In evasive maneuver, they boarded flights from different cities in Brazil. Both arrived in Mumbai and were changing their locations frequently. When NCB team intercepted them, them were in preparing to check out of the hotel.





1.3 NARCOTIC CROPS

1.3.1 Licit Opium Poppy Cultivation


India is the only country, authorized by the United Nations Single Convention on Narcotic Drugs (1961), to produce Gum Opium. Countries such as Australia, Austria, France, China, Hungary, Netherlands, Poland, Slovenia, Spain, Turkey and Czech Republic also produce Opium but through Concentrate of Poppy Straw (CPS) method.

Licit cultivation of Opium Poppy is carried out in India on selected tracts notified by the Central Government annually in the States of Madhya Pradesh, Rajasthan and Uttar Pradesh. Licences are issued by the CBN to eligible cultivators in the above three States as per the General Conditions relating to Grant of Licence framed by the Central Government.

1.3.2 Illicit Opium Poppy Cultivation

The extent of illicit cultivation of Opium Poppy cannot be exactly quantified but eradications undertaken by law enforcement agencies are indicative of the areas prone to such cultivation. The Government of India has undertaken the satellite imaging of such illicit cultivation and results from this enable a more focused approach for eradication of the illicit crop.

During 2023 illicit cultivation of Opium Poppy was found in the States of Arunachal Pradesh, Assam, Gujarat, J&K, Jharkhand, Madhya Pradesh, West Bengal, Uttar Pradesh, Bihar & Manipur & total 31785 Acres of illicit opium cultivation has been destructed by NCB in coordination with other enforcement agencies.









1.3.3 Illicit Cannabis Cultivation

Under the NDPS Act as well as under the UN Drug Control Conventions, the cultivation of Cannabis is illegal. One of the important counter-measures undertaken by NCB is to identify and destroy illicit cultivation of the

plant. During 2023, the area under illicit cannabis cultivation detected was around 22507 acres, in the states of Odisha, Gujarat, H.P., J&K, Tripura and Uttarakhand etc. which was subsequently destroyed by various Central & State agencies.

1.4 PSYCHOTROPIC SUBSTANCES

Psychotropic Substances are any chemical agent affecting the mind or mental processes (i.e. any psychoactive drug). The UN Convention on Psychotropic Substances, 1971, establishes the international control regime for such substances. The Convention responded to the diversification and expansion of the spectrum of drugs of abuse and introduced controls over a number of synthetic drugs according to their abuse potential on the one hand and their therapeutic value on the other.

1.4.1 Synthetic Drugs

Synthetic drugs like Amphetamine Type Stimulants (ATS) have become the drug of choice in South East Asia and in North America. In India, several attempts have been made in the past to set up clandestine manufacturing facilities, especially in Maharashtra and Gujarat to produce ATS. Narcotics Control Bureau has successfully thwarted these attempts.

Trends:

- ◆ Trafficking of ATS from Myanmar to India along North-Eastern Border States.
- Australia, Malaysia and Thailand are the major destination countries for ATS trafficking sourced from India.
- USA, Australia, Malaysia and South Africa are the major destination countries for Methaqualone/ Mandrax sourced from India.
- A major portion of Methaqualone/ Mandrax seizures are effected at Airports of New Delhi, Kolkata and Mumbai.

Significant seizures of Mephedrone by NCB:

- On 05.01.2023, Officers of NCB, Ahmedabad Zonal Unit seized 1.478 kg of Mephedrone and 01 person was arrested.
- ◆ On 13.03.2023, Officers of NCB, Mumbai Zonal Unit seized 1 kg of Mephedrone at DHL Courier, Mumbai, Maharashtra.
- On 30.04.2023, Officers of NCB, Mumbai Zonal Unit seized 02 kg of Mephedrone at Bhiwandi, Maharashtra. 03 persons were arrested.
- ◆ On 09.06.2023, Officers of NCB, Mumbai Zonal Unit seized 20 kg of Mephedrone, Rs. 1,10,24,000/- and 186.6 gram of Gold Ornaments at Dongri, Mumbai. 03 persons were arrested.
- ◆ On 04.08.2023, Officers of NCB, Lucknow Zonal Unit along with STF Varansi busted a clandestine lab of Mephedrone operating at duplex house at Shivpur Varanasi and recovered 1.3 kg of Mephedrone along with clan lab equipments like, beakers, jars, glass containers, chemicals, gas cylinder and gas oven etc, 01 pistol, 01 magazine and 04 live rounds and cash worth Rs. 40,000/-



CASE STUDY-06

Name of the Drug: Mephedrone Qty. Seized: 20 Kg Mephedrone

NCB Zonal Unit: Mumbai Zonal Unit Total Arrest: 06 Persons

♦ In wake of rapid drug trafficking activity, especially Mephedrone, NCB-Mumbai boosted its intelligence sources which led to identification of a Dongri, Mumbai based syndicate. This area is known as hub of organized crime syndicate (Underworld) of country. Gradually, information was deciphered which led to zero down of kingpin named 'X'. He was actively supported by his wife 'Y' and other person 'Z'.

- ◆ The specific information was analysed wherein consignment was to be delivered on behest of 'X' to 'A' in Dongri. A team of NCB-Mumbai was established who setup a infallible trap layout in Dongri. Later, based on specific information on 09.06.2023, 'B', a close associate of 'A' was intercepted with 3 kgs Mephedrone in Dongri. Immediate follow up action led to interception of 'A' with 2 kgs Mephedrone from his premise in Dongri, Mumbai. However, subsequent field information was analyzed which indicated huge drug quantity of Mephedrone was stored nearby only.
- ◆ Consequently, follow up action was conducted at home of 'X' which led to recovery of another 15 kgs Mephedrone which was closely guarded by his wife 'Y'. Further extended search led to recovery of cash in tune of Rs.1,10,24,000/- and gold ornaments weighing 186.6 gms.
- ◆ During financial investigation multiple properties including 03 flats, gold, cash, worth Rs. 4.90 crores were freezed. Further, three more bank lockers were opened and found cash, gold & silver worth Rs 80,80,870/-. Two under construction flats booked by accused worth Rs 70 lakh, were identified and subject to financial investigation. It was found that huge amount of drug proceeds was routed through different bank accounts to launder the money. Thus this laundered money was used for purchase of properties, gold and other valuables.

CASE STUDY-07

Name of the Drug: Methamphetamine Qty. Seized: 2525.675 Kgs

Methamphetamine

NCB Zonal Unit: Cochin Zonal Unit Total Arrest: 06 Persons

◆ Based on a specific information, Indian Navy apprehended one foreign national (Iranian / Pakistani) along with Methamphetamine (2525.675 kg), which was recovered from a non AIS vessel in Arabian Sea.

- ◆ The foreigner along with contraband was handed over by Indian Navy to NCB Cochin on 13.05.2023. NCB Cochin seized the contraband and arrested the foreigner after his examination.
- ◆ The contraband is believed to have originated from Pakistan and transported via sea route off Chabahar Port, Iran. The contraband belongs to a Pakistan based drug trafficker named 'X'. The contraband was trafficked by 'X' through his associate 'Y', a Pakistani, operating also from Iran and the carrier 'Z' (arrested accused).







1.5 PRECURSOR CHEMICALS

Precursor Chemicals are dual use chemicals that have legitimate uses, and can also be used in the manufacture of illicit narcotic drugs and psychotropic substances.

Trends:

- Ephedrine/ Pseudoephedrine trafficking is done mainly through Delhi, Chennai, Cochin Airports.
- Instances of use of courier/ parcels also have been noticed.

Significant seizures of Ephedrine / Pseudoephedrine / Acetic Anhydride:

From 31.03.2023 to 03.04.2023, Officers of NCB, Ahmedabad Zonal Unit seized

- 39,60,000 capsules (475.2 kg) of Pseudoephedrine at S-3 Godown, Port CFS, APM Terminal, Pipavav Port, District-Amreli, Gujarat.
- On 25.04.2023, Officers of NCB, Delhi Zonal Unit seized 4.927 kg of Pseudoephedrine at DHL Exp. Pvt. Ltd. Rama Road, Kriti Nagar, New Delhi.
- On 04.07.2023, Officers of NCB, Mumbai Zonal Unit seized 3.87 kg of Pseudoephedrine at Aramax Couriers, Andheri, Mumbai.
- On 25.09.2023, Officers of NCB, Mumbai Zonal Unit seized 49.880 kg Pseudoephedrine at Mumbai.

CASE STUDY-08

Name of the Drug: Pseudoephedrine Qty. Seized: 39,60,000 capsules

Pseudoephedrine

NCB Zonal Unit: Ahmedabad Zonal Unit **Total Arrest: 02 Persons**

- Acting upon a specific input, a team of officials of Narcotics Control Bureau, Ahmedabad had searched a container bearing no. TCLU5702630 at Pipavav Port and took batch wise samples (in triplicate) of medicines claimed/suspected to be containing Pseudoephedrine. The first sample of each batch was sent to National Forensic Science University, Gandhinagar (NFSU) for chemical analysis.
- Since the intelligence regarding diversion of pseudoephedrine was found correct as per the NFSU report, a team of NCB Ahmedabad carried out seizure procedure of medicines contained in said container bearing no. TCLU5702630 and seized fake capsules of Pseudoephedrine totaling to 3960000 nos. As per declaration, each capsule was supposed to contain 120 mg of pseudoephedrine HCL and in this manner diversion of 475.2 kg of Pseudoephedrine HCL was prima facie unearthed in this operation
- During the investigation, it was found that the said medicines were manufactured and being exported by M/s 'X' to South Sudan. In this connection, The Director, Authorized Chief Chemist and Store incharge of M/s 'X' were arrested for their involvement in the crime and contravention of provisions of Sections 9A, 25A, 26, 29 & 38 of NDPS Act.









1.6 PHARMACEUTICAL DRUGS

India has one of the biggest pharmaceutical industrial bases & diversion of pharmaceutical substances is resulting in the increasing abuse of prescription drugs. The problem seems to be serious in the North-East and North-West region of the country. The pharmaceutical products that are abused include Buprenorphine, Codeinebased cough syrups, Alprazolam, Diazepam and other sedatives. The easy availability of such preparations is the major factor that encourages their misuse. There is also a perception that these pharmaceutical drugs are less harmful than hard drugs like Heroin, Cocaine, etc. However, this is a misconception, since these can be addictive and also have a debilitating effect on health. Pharmaceutical preparations having narcotic / psychotropic substances are under the purview of the Drugs and Cosmetic Acts, and the NDPS Act in India.

Law enforcement agencies have also seized sizeable quantities of Alprazolam tablets, Zolpidem, Tramadol tablets, Sildenafil tablets, etc.

- On 09.03.2023, Officers of NCB, Delhi Zonal Unit seized 530 tablets of Diazepam, 1650 tablets of Alprazolam, 1890 tablets of Lorazepam, 465 tablets of Clonazepam and 495 tablets of Zolpidem at Aramax India Pvt. Ltd., Bandoli, Dwarka, Sector-28, New Delhi
- On 01.05.2023, Officers of NCB, Dehradun Sub-Zonal Unit seized 1010 tablets of Alprazolam and 32 tablets of Tramadol at Madhu Medicos, Prem Nagar, Dehradun. 01 person was arrested.

- ◆ On 02.05.2023, Officers of NCB, Mumbai Zonal Unit seized 5,970 tablets of Nitrazepam at the professional Courier, Pune, Maharashtra. 02 persons were arrested.

- On 28.07.2023, Officers of NCB, Delhi Zonal Unit seized 1000 tablets of Zolpidem at DHL Exp. Pvt. Ltd., Rama Road, Kirti Nagar, New Delhi.
- On 02.07.2023, Officers of NCB, Mumbai Zonal Unit seized 25,000 tablets of Alprazolam at Dadar Railway Station, Mumbai.01 person was arrested.
- On 07.07.2023, Officers of NCB, Dehradun Zonal Unit seized 20,700 tablets of Alprazolam at Kaulagarh, Dehradun. 01 person was arrested.
- On 06.09.2023, Officers of NCB, Mumbai Zonal Unit seized 15,000 tablets of Alprazolam.
- On 07.10.2023, Officers of NCB, Mumbai Zonal Unit seized 199.25 kg of Alprazolam from illegal drug manufacturing lab from Pune. 01 person was arrested.
- On 26.10.2023, Officers of NCB, Indore Zonal Unit in coordination with Chhattisgarh Police seized 12000 tablets of Alprazolam and 240 tablets of Tramadol at Bela Bazar, Jagdalpur, Chhattisgarh. 01 person was arrested.
- On 15.11.2023, Officers of NCB, Jaipur Zonal Unit seized 13, 810 tablets of Tramadol /Alprazolam and 06 bottles of CBCS. 02 persons were arrested.

CASE STUDY-09

Qty. Seized: 199.3kg Alprazolam Name of the Drug: Alprazolam

NCB Zonal Unit: Mumbai Zonal Unit **Total Arrest: 02 Persons**

Mumbai Zonal Unit seized 199.3 kgs of Alprazolam along with huge amount of raw materials from two clandestine labs situated in two locations in Pune, Maharashtra.

Two persons have been arrested including one from Hyderabad, Telangana. The syndicate had multi-state linkages.

















CASE STUDY-10

Qty. Seized: 1019.64 Kgs CBC Syrup Name of the Drug: CBC Syrup

NCB Zonal Unit: Ahmedabad Zonal Unit **Total Arrest: 02 Persons**

On the basis of the information, Ahmedabad Zonal Unit has seized 1019.64 kgs of CBCS from a courier services and two persons were arrested, including a government official.

- The courier was sourced from Gujarat. Multiple state linkages found in this matter with involvement of kingpin in multiple cases of NCB.
- Both accused are under Judicial Custody. Case is under investigation



CASE STUDY-11

Name of the Drug: Tramadol Qty. Seized: 540.980 Kgs Tramadol

NCB Zonal Unit: Ahmedabad Zonal Unit Total Arrest: 01 Person

- ◆ On 21.06.2023, NCB Ahmedabad Zone had received a specific information through a reliable source that "A pharmaceutical company M/s 'X' is trying to export one product in around 400 drums which they have declared as "SILDENAFIL MICRO GRANULES BP 90%." The said product is stuffed in a container bearing number PONU0047066 and is destined for Congo, Africa via ICD, Sanand. However out of the 400 drums, 25 contain Tramadol, a psychotropic substance in powder form, and not the declared SILDENAFIL MICRO GRANULES BP 90%. The said container lying in ICD Sanand has to be checked and examined as Tramadol is a prohibited banned psychotropic substance covered under NDPS Act 1985 (as amended).
- On 22.06.2023 based on the specific input, the NCB, Ahmedabad had examined and seized one container that was lying in ICD Sanand. Upon interception, 540.980 kg (gross weight) Tramadol in powder form were seized from the aforesaid container, and one person was arrested.
- ◆ Upon thorough examination of the drums lying in the said container, it was observed that there were some visible difference in weight and other physical characteristics like texture, odour and colour in the randomly opened drums. Then 'Y' voluntarily disclosed in the presence of the panchas that the off-white powdered substance present in drums was Tramadol and the same is stuffed in 25 drums.
- ◆ Then, the NCB team took the weight of the aforesaid 25drums (drum no 77 to 101) one by one using the weighing machine available in the warehouse. Total 540.980 Kgs (Gross weight) Tramadol was seized.
- ◆ After that on the basis of voluntary confession of 'Y' that he was actively involved in trafficking of Tramadol covered under NDPS Act 1985. He was put under arrest on 01/07/2023.









1.7 BUSTING OF ILLICIT LABS

 Busting of 02 Clandestine Laboratory at Greater Noida, UP (May 2023)

On 17.05.2023, Officers of UP Police busted a lab and seized 46.2 Kg Methamphetamine along with other manufacturing equipment and 01 car at Greater Noida, UP and arrested 10 persons (09 Nigerian and 01 Senegalese). In follow up action UP Police also busted another lab and seized 30.9 Kg Methamphetamine along with other manufacturing equipments and 02 Car at Greater Noida, UP and arrested 03 persons (02 Nigerian and 01 Kyrgyz)

 Busting of 01 Clandestine Laboratory at Mapusa, Goa (May 2023)

On 01.05.2023, Officers of NCB Goa busted a lab and seized 2466 LSD blots, 5 gram Psilocybin, 10.470 gram MDMA, 60.50 gram

Ganja, 80 gram Hashish and other manufacturing equipments at Mapusa, Goa and arrested 01 person.

 Busting of 01 Clandestine Laboratory at Hyderabad (May 2023)

On 07.05.2023, Officers of NCB Hyderabad busted a lab and seized 3.9 Kg Alprazolam and other manufacturing equipment at Hyderabad and arrested 03 persons

 Busting of 01 Clandestine Laboratory at Hyderabad (June 2023)

On 05.06.2023, Officers of NCB Hyderabad busted a lab and seized 119.5 Kg Alprazolam and other manufacturing equipments at Hyderabad and arrested 04 person.







Busting of 01 Clandestine Laboratory at Kolkata (June 2023)

On 17.06.2023, Officers of NCB Kolkata busted a lab and seized 2.65 Kg Opium,0.07 AA, 0.4 Kg Heroin and other manufacturing equipments at Hyderabad and arrested 02 person.

Busting of 01 Clandestine Laboratory at Varanasi (August 2023)

On 04.08.2023, Officers of NCB Lucknow/ STF Varanasi busted a lab and seized 1.3 Kg Mephedrone, 01 pistol, 01 ammunition magazine, 04 Rounds, INR 40,000/- and other manufacturing equipment at Shivpur Varanasi and arrested 05 persons.

Busting of 01 Clandestine Laboratory at Pune (Oct 2023)

On 06.10.2023, Officers of NCB Mumbai busted a lab and seized 199.3 Kg Alprazolam, and other manufacturing equipments at Pune and arrested 01 person.

Busting of 02 Clandestine Laboratory at Chhatrapati Sambhaji Nagar (Aurangabad) (Oct 2023)

On 20.10.2023, Officers of DRI Mumbai busted a lab and seized 23.32 Kg Cocaine, 2.96 Kg of Mephedrone, and other manufacturing equipments at Chhatrapati Sambhaji Nagar (Aurangabad) and in follow up action seized 4.5 Kg Mephedrone, 4.3 Kg Ketamine, 9.3 Kg mixture of Mephedrone/Ketamine. In further follow up action on 28.10.2023 seized 107 litre of liquid Mephedrone and also seized 31,00,000/-INR and arrested 04 persons.







1.8 CONTROLLED DELIVERY

Controlled Delivery is a technique which allows illicit or suspected consignments of Narcotics Drugs and Psychotropic substances, controlled substances or substances substituted for them to pass out of, or through or into territory of India with the knowledge and under the supervision of an Officer empowered in this behalf or duly authorized under Section 50A with a view to identify the persons involved in the commission of an offence under this Act.

The Director General of Narcotics Control Bureau constituted under sub Section (3) of section 4 or

any other Officer authorized by him in this behalf, any notwithstanding anything contained in this Act, undertake controlled delivery of any consignment to:-

- Any destination in India;
- ◆ A foreign country, in consultation with the competent authority of such foreign country to which such consignment is destined, in such a manner as may be prescribed.

During the year 2023, total 51 controlled delivery operations were carried out by NCB and other agencies as well.

1.10 PIT-NDPS

Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act, 1988

Trafficking and abuse of Narcotic Drugs and Psychotropic Substances has, over years reached alarming proportions in some parts of the country. It is important that all State Governments and the Central Government use all available legal provisions to curb this menace. One very potent law which has been extremely underutilized is the PITNDPS Act. Once a preventive detention order under PITNDPS Act is issued against a person, the illegally acquired properties of that person, his relatives and associates can be seized, frozen and forfeited through a quasi-judicial process as per Chapter VA of NDPS Act.

What is PITNDPS Act?

It is an act that provides for Preventive Detention Orders against any person with a view to prevent from engaging in illicit traffic in narcotics and psychotropic substances.

The process:

The Sponsoring Authorities such as police, CBN, NCB, Customs, etc. send proposal for preventive detention to the detaining authority. Sponsoring authority working under State Government such as Police can send proposal to the detaining authority in their State or to the detaining authority at the centre. Similarly, Sponsoring Authorities working under Central Government such as NCB or Customs can send proposals either to the detaining authority under the Central Government or to the detaining authority under the State Government.

Why Preventive Detention?

Officers of NCB,CBN,DRI, Customs, State police, etc. search, seize, arrest and investigate drug offences and prosecute traffickers under the NDPS Act, 1985. However, if the traffickers are habitual offenders, whose activities are required to be curbed immediately, the provisions of PITNDPS Act, 1988 are invoked which provide for preventive detention for one year. It is not a substitute for prosecution, but an additional weapon to fight organized trafficking of drugs. It is invoked to snap the nexus/network of crime.

Basic objective of PITNDPS Act is to target individuals such as organizers financiers and their agents who organize things from behind the scene. Habitual or organized illicit traffickers caught red-handed with ND/PS/CS to be detained pending prosecution, licensed cultivators indulging in embezzlement of Opium or undertaking excess cultivation and persons indulging in illicit cultivation Opium Poppy /Cannabis.

Who can issue Detention Orders under PITNDPS Act?


- I) Central Government-Officer not below the rank of a Joint Secretary
- ii) State Government-Officer not below the rank of a Secretary

If State Government issues the Detention Order, it has to send a report to the Central Government within 10 days from the date of detention orders and the grounds of detention to be communicated to the detenue within 5 days or 15 days (exceptional circumstances) [Section3(3)].

1.11 MONEY LAUNDERING

Enforcement Directorate has taken vigilant steps in tackling the threat of money laundering by taking

necessary action under the provisions of PMLA, 2002 which includes money laundering in cases, where the predicate offences have been registered under Section 15-24, 25A, 27A & 29 of the Narcotic Drugs and Psychotropic Substances Act, 1985.

Case study on NDPS Case

The NCB received information that Mr. X of M/s. ABC was involved in an internet-based pharmacy that shipped parcels/couriers, suspected of containing Narcotics Drugs/Psychotropic substance-based medicines on behalf of another firm, M/s. DEF. A case under Narcotics Drugs and Psychotropic Substances Act, 1985 was registered against the accused. The investigation revealed that Mr. X operated from different addresses, including his own house in Gurugram.

Based on this information, the NCB conducted searches at Mr. X's premises, resulting in the

seizure of psychotropic substances. Subsequently, they filed a Criminal Complaint against Mr. X, M/s. ABC, M/s. DEF & others under various sections of the NDPS Act of 1985.

ED initiated ML investigation and to trace the proceeds of crime, the bank account statements of various entities were analyzed. This analysis revealed that M/s. ABC had been receiving funds from a company M/s. XYZ in USA. However, it was found that M/s. XYZ did not exist at the address provided in the agreement, indicating that the money received by M/s. ABC from M/s. XYZ was the proceeds of illegal drug sales.

The main accused, Mr. X & his two accomplices Ms. Y and Mr. Z were declared proclaimed offenders and remained absconding during the investigation. Nonetheless, searches were conducted at three locations, and statements of various other suspects/accused persons were recorded under Section 50 of PMLA, 2002.

The investigation resulted in identification and attachment of properties worth Rs. 6.57 crores purchased from the proceeds of crime, thus making them available for confiscation.

During further investigation, proceeds of crime in the form of movable and immovable properties

1.12 FINANCIAL INVESTIGATION

Financial Investigation is an important tool in the hand of Narcotics Control Bureau which was introduced in the year 1989 in the Act with an objective to ensure that the properties of traffickers generated from drug money could be frozen / seized or forfeited without delay. In order to break the backbone of a drug trafficking networks, it is very important to trace, identify, seize/freeze and forfeit their tangible/intangible and movable/immovable assets generated out of drug money, immediately after an offence is committed under the Act.

amounting to Rs. 23.36 crores were identified. These properties were derived or obtained by Mr. X, M/s ABC, and their associates.

A Prosecution Complaint was filed on 23.02.2022 before the Special Court under PMLA, 2002 at Gurugram. The case is currently at the notice stage.

This case study highlights the successful collaboration between the Narcotics Control Bureau and Directorate of Enforcement. It illustrates the financial trail of proceeds earned through the illegal sale of drugs and the legal actions taken to address the issue, including property attachments and prosecution.

FI can be done in respect of following:

- a. Every person who is convicted for an offence punishable under the Act for 10 yrs or more.
- b. Every person who has been convicted for a similar offence outside India...
- Every person against whom a PITNDPS c. Detention order has been issued (provided it has not been revoked).
- Every person who has been either arrested or d. against whom a warrant of arrest has been issued in India or corresponding law of any other country for an offence punishable under act for 10 yrs or more.

Role of Competent Authority

Section 5 of the N.D.P.S Act,1985 (as amended) provides for appointment of Competent Authority & Administrator for proceedings under the Act. Upon receipt of information regarding property holding of any person covered under the Act, the Competent Authority issues a notice to the Concerned person for

explaining the sources of income required for acquisition of the property. The Competent Authority, after considering the submissions made by the person, finally forfeits the property, or imposes fine in lieu of forfeiture.

After the forfeiture order reaches its finality, the forfeited property is put to public auction and proceeds of highest bid prices received in the public auction is accordingly deposited to the designated fund of Government of India.

1.13 NARCO-TERRORISM

Terror Financing

The problems of terrorism, drugs and international organized crime are significant challenges to our country. These problems are mostly occurring across the border States, especially in Punjab and the North Eastern States of India. Terrorists around the world and in every region appear to be increasing their involvement in the trafficking of illegal drugs, primarily as a source of financing for their terrorist operations.

Narco-terrorists participate directly or indirectly in the cultivation, manufacture, transportation and /or distribution of Narcotics Drugs & Psychotropic Drugs. Several terrorist groups provide security for drug traffickers transporting their products through territories under the control of terrorist organizations or their supporters.

As per the information available with NCB, composite seizures (seizure of drugs along with arms/ammunitions/FICN) have been effected by Law Enforcement Agencies in India. Most of these seizures are reported from Indo-Pak border

in the States of Punjab, Rajasthan and J&K. Few seizures have been made in West Bengal, Odisha, MP, UP, Manipur, Nagaland and Meghalaya.

Punjab border has been the most affected where the maximum composite seizures of drugs, FICN and Arms & Ammunitions have been affected either by State or Central Agencies. These seizures include huge quantities of Heroin, Opium, Charas and other drugs. Sophisticated weapons like AK-47/ AK-56 rifles, RDX, foreign made pistols, and FICN were also seized in Punjab bordering areas.

Illicit cultivation of Cannabis is found in districts of Vishakhapatnam, in Andhra Pradesh, and Malkangiri, Gajapati, Rayagada, Sambalpur, Kandhamal, Koraput, Sundargarh, Kalahandi and Deogarh in Odhisa. All these are the LWE affected districts, with reports of illicit cultivation of Cannabis and LWE groups are more active. It may be presumed that LWE Groups may be linked to this illicit cultivation of Cannabis, however confirm reports regarding involvement of LWE Groups in illicit cultivation are not available with NCB Total 190 composite seizures have been reported to NCB Hqrs. during 2009-2023. The details of composite seizure during last 05 years are as.

CAPACITY BUILDING

2.1 TRAINING

The mandate of NCB also creates an obligation on it for capacity building of other drug law enforcement agencies entrusted to enforce drug laws in the country. In addition to providing material support to them through the Assistance to States scheme, it is also mandatory to develop and enhance enforcement skills of their personnel / drug law enforcement officers.

In India, the Officers working for drug law enforcement include Officers from Central and State Government agencies which include the following;

- Narcotics Control Bureau
- Customs and Central Excise
- Department of Revenue Intelligence
- Border Guarding Forces
- State Police
- State Excise
- State Drug Controller, etc.

Common training requirements of the above mentioned agencies include, principal laws like Narcotic Drugs and Psychotropic Substances Act, 1985, PITNDPS Act, 1988, Regulation of Controlled Substances Order (RCS Order), 2013, Circular/ notifications, documentation procedures, emergence of New Psychoactive Substances (NPS), precursor control mechanism, collection of intelligence, National/ International trends in drug traicking, the study of reasons for acquittal of cases etc.

NCB conducts regular short duration training programmes for such field officials, either by itself or in co-ordination with other authorities like National Academy of Custom, Indirect Taxes and Narcotics(NACIN), Intelligence Bureau(IB), Central Bureau of Investigation(CBI), North Eastern Police Academy(NEPA), National Institute of Criminology and Forensic Sciences(NICFS), Central Academy of Police Training (CAPT), National Forensic Science University (NFSU), Border Guarding Forces, State Police Training Centres, etc.

These programmes also provide a platform for sharing of best practices of the agencies in their respective areas of strength like increased knowledge of Drug Law Enforcement, enhancement of intelligence collection as well as investigation, knowing new trends & patterns of drug trafficking, understanding the execution of "Controlled Delivery" operations, busting of Clandestine Labs etc.

NCB also provides 'resource persons' and training materials to other sister organizations like NACIN, CBI Academy, NICFS, BSF, SSB, NPA and State Police Academies for specialized training in drug law enforcement.

Narcotics Control Bureau consistently collaborates with various training academies and drug law enforcement agencies to facilitate training courses on drug law enforcement. During the year 2023, a total of 320 such courses were

conducted across the nation. These courses involved the training of approximately 16724 personnel from the Narcotics Control Bureau and various State Police, Central/State Excise Departments, Customs, Central Armed Police Forces (CAPFs), Coast Guard and courier agencies.

In addition to the aforementioned efforts, this Bureau recognizes the evolving tactics employed by Drug Trafficking Organizations (DTOs), particularly their adept use of advanced cyber technology. Consequently, the Bureau has been proactive in bolstering the technical proficiency and capabilities of its officers, as well as those from other Central/State agencies. To achieve this, the Bureau has facilitated a series of technical courses and workshops focusing on areas such as digital footprints, cyber and mobile forensics, intelligence gathering, CCTV footage, evidence extraction from Open Source/Social Media, and the investigation of Dark net and crypto currencies.

2.2 ASSISTANCE TO STATES

With a view to eradicate drug menace, the Government of India has introduced a Scheme namely, 'Assistance to States & UTs for Narcotics Control' to finance State Governments in order to strengthen their enforcement capabilities towards combating illicit trafficking in Narcotics Drugs

and Psychotropic Substances. Under this Scheme, financial assistance is given for augmenting the drug law enforcement capabilities of the States.

The Scheme was launched by the Ministry of Home Affairs on 24th October, 2004 for 05 years and subsequently extended from time to time according to existing guidelines. The details of the timeline of the scheme are as under:

Narcotics Control Bureau, being the national Nodal agency for drug administration has been given the responsibility to process the proposals received from State Governments for Central Assistance for improving enforcement capabilities in dealing with the supply side of drug menace. 2.3 DRUG DETECTION KITS

NCB procures and provides Drug Detection Kits to Drug Law Enforcement Agencies across the country. These DD Kits provide simple, correct and user-friendly method for 'on the spot' testing of suspected materials, even by non-technical officials. These Drug Detection Kits are of three types:

- Narcotic Drugs Detection Kit,
- B) Precursor Chemicals Detection Kit and
- Ketamine Detection Kit.

The DD Kits have been procured centrally by

NCB Hqrs. since 1989 from Hindustan Antibiotics Ltd., Pune and distributed to all the Zonal Units of NCB which are the further distributed to law enforcement agencies falling under their respective jurisdictions.







2.5 NATIONAL NARCOTICS CANINE POOL (NAR-K9)

Nar-K9 along with dog handlers/assistant dog handlers are being provided to NCB by the BSF, SSB and Assam Rifles in Delhi, Jammu, Ahmedabad, Kolkata, Mumbai, Imphal and Chandigarh.

NCB Zonal Directors have been designated as Nodal Officers for all practical purposes under guidance of Regional DDG with respect to the Canine Squads established in their respective Zones. It has also been decided/directed by DG-NCB to Zonal Director to submit the progress report in respect of deployed Canine Squad to DDG (OEC), NCB HQ for better monitoring and optimum utilization.

Nar-K9 requisitions received from Central/State/UT DLEAs and NDPS Act empowered CAPFs may be fulfilled by concerned NCB Zonal Units on requirement basis. Necessary Requisition Form can be filled and submitted online by DLEAs on the NCORD Portal itself. Proforma for Feedback Report has also been provided on the NCORD Portal.

- During the 3rd APEX NCORD Committee meeting held on 27.12.2021, the Hon'ble Union Home Minister had directed to set up a **National Narcotics Helpline** that would be dedicated, 24x7, toll-free National Narcotics Call Centre for reporting any information w.r.t drugs trafficking, drug usage or to deliver information w.r.t drugs and policies of NCB.
- MANAS has been envisioned as an integrated system providing a single platform for citizens to log, register, track, and resolve drug-related issues/problems through various modes of communication like call, SMS, Chat-bot, e-mail and we-link.
- Narcotics Control Bureau in collaboration with Digital India Corporation (DIC) is developing a helpline i.e MANAS (मादक पदार्थ निषेध आसूचना केंद्र), a National Narcotics Helpline and the development is in the final stage and is proposed to be launched shortly.

3.1.5 INCB/UNODC Reporting

Being a signatory to the various international conventions on narcotic drugs and psychotropic substances, India is under obligation to submit the required information to the United Nations Office on Drugs Crime (UNODC) and International Narcotics Control Board (INCB) in the prescribed formats. NCB is the nodal/central agency for implementation of the India's obligations under various international conventions.

International Narcotics Control Board (INCB)

To meet the international obligations under the UN Conventions on Narcotic Drugs, 1961, Convention on Psychotropic Substances, 1971 and United Nations Convention against illicit traffic in Narcotics Drugs and Psychotropic Substances, 1988, NCB submits seven reports in the prescribed formats namely, Form A, B, C, D, P, A/P and B/P to INCB Vienna. Form A& A/P relating to Import and Export of Narcotic Drugs and Psychotropic Substances, respectively, are being submitted to INCB on a quarterly basis.

The other Forms i.e B, C, D & P are being submitted to INCB on an annual basis. These forms are related to annual assessment/ estimates of narcotic drugs and psychotropic substances in different fields. While Form B/P is being submitted once in three years,

which is related to annual assessment of medical and scientific requirement of scheduled substances. Inputs on the different Forms come from agencies like Central Bureau of Narcotics (CBN), the Chief Controller of Factories (CCF), the Drug Controller General of India (DCGI) besides the Narcotics Control Bureau (NCB).

United Nations Office on Drugs and Crime (UNODC)

Each member country has to provide inputs in the Annual Report Questionnaire (ARQ) every year on the working of the international drug control treaties to UNODC. Before 2021, ARQ has to be submitted offline and contained 04 Parts:

Part I: Legislative and Institutional Framework

Part II: Comprehensive Approach to Drug Demand Reduction and Supply

Part III: Extent and Patterns of Drug Use

Part IV: Extent and Patterns of and Trends in Drug Crop Cultivation and Drug Manufacture and Trafficking

However, from 2021, the Annual Report Questionnaire (ARQ) is to be filled online by the Officially Appointed Focal Point. The ARQ for 2020 is divided into 14 Annual Modules (A01-A14) and 06 Rotating Modules (R06, R07, R09, R11, R12, R13).

- Apart from the regular members of monthly NCORD, the Eastern States/ UTs i.e. Bihar, Jharkhand, Odisha, West Bengal and Andaman & Nicobar Islands were also invited for the meeting.
- ◆ On 15.09.2023, the 26th Monthly meeting of NCORD under the Chairmanship of DG, NCB was held through video conferencing mode. Apart from the regular members of monthly NCORD, the Southern States/ UTs i.e. Karnataka, Tamil Nadu, Kerala, Andhra Pradesh, Lakshadweep & Puducherry were also invited for the meeting.





On 10.11.2023, the 27th Monthly meeting of NCORD under the Chairmanship of DG, NCB was held through video conferencing mode covering different issues related to drug trafficking, particularly pertaining to the Western Region States & UTs. Representatives from States & UTs - Gujarat, Rajasthan, Madhya Pradesh, Dadra & Nagar Haveli & Daman and Diu participated in this meeting apart from the regular members of monthly NCORD.

Details of Apex NCORD Committee Meetings conducted in the year 2023

• 6th Apex level NCORD Committee Meeting:

On 09.10.2023, the 6th meeting of the Apex level Committee of NCORD (Narco Coordination Centre) was held (in hybrid mode) at North Block, MHA and which was presided over by the Union Home Secretary Sh. Ajay Bhalla. Officials of NCB and Officers from various Central Ministries / Departments / Agencies participated in the meeting. In addition to the above, Chief Secretaries of all States & UTs and Director General(s) of Police or their representatives participated in the meeting in virtual mode.

Agenda Points of the 6th Apex level NCORD Committee meeting were as follows:

• Review of actions taken on the decisions taken at the 3rd Apex NCORD Committee Meeting held on 27.12.2021.

- Drug trafficking through maritime routes and various measures for its containment.
- Development of effective mechanism for destruction of illicit cultivation of Opium and Cannabis.
- Improvement in Enforcement agencies response in dealing with legal aspects of NDPS cases.
- Drug Demand Reduction Initiative- 'Nasha Mukt Bharat Abhiyaan'.

The Union Home Secretary stated that the menace of drug abuse is a matter of serious concern which needs coordinated action from all Departments/ Ministries and drug law enforcement agencies in order to fulfill the vision of the Hon'ble Prime Minister of India,



that of a "Nasha Mukt Bharat". Some of the major decisions taken during the meeting are as under:

- Pending issues related to the directions given during 3rd Apex NCORD need devotion of proper attention by the States and UTs. Chief Secretaries were requested to review the status in their respective State/ UT NCORD meetings for better implementation and improved results.
- It was emphasized that there is a need to review Notification dated 16.01.2015 issued by DoR with regards to disposal of seized drugs by taking into cognizance the views and suggestions of different stakeholders and also

- the directions issued by the Hon'ble Supreme Court and other High Courts in the matter.
- ◆ Concerned authorities dealing with coastal security like Indian Navy, Indian Coast Guard and Port Authorities with active participation of DLEAs should form a 'Special Study Group' to handle drug trafficking through the maritime route and to examine the possibility of using drones for surveillance.
- ◆ It was proposed that the DoR may make suitable amendments in rules, if required regarding destruction of illicit cultivation of Opium/ Cannabis as well as to provide alternate livelihood sources for the farmers in those area involved in such cultivation traditionally.

On 17.07.2023, the 4th Regional Conference on 'Drug Trafficking and National Security' was Chaired by the Hon'ble Union Home & Cooperation Minister, Sh. Amit Shah with Lt. Governor Delhi, Chief Ministers, Chief Minister, Chief Secretaries and Director General of Police of Northern States (Punjab, Haryana, Himachal

Pradesh, Uttarakhand, Uttar Pradesh, Jammu & Kashmir, Delhi and Chandigarh) in attendance at New Delhi. The Union Home Secretary, Director General of NCB, and senior Officers from various security agencies and related Ministries and Departments of the Government of India also attended the Conference.

Following activities were undertaken and points discussed during the Conference:

- ◆ In the presence of the Hon'ble Union Home Minister, more than 1.40 Lakh kgs of narcotics worth INR 2,378 Crore were destroyed in different parts of the country and which is a record for a single day disposal.
- ◆ Participants were informed that under the able leadership of the Hon'ble Prime Minister of India, Shri Narendra Modi, 10 lakh kilograms of narcotics worth around Rs. 12,000 Crores have been destroyed in the last one year.
- ◆ The Hon'ble Union Home Minister appealed to all to lay emphasis on the continuity of conduct of NCORD meetings in the States and Union Territories for better coordination.







ORGANISATION

Narcotics Control Bureau

Narcotics Control Bureau (NCB) is the National Nodal Agency created under the Narcotic Drugs and Psychotropic Substances Act, 1985 for preventing and combating drugs abuse and illicit trafficking in Narcotics Drugs and Psychotropic Substances. NCB is responsible for coordination with various Ministries, other offices and State/Central Enforcement Agencies.

Narcotics Control Bureau (NCB) is also responsible for implementation of the international obligations under various United Nation Conventions of 1961, 1971 & 1988 (to which India is signatory) against illicit trafficking of Narcotics Drugs and Psychotropic Substances.

Narcotics Control Bureau (NCB) with its headquarters at New Delhi has seven Regional Deputy Director General offices i.e., Northern Region at (Delhi), South Western Regions at (Mumbai), Eastern Region at (Kolkata), North Western Region at (Amritsar), Western Region at (Ahmedabad), Southern Region at (Chennai), North Eastern Region at (Guwahati)and 30 Zonal Units at Delhi, Mumbai, Chennai, Kolkata, Lucknow, Jodhpur, Chandigarh, Jammu, Ahmedabad, Guwahati, Indore, Bangalore, Patna, Cochin, Hyderabad, Goa, Bhopal, Amritsar, Jaipur, Ranchi, Srinagar, Vishakhapattnam, Imphal, Dehradun, Bhubaneswar, Gorakhpur, Agartala, Itanagar, Siliguri and Raipur. At present, the sanctioned strength of NCB is 1497.

During the period (from 01.01.2023 to 31.12.2023) NCB initiated actions with respect to acquisition/creation of the following infrastructure with a view to strengthen the enforcement capabilities of the organizations. Work is going on: Office-cum-residential (OCR) at Guwahati, Assam, Office Complex (OC) at Amritsar, Punjab and Office Complex (OC) at Delhi.

Hon'ble Union Home Minister inaugurated the newly constructed Office Complex at Indore on 18.04.2023 and Office Complex at Bhubaneswar on 17.07.2023.

The land for new zone at Gorakhpur and Raipur Zone and DDG/Region at Amritsar has been identified and proposals are under consideration at MHA.

4.1 NCB CHARTER

In exercise of powers under Section 4 of NDPS Act, 1985, the 'NARCOTICS CONTROL BUREAU' was constituted with Headquarters at Delhi with effect from 17th March, 1986. The Bureau, subject to the supervision and control of the Central Government, is to exercise powers and functions of the Central Government for taking measures with respect to:

Co-ordination of actions by various offices, State Governments and other authorities under the N.D.P.S. Act, Customs Act, Drugs and Cosmetics Act and any other law for the time being in force in connection with the enforcement provisions of the NDPS Act, 1985.

- ◆ Implementation of the obligation in respect of counter measures against illicit traffic under the various international conventions and protocols that are in force at present or which may be ratified or acceded to by India in future.
- Assistance to concerned authorities in foreign countries and concerned international organizations to facilitate coordination and universal action for

- prevention and suppression of illicit trafficking in these drugs and substances.
- Coordination of actions taken by other concerned Ministries, Departments and Organizations in respect of matters relating to drug abuse.
- ◆ On the recommendation of the Group of Ministers (GoM) on national security, NCB was transferred from Department of Revenue (DoR) to Ministry of Home Affairs (MHA) on 18.02.2003.

- Construction work of Office-cum-Residential (OCR) complex at Guwahati is going on.













संघ की राजभाषा नीति के संबंध में राजभाषा विभाग, गृह मंत्रालय द्वारा समय—समय पर जारी निर्देशों का ब्यूरो मुख्यालय एवं इसके अधीनस्थ कार्यालयों में अनुपालन कार्य किया जा रहा है। स्वापक नियंत्रण ब्यूरो मुख्यालय, उप महानिदेशक के कार्यालयों, क्षेत्रीय कार्यालयों के सभी अधिकारियों व कर्मचारियों द्वारा इस संगठन में राजभाषा के प्रयोग को बढ़ाने के निम्नांकित सार्थक प्रयास किए गए:—

राजभाषा कार्यान्वयन समिति की तिमाही बैठकें

स्वापक नियंत्रण ब्यूरो, मुख्यालय में विभागाध्यक्ष की अध्यक्षता में गठित विभागीय राजभाषा कार्यान्वयन समिति की बैठकों (OLIC) का प्रत्येक तिमाही में आयोजन किया गया। बैठकों में हिंदी में कार्य करने और हिंदी के प्रयोग को बढ़ाने के लिए चर्चा की गई तथा इस संबंध में कार्य नीतियां बनाकर उनका कार्यान्वयन सुनिश्चित किया गया।

तिमाही, अर्धवार्षिक तथा वार्षिक प्रगति रिपोर्ट का संकलन

ब्यूरो मुख्यालय की प्रत्येक तिमाही प्रगति रिपोर्ट का संकलन करने के लिए मुख्यालय के सभी अनुभागों से आंकड़े मंगवाए गए और ब्यूरो मुख्यालय की समेकित रिपोर्ट गृह मंत्रालय तथा राजभाषा विभाग को भी भिजवाई गई। ब्यूरो मुख्यालय की वार्षिक मूल्यांकन रिपोर्ट तथा अर्धवार्षिक रिपोर्ट भी समेकित कर तैयार करके भेजी गई।

ब्यूरो मुख्यालय के सभी उप महानिदेशक के कार्यालयों, क्षेत्रीय कार्यालयों से राजभाषा प्रयोग संबंधी तिमाही प्रगति रिपोर्टें नियमित रूप से मँगवाई गई। सभी उप महानिदेशक कार्यालयों तथा क्षेत्रीय कार्यालयों की वर्ष 2023 में सभी तिमाहियों की राजभाषायी रिपोर्टों की मदवार विस्तारपूर्वक समीक्षा की गई तथा पाई गई किमयों को दूर करने हेतु सुझाव दिए गए।

हिंदी प्रशिक्षण

हिंदी शिक्षण योजना के अंतर्गत हिंदी टंकण प्रशिक्षण के लिए ब्यूरो मुख्यालय से श्री दशरथ सिंह, हवलदार को नामित किया गया। नामित कार्मिक ने हिंदी टंकण प्रशिक्षण प्राप्त करके जनवरी, 2024 में हिंदी टंकण परीक्षा उत्तीर्ण की तथा 12 माह के लिए वैयक्तिक वेतन वृद्धि एवं नकद पुरस्कार प्राप्त किया।

राजभाषायी निरीक्षण

LEGAL SECTION

Legal Section in NCB HQrs. functions under the Additional Legal Advisor and the DDG (Legal) to assist NCB HQrs as well as NCB Regions and Zones in all legal matters. The following are the some of the important functions carried out by the section:

- 1) FILING OF SLPS IN SUPREME COURT AND MONITORING THEREOF: Legal section processes the SLP proposals received from NCB Zones against the unfavourable orders of Hon'ble High Courts before Supreme Court of India. The Proposals are processed through Ministry of Law & Justice. The section ensures drafting, filing of SLPs in Supreme Court in coordination with Central Agency Section, Ministry of Law & Justice. During the period Legal Section processed around 200 SLP proposals. Out of 200 SLPs, around 20 resulted in NCB's favour. Legal section also monitors the writ petitions filed in various High Courts where NCB is a party. Timely filing of counter affidavit and briefing of Panel counsels are also ensured.
- 2) VETTING OF LEGAL DOCUMENTS:
 Legal Section also vets all legal documents
 including applications, petitions,
 complaints, replies/counter affidavit etc to
 be filed in various courts. During the period,
 Legal Section vetted around 40 legal
 documents received from NCB HQrs.,
 Regional Offices and Zonal Units.
- 3) TENDERING OF LEGAL OPINION: The Additional Legal Advisor as a representative of Ministry of Law and Justice tenders opinion in legal as well administrative matters of NCB HQrs/Regions/Zones/Sub Zones placed before him. Legal Section also

- provides opinion in the matter of appeal to High Court to NCB Zones of northern region where no branch secretariat of Ministry of Law & Justice function. During the period, the Additional Legal Advisor tendered opinion in more than 200 SLP matters and 100 other legal and administrative matters.
- 4) DRAFTING AND CIRCULATION OF NCB CIRCULARS/SOPs: The Legal section also tasked with drafting of important circulars and SOPs especially on Legal matters. During the period, Circular No. 01/2023 was issued with valuable contributions from the legal section
- 5) APPOINTMENT OF SPPs IN NCB: Legal Section also looks after the entire process of appointment of SPPs starting from the seeking vacancies, publication, and taking up with Ministry of Law & Justice. NCB HQ. also accords sanction for adhoc appointment of SPPs. During the period, around 30 SPPs on regular and adhoc basis were appointed.
- 6) MONITORING OF PERFORMANCE OF SPPs: Legal Section also monitors the performance of SPPs and places before the competent authority for issuance of appropriate directions in the matter.
- 7) ANALYSIS OF ACQUITTAL CASES: Legal Section also analyses acquittal orders of trial courts and issues necessary instructions to zone for observation.
- 8) CIRCULATION OF LANDMARK JUDGMENTS: Legal Section also circulates important and landmark judgments of Hon'ble Supreme Court and High Courts to NCB Zones / Regions for their information

- and compliance. During the period around 10 landmark judgments of Supreme Court and High Court were circulated.
- FURNISHING OF COMMENTS ON 9) REPATRIATION /TRANSFER OF ACCUSED PERSONS BETWEEN INDIA **AND OTHER COUNTRIES:** Legal Section also furnishes comments on the repatriation and transfer of accused persons between India and other countries.
- 10) IMPARTING OF TRAINING ON LEGAL **TOPICS:** Addl. Legal Adviser and other staff members in Legal Section are also detailed for delivering lectures on legal topic during training programs / seminars etc. Legal Section has organized 05 training of SPPs in collaboration with CAPT Bhopal.

DIGITAL INITIATIVES

6.1 NCORD PORTAL



Due to multiplicity of the stakeholders in drug administration mechanism in India, the central government has created a four-tier mechanism to ensure tight cooperation in the field of drug supply-demand and harm reduction. NCB being the national nodal agency in the field of drug law enforcement took initiative to develop an NCORD Portal which can be accessed @ https://narcoordindia.in/. This platform is a gateway for all drugs and NCB related information and total KMS for all four tiers of stakeholders starting from district level to state level also including the ministries under central government. The knowledge management system (KMS) is accessible to one and all whereas restricted access is provided to the NCORD portion where all decisions taken during different NCORD meetings can be viewed category wise at the portal.

In the KMS front, the portal is rich in terms of the MoUs, Bilateral Agreements, Extradition Treaties, Training course schedules and training calendar, important judgments etc.

The stakeholders can upload, view and download meeting notice, agenda, and minutes of the meeting and ATR of the concerned meeting from concerned section of NCORD Portal after login on it.

6.2 NATIONAL INTEGRATED DATABASE ON ARRESTED NARCO OFFENDERS (NIDAAN)

To assist all law enforcement agencies like NCB, NIA, Other central and state investigation agencies, NIDAAN portal is developed and released at the URL https://nidaan.nic.in/NIDAAN/ (on NICNET). ICJS Login credentials can be used for accessing NIDAAN. It is a database of all India narcotic offenders arrested in narcotic offences and are directly or indirectly involved in offences under Narcotic Drug

Psychotropic Substance (NDPS) Act 1985. All the accused lodged in the prison at least for a day across the country are registered in the e-Prisons and are accessible to the Law enforcement agencies. It maintains a centralized database of all narcotic offenders, using the latest technologies available as on date, through e-Prisons which is cloud-based application available for all the states.



6.3 CRIMINAL TRACKING NETWORK & SYSTEMS (CCTNS)

It is a mission mode project under national egovernance plan (NeGP) of Government of India. It aims at creation of a nationwide networking infrastructure and tracking system around investigation of crime and detection of criminals. NCB is first Central Drug Law Enforcement Agency implemented the Crime & Criminal Tracking Network & Systems (CCTNS) after modification of CCTNS Portal according to requirements and organizational structure. NCB has digitized its legacy data of more than 7000 seizure case registered since 1986 and the newly registered cases of NCB are being fed on the CCTNS portal with Crime Registration Number (CRN).



6.4 NATIONAL AUTOMATED FINGERPRINT IDENTIFICATION SYSTEM (NAFIS)

It is a country wide searchable database of Crime & criminal related fingerprints developed by National Crime Record Bureau (NCRB) and Central Fingerprint Bureau (CFPB), New Delhi. The web-based application functions as a central information repository by consolidating fingerprint data from all states and Union Territories. It enables law enforcement agencies to upload, trace, and retrieve data from the database in real time on a 24×7 basis. It would help in the quick and easy disposal of cases with the help of a centralized fingerprint database.

NCB has successfully rolled out NAFIS at 16 zones located at different locations. Soon, NAFIS will be extended to upgraded & newly created Zones.


